# Wednesday, March 8, 1978

The Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1978, convened at 11: 30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Reverend Olin Pendleton of the Kokokahi Church, after which the Roll was called showing all Senators present.

The President announced that he had read and approved the Journal of the Thirty-Fourth Day.

"Mr. President, I'd like to cast a 'no' vote on this bill and very briefly, I'd like to let it be known to some of you, especially from the neighbor islands and some of the businessmen here, that this bookstore is not a bookstore. It's a department store.

The intent of the bookstore originally of course was to provide books and sundries that were needed for the boarding students. But this bookstore is something like a 4 or 5 million dollar enterprise. It's got everything from books to sundries, gifts, toys, candies and toilet articles and on and on. They haven't yet gone to a catalog for importing cars, but that's next year.

The legitimate businessmen situated around the University campuses and the businesses near the vicinity of the neighbor island universities have to compete with this bookstore. A five million dollar enterprise is quite sizeable.

The students that they hire to sell, of course, don't get the fringes and aren't afforded the same privileges that the private sector is mandated to pay the employees. I would just ask that you talk to some of your small businessmen in your various communities and really find out the impact of this so-called 'bookstore' on the University's campuses.

Thank you, Mr. President."

On motion by Senator O'Connor, seconded by Senator Ching and carried, S.B. No. 782, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO MOTOR-BIKES", having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

Ayes, 25. Noes, none.

At 12:08 o'clock p.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 12:10 o'clock p.m.

Senate Bill No. 2525-78, S.D. 1:

Senator O'Connor moved that S.B. No. 2525-78, S.D. 1, having been read throughout, pass Third Reading, seconded by Senator Ching.

Senator Kuroda then spoke for the measure as follows:

"Mr. President, although I am going to vote 'yes' on this bill, I think that the action taken by the Committee resulted in a too restrictive provision and I just wanted to call to the attention of the group that this practice of inexpensive campaigning by sign-holding along the roadside should be given a little more flexibility than limiting it to the highways of less than 25 miles per hour and also limiting the number of people. In this case, it is only the candidate and I think that there should be a little more provision whereby one, two or three associates could also be with him.

Thank you, Mr. President."

Senator Leopold then stated as follows:

"Mr. President, in my campaign for the State Senate, I did not hold a single sign on any day, but I would like the Clerk to register a 'no' vote for me on this bill because I feel it is discriminatory and unconstitutional."

Senator Chong then spoke against the measure as follows:

"Mr. President, I go along with the comments made by the Senator from the Fourth District in that I think this bill is restrictive. It is not clear to me that sign-holding has caused major accidents along the highway and I urge my colleagues to vote against this bill."

Senator Kawasaki, in opposition to the measure, stated as follows:

"Mr. President, I am one who voted against the proposition of allowing sign-holding as a major way of getting elected to office simply because, first of all it is dangerous; and secondly, I think to expect to get elected to office on the basis of a sign that you hold or wave as people pass by, is an insult to the intelligence of electorates. Therefore, I am again being consistent in voting against this bill.

Thank you, Mr. President."

Senator Anderson then rose to speak against the bill as follows:

"Mr. President, over the years we have seen the erosion of the capability of the politician to reach his constituency. I disagree, of course, with the Senator who just spoke. This was a compromise a couple of years ago when it wiped out all the other provisions for the politicians. This was the one that was left for the newcomer where he could get some name identification because he couldn't raise the money to buy expensive television and expensive newspaper ads.

It was house-to-house and on the street where the newcomer could challenge the incumbent and then he would follow up with the one-to-one contact or the coffee hours or the rallies.

It's getting more and more difficult. First you banned the passing out of political literature within 1,000 feet to voters on that particular morning.

You came back in a couple of years and you forbade and banned the posting of these cloth banners on the trees and the highways, which I still happen to think was very much a part of Hawaii.

Then we went to a campaign spending and we limited how much a politician could spend to reach his constituency in getting his viewpoints across. Then last year we came in with another restriction and now, finally, this one.

As an incumbent, this helps me, of course, against anyone who challenges me because the incumbents are better known in the district.

I think some politicians overdo this on the highways in the morning when you have twenty-five or thirty people waving signs, but I don't think it is challenging the intelligence of the voter.

The politician, and I'm sure I speak for all of you, has a difficult time reaching the constituency today. Most of us can't afford television in a district race or even a senatorial race and newspaper ads are very, very expensive.

If some of you hadn't been on street corners campaigning in this very manner, you wouldn't be sitting in your chairs today. We all got here in different types or forms of campaigning, but you've got to admit that some of you wouldn't be here today if you didn't have this inexpensive opportunity to reach the voter.

I think it is discriminatory that it is okay for the unions to put out fifty or seventy-five people in a driveway and picket, but my supporters to elect Andy Anderson or anybody else, can't picket or hold signs.

I don't stand on street corners and I never have, but I don't like denying the privilege to others who may want to take this opportunity to campaign. I think you sometimes over-react in your legislation or your intent to clean up for safety or whatever.

I think a certain amount of common sense has to prevail in every election campaign that represents every candidate. If I put out thirty-five or forty people on Kalanianaole Highway some morning, and this causes a traffic tie-up, then that's going to work against me. I have got to believe that you have to allow some common sense to be left to the candidate in his campaign, and trying to put everything into law, for whatever reason you support it, I think is wrong.

Therefore, I think this measure should not pass.

Thank you, Mr. President."

Senator Kawasaki then noted as follows:

"Mr. President, just as a matter of clarification and for the edification of the good Senator from the Third District, I think I was the only member of this twenty-five-member body that appeared before the City Council way back when they were deliberating on the proposition of banning the use of these cloth banners that he speaks of, and, at that time, I advocated the allowance of the use of these banners that are no longer permitted, on the grounds that that was a very cheap means of exposure for the new candidate.

Thank you, Mr. President."

Senator Kuroda then stated as follows:

"Mr. President, I have a little concern here that there may not be enough votes to move this bill. I want to clarify the situation here that five years ago, I stood on this floor and spoke in opposition to the bill that eventually became law prohibiting sign-nolding and which was declared by the courts to be unconstitutional.

Inasmuch as there may be an attempt in the future to try and prohibit signholding again, I introduced this bill so that we can regulate it, because regulation is much better than prohibition.

Also, Mr. President, when the good Senator from the Third District talks about common sense employed by campaigners, oftentimes unless you have some regulatory type of policy or law to guide the socalled people who are supposed to be practicing common sense, if you don't come down hard with some kind of guidelines, you are going to find 100 people on the roadside.

I agree with the Senator from the Third District that people should be given freedom of conducting inexpensive campaigns because I am a product of that. However, unless we provide strict guidelines, we are going to find that our fellow man will not be using their common sense, so I urge my fellow Senators here to vote for this measure.

Thank you, Mr. President."

At 12: 18 o'clock p.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 12:19 o'clock p.m.

Senator Anderson then commented as follows:

"Mr. President, very briefly, on

the word 'regulate' that was used a few minutes ago, we have laws on the books today that regulate signs of any size. But you ought to venture out to the Waiahole Valley where you can find some 4 x 8 plyboard signs very poorly done in composition and art that have been there for a year, damning politicians, damning government and damning private owners. I haven't seen the laws being regulated or enforced against people who do it that way because of practical politics and I don't like being regulated because I am an easy victim.

Thank you, Mr. President."

"Mr. President, I'm voting against this bill primarily because the language of the bill does not very specifically state what segment of the agriculture industry would be given a liberalized loan repayment treatment.

It just seems to me because we have been overly liberal in our farm loan program, our monitoring has been lax. This is the reason why we have had situations like the Kohala Task Force mess that we have been involved in in the last two years.

The subsidies the farmers obtain from the State at taxpayers' expenses are the kind of subsidies other businesses do not get. For this reason, I would hate to just carte blanche liberalize the term of repayment on the monthly principal, which payments basically are pretty nominal sums. I think to further extend the limitation for five years for all categories of farmers may not be improving our miserable farm loan repayment record in this State.

Thank you, Mr. President."

Senator F. Wong then spoke for the passage of the bill as follows:

"Mr. President, I think it is wrong to categorize that the bill is too liberal because it covers all farm loans. Our farm loan system right now is vested with the Board of Agriculture. They have the discretionary powers to extend the particular loans that we are talking about.

I have indicated to the Senator from the Fifth District that our present statute right now does not permit the discrimination in favor of one particular segment of our agricultural industry against the other and thus whatever farm loan statutes that we have have to be applied across the board to all segments of agriculture.

More importantly, Mr. President, we have a serious problem in our farm community today. The situation in extending the farm loan is similar to a measure that was adopted by the U.S. Congress and given a mandate to the United States Department of Agriculture to extend similar farm loans up to two years, and this conforms our statute to the Federal statute.

I ask all members to support the agricultural industry and pass this measure.

This particular bill makes the penalty for the possession of silencers to a class A felony. A person has a silencer in his possession only for one reason.

Also emanating from the Judiciary Committee is going to be Senate Bill No. 1855-78, S.D. 1, and Senate Bill No. 2086-78, S.D. 1. One makes it mandatory sentencing for repeater offenders who are felons and the other makes it mandatory for the judge to impose restitution to a victim of an offender. Where a victim suffers financial damage, it mandates the judges to require restitution.

After the offender is incarcerated, he comes out on parole, then he has to make restitution over a period of time at the discretion of the judge at the terms outlined by the judge.

These are law and order bills, if you want to call them that, but I think this is well addressed to the criminal elements. Hopefully, the public who is so concerned about the proliferation of serious crimes, will be made aware of the Senate's position on this.

I think it would be in the public service for the media to publicize these bills and their passages adequately so that the criminal elements will get a very clear message that at least the Senate of the State of Hawaii will not condone the kind of activities the criminal elements have been involved in in the last few decades.

If a family has four cars, three of which belong to the youngsters in the family with no apparent contribution of income to that family, the taxpayers still have to pay for that insurance, and for this reason, I will have to vote against this bill.

Senator Anderson then spoke against the bill as follows:

"Mr. President, I rise to speak against this bill. I remember a few years ago when this very body had to be the first in the country to ratify the 18-year-old vote. I don't think the ink was dry on the newspaper or the cable and before it was typed in the back room, then a resolution supporting the 18-year-old vote was before this body.

Since then we changed the age of majority and it's really somewhat contradictory to recognize an 18-year-old person who is responsible and liable for all the laws of the State, who can vote for the governor, who can get involved in the Constitutional Convention, who can change the makeup of this State entirely, but who can't drink until he is 19 even though he is recognized as a legal adult when he is 18.

Again, it's just trying to legislate moral standards on people. If a young man has been drinking at 18, they're going to drink at 17, or they're going to drink at 16 or 14. It really depends on the environment, his home and his upbringing, and all the laws that you pass and all the words that you put down on paper trying to prohibit it, isn't going to stop the young man at 18 not to drink because you passed a law.

I think it's contradictory to our past actions and I will vote 'no'.

Thank you, Mr. President."

At 6: 47 o'clock p.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 6:50 o'clock p.m.

By unanimous consent, consideration of S.B. No. 1863-78 was deferred to the end of the calendar.

Senate Bill No. 2046-78:

Senator Nishimura moved that S.B. No. 2046-78, having been read throughout, pass Third Reading, seconded by Senator O'Connor.

Senator Kawasaki then spoke against the measure as follows:

"Mr. President, I am voting 'no' on this bill primarily because of the Department of Accounting and General Services' concern about the immensity of a contract like this. They estimate that a contract involving this type of program might involve somewhere between 60 and 80 million dollars with the term of the contract running 20 to 25 years.

We were also told in testimony before the Committee that the County now has the authority to enter into no-bid contracts involving these types of projects and they do not need our sanction. That being the case, I don't think we should enable them to enter into these types of contracts by state statute.

I recall very clearly some of the newspaper articles involving the Federal investigation of the sewer treatment plant overruns by the City and County of Honolulu and some of the concerns of the Federal officials. Let me quote a sentence or two that I am concerned with, and you will know that these types of projects will, as of necessity, require Federal funding, Federal consent, and so forth.

In the Honolulu Star-Bulletin, December 1, 1977, there was an article entitled 'Non-Bid Sewage Contracts Questioned', and it goes to say 'A preliminary audit report by the United States Environmental Protection Agency (EPA) says that the City had apparent deficiencies in its selection process for non-bid contracts for sewage plant projects that may have led to 'unreasonable' architectural and engineering fees. Further, public works personnel indicated that in most instances the final selection of an architectural engineering firm was made within the Mayor's office, the audit report said.'

Mr. President, it's articles like this that I would quote on but I won't take the time to, that lead me to believe that if the County wants to enter into non-bid contracts involving these amounts of money for a long time--20, 25 years-then that's their business. Certainly we should not sanction this by State statute and I will vote against this bill for that reason.

Thank you, Mr. President."

The motion was put by the Chair and carried, and S.B. No. 2046-78, entitled: "A BILL FOR AN ACT RELATING TO THE PROCUREMENT OF PUBLIC CONTRACTS", having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

Senate Bill No. 2093-78:

Senator Ching moved that S.B. No. 2093-78, having been read throughout, pass Third Reading, seconded by Senator Hara.

Senator Nishimura then spoke against the measure as follows:

"Mr. President, this bill came out from the Judiciary Committee of which I am Chairman and I signed the report 'I do not concur'. It is the first time in the ten years that I have been here that I have signed a committee report prepared by <u>my</u> Committee 'I do not concur.' But, inasmuch as I have learned a lesson from that here, I have allowed this bill to come down to the floor for full consideration by the whole body and I would like to try to persuade members of this Honorable Body to feel as I do, that we don't need this bill.

In 1970, Mr. President, the Judicial Council of Hawaii Penal Law Revision Project, chaired by the Honorable Judge Masato Doi, published a preliminary draft detailing a comprehensive division of the criminal laws of this State. The final product was a polished one that emerged after intensive review encompassing many hours of hard work. The final product became Act IX of 1972 and, from 1973, we have been governed by the provisions of the Hawaii Penal Code.

The Penal Code provided that upon conviction, a judge would basically face two choices; he could either place the defendant on probation or he could incarcerate the defendant. If the judge chose incarceration, he had to sentence the defendant to the maximum sentence provided by law, except for a few unique circumstances.

Within six months, the Parole Board sets the minimum sentence the defendant must serve prior to being eligible for parole. At the time of hearing to set the minimum sentence, the Parole Board had the benefit of detailed studies profiling the defendant's strengths, weaknesses and needs. Thus, the Parole Board knows how much time is needed for a program of rehabilitation so that when he once again emerges from the confines of the prison walls, he will be able to walk the streets as a useful productive member of society.

Now, this is not the only factor recognized by the Parole Board. They also look at the seriousness of the crime to determine the length of the minimum sentence. But now this body is asked to change the system.

I ask why? What has happened in the last five years to make us change our minds? Has the Parole Board demonstrated incompetence? Has the Parole Board demonstrated laziness? In my opinion, it has not.

In my opinion, they have done an excellent job. It is not an easy job to judge the future of peoples' lives, balancing the need of the convict, the needs of society.

Just a short two years ago, we enacted into law, Act 92 making the Parole Board a full-time board. Since then, they have made great strides in developing uniformity of minimum sentences.

One criticism of our system of sentencing is the disparity of the length of sentences meted out to the defendant. Two defendants, for example, of similar background and committing the same crime in similar circumstances may meet and find that one is serving a minimum of five years while the other is serving ten years.

The injustice of it all is quickly apparent to everyone and especially to the one serving ten years. The bitterness engendered does not make rehabilitation any easier--it makes it a hell of a lot tougher.

In the Federal system, the judge sets the minimum and the disparity resulting of sentencing has been attacked by experts in the correction field.

The Senate of the United States has just passed S. 1437 decodifying and revising the U.S. Penal Code in a serious attempt to reform criminal law at the national level. That bill makes provision for a sentencing commission to issue guidelines on sentencing to attack the problem of disparate sentences. While the Federal government moves in one direction towards uniformity, we are now considerating a move toward disparity since obviously the judge sets the minimum, there will be no uniformity.

The Parole Board has met this problem of disparate sentences head on. They have set up guidelines on the minimum sentences that should be served for such types of crime, for each type of crime, but to insure flexibility they have set up a system where time could be added to the sentence when aggravating factors exist and the minimum could be reduced when mitigating circumstances warrant such action.

Before the full-time Parole Board existed, Mr. President, the average minimum was one-fourth of the maximum sentence. Now it is more like one-third of the maximum.

Some argued that we should wait nine months before setting the minimum. They say that a good criminal can be a good con artist and behave for six months, but would find it difficult to behave for nine months. I say that this demonstrates a certain naivete of the usefulness of information on behavior in prison.

Mr. President, prison society is a society of criminals. The one who gets along best in that kind of society is the criminal. He will not be a behavior problem for his values and mores fit in with the rest of the prison society. A good con, in other words, knows how to pull time. It is the inexperienced prisoner who is not a hard-core criminal that finds it difficult to adjust to prison life. What we can learn in the additional three months is irrelevant to the making of an intelligent decision. Some say that judges should set the minimum sentence because they know all the circumstances of the case. That may be true, Mr. President, if the case went to trial, but we should remind ourselves that over 90% of convictions result from guilty pleas. The only facts the judge ever knows are those contained in the pre-sentence report which is also available to the Parole Board.

There is also the problem of time-a judge will have other duties besides setting minimum sentences and doing parole revocation hearings. He must preside over trials, sentence hearings, pre-trials and hear motions. And these go on constantly, since by its very nature, criminal law is very litigation-oriented.

Just recently the First Circuit had to assign a fourth judge to the criminal calendar to handle the volume of cases going to trial. But yet it is not uncommon for trials to go long into the night. In fact, sometimes the session goes as long as those of our colleagues across the way.

Could the Judiciary handle this extra burden? In this respect, Mr. President, I should like to call to the member's attention that the Judiciary Branch testified on this bill and on February 27, 1978, they submitted written testimony and also read into the record, their feelings on this bill.

Rather than read the reasons why they feel this bill should not pass, let me just read the bottom line: 'The Judiciary actively opposes Senate Bill No. 2093-78 on the following bases: ' (And they outline the reasons why they do not want this particular bill.)

Mr. President, since our recent poll results show that crime is the number one concern of the citizens of this State, it seems that any bill which claims to deal more harshly with criminals has become a 'motherhood' bill which should be passed in the interest of the public safety and public welfare.

This bill will not reduce crime, Mr. President. This bill will not guarantee that the convicted person will end up in jail. This bill will not ensure that longer sentences of convicted criminals will result. On the contrary, Mr. President, this bill, if it becomes law, will do just the opposite of what the proponents think the provisions of this bill will accomplish.

I for one, Mr. President, am willing to give our Parole Board a vote of confidence. I am willing to kokua the Judiciary branch who has asked that this bill be filed, and I ask all the members of this body to join me, Mr. President, in extending a helping hand to the Judiciary branch by voting 'no' on the bill.

Thank you, Mr. President."

Senator Kawasaki then spoke against the bill as follows:

"Mr. President, I am voting 'no' on this bill primarily because of the Judiciary Department's objection to the bill.

In my dialogue with the Department, I was told that they are particularly concerned because the pre-sentencing program which we enacted a year or two ago has not as yet been truly implemented.

They are going through the throes of a new type of program being consolidated and so forth, and to add the parole and probationary program to the Intake Services personnel is, in the judgement of the Judiciary Department, just going to compound a problem. They would be supporting such a proposition in subsequent years after the pre-sentencing program has been fully developed and fully operating to the Judiciary's satisfaction.

They are concerned about the lack of dialogue for example, right now, in the pre-sentencing program between the Judiciary, the judges and the authorities in the Judiciary and the pre-sentencing Intake Services personnel. So with the recommendation of the Department of the Judiciary, I will have to vote 'no' and I urge others to vote the same way.

Thank you."

Senator O'Connor then commented:

"Mr. President, lest there be some confusion on the part of the members on the comments that were made by my esteemed colleague, this bill has to do with matters that happen after sentencing or after trial has occurred. The bill which has to do with the pre-sentencing portion of this did not come down from the Judiciary Committee. So this bill does not change the law as it presently exists for Intake Service Centers in the pre-sentencing area. It has to do with probation and supervision of convicted persons who are placed on probation and matters that occur after the sentencing."

Senator Kawasaki then stated, "For the edification of the previous speaker, I am fully aware of the situation, Mr. President."

Senator Nishimura then explained further:

"Mr. President, there are two bills that pertain to pre-sentence investigation. My understanding of the Judiciary's concern and objections relate to a bill that is still in the House. This particular bill, as the Vice Chairman of the Judiciary Committee has noted, pertains to probation, which is postsentence, and it is my understanding that the Judiciary Branch has no objection to this particular bill...the functions being transferred to the Intake Service Center."

Senator Kawasaki then asserted, "Mr. President, as a matter of clarification, twenty minutes ago, I talked with Mr. Lester Cingcade of the Judiciary Department to clarify this very bill."

By unanimous consent, consideration of S.B. No. 2590-78, S.D. 1, was deferred to the end of the calendar.

Standing Committee Report No. 500-78 (S.B. No. 1568-78, S.D. 1):

Senator R. Wong moved that Stand. Com. Rep. No. 500-78 be adopted and S.B. No. 1568-78, S.D. 1, having been read throughout, pass Third Reading, seconded by Senator Yamasaki.

Senator R. Wong then spoke for the measure as follows:

"Mr. President, I rise to speak in favor of this bill and the following seven bills. Senate Bill Nos. 1568-78, S.D. 1; 1570-78, S.D. 1; 1572-78, S.D. 1; 1573-78, S.D. 1; 1578-78, S.D. 1; 1579-78, S.D. 1; 1581-78, S.D. 1; and 1597-78, S.D. 1 are the various bills comprising the Senate Energy Program which were referred to Ways and Means and which are now before us for Third Reading.

This package of bills reflects the commitment of the members of the Senate towards the development of alternative energy sources for Hawaii. All the members of the Senate have been involved in the development of this package.

I would, however, like to especially acknowledge the hard work and long hours put in by the Senate Energy/Natural Resources Committee and staff under the able chairmanship of Senator T.C. Yim. Mr. President, the results of their work are now before us.

I urge the members of the Senate to vote in favor of these bills."

"Mr. President, although I am a music major myself, I am voting against this bill.

If this bill had provided that the thirty tuition waivers for the University of Hawaii students were based on need, it would be one thing, but just blanket providing tuition waivers for thirty music major students and possibly denying some other students who may need tuition waivers, in addition to the 600 that we already provide for, I think might not be the desirable thing under the present situation.

I would be in favor of a bill that very specifically states that the tuition waiver to a music major student should be based on financial need and not blanket tuition waiver treatment for thirty students."

Senator Yee, also in opposition, spoke as follows:

"Mr. President, I feel again that we are making an exception to one group of students, and I feel that there are other groups of worthy artistic talent not included here-in art, dancing, athletics, whatever you have. I think it is very discriminatory to single out just one group, so I will be voting 'no' on this measure."

Senator Soares, in support of the bill, commented as follows:

"Mr. President, I am going to speak in favor of the bill.

I know that many students are given scholarships for their football, baseball, basketball or other athletic ability. These athletic scholarships are based on their ability and not on need.

Many of the grants are based on need but scholarships are not. Therefore, I'd like to see this bill passed because it will be moving to a new area where we have a lot of musical talent and where we can attract top students for our orchestra at the University. So I urge a 'yes' vote on the bill."

Senator O'Connor then stated as follows:

"Mr. President, I'm going to vote against this bill because the section of the law as presently constituted sets up a formula for a landowner who has a historic site on his property with a 90-day period during which he may not touch the property. At the end of the 90-day period, the State is required either to go forward with condemnation or to allow the landowner to do something about the historic site.

The proposed amendment would alter that formula and tack on a 6-month period before the 90-day period and instead of having the landowner able to do anything during that period, he would then be hung up for a period of nine months with no knowledge of what might happen to his land.

I believe that this is unconscionable. I believe that the State, if acting in this fashion, should be faced with a condemnation period within which they either have to do something or 'get off the pot'. Therefore I am going to vote 'no' on this bill."

The motion was put by the Chair and S.B. No. 2533-78, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO HISTORIC PRESERVATION", having been read throughout, failed to pass Third Reading on the following showing of Ayes and Noes:

Ayes, 11. Noes, 14 (Anderson, Ching, Hara, Henderson, Kawasaki, O'Connor, Saiki, Soares, Taira, Takitani, Toyofuku, F. Wong, Yamasaki and Yee).

Senate Bill No. 1912-78:

By unanimous consent, S.B. No. 1912-78, entitled: "A BILL FOR AN ACT RELATING TO WATER CONSERVATION", was recommitted to the Committee on Economic Development.

Senate Bill No. 1622-78, S.D. 1:

Senator R. Wong moved that S.B. No. 1622-78, S.D. 1, having been read throughout, pass Third Reading, seconded by Senator Yamasaki.

Senator Anderson then spoke against the bill as follows:

"Mr. President, we have no argument with the portion of compensation for the people who legitimately went to court and settled with the State, but in this bill on page 10, Mr. President, various school teachers have damages to their cars. For instance, damage to car in Kahuku High and Elementary School parking lot, \$89.80; damage to car by vandals at Roosevelt High School, \$57.20; damage to car by vandals at McKinley High School, \$197.00; damage to car by vandals at McKinley High School, \$169.31. I thought most of the people had insurance programs for vandalism to cars.

In questioning the Attorney General's Office and DAGS, I believe it was, when they were before the Ways and Means Committee, we were told that there is no policy if a teacher's car or a student's car or a State employee's car is vandalized in the various parking lots. I think it allows all kinds of shenanigans between students. It allows all kinds of abuses against the State on the claiming of vandalism. If the car is scratched by students, deliberately, on his own car or someone else's car with a point job on the hood, he can now, under the procedures claim vandalism and get compensation for a new paint job. It can go on and on.

I don't think this was the intent of the bill originally. I think the State needs a policy of vandalism. Everybody has to have and should have an insurance policy which takes care of these kinds of compensations and for this part of the bill, I ask that a 'no' vote be had--that the bill be put back in Committee and this be taken out and then re-submitted at a later date.

Thank you."

Senator R. Wong then commented:

"Mr. President, in answer to the Minority Floor Leader's comments, I would like to point out that the bill contains payments for school teachers and not students.

The point to be made, Mr. President, is that under the collective bargaining contract with the HSTA organization, part of the negotiating item involved in the settlement of fringe benefits is the idea that teachers be allowed to park on the school premises. Therefore, Mr. President, under those circumstances, it becomes a responsibility of the schools. All of the claims submitted in this bill for damages to automobiles have occurred on school premises. I just want the body to note that.

Thank you."

Senator Yee, in opposition to the measure, spoke as follows:

"Mr. President, to elaborate further, I think what the Minority Floor Leader was alluding to is that these are school teacher's cars parked on school campuses, but there is no criteria as to when you are going to say, okay it's a teacher's car or custodian's car or student's car, because then this can apply to the University of Hawaii where thousands of cars are parked each day by students, faculty and employees on State property. This can go on and on and create a tremendous financial burden on the State, so our reason for voting 'no' is because of this opening of Pandora's box to all kinds of claims against the State on State property.

Thank you, Mr. President."

Senator R. Wong then noted:

"Mr. President, I don't want to belabor the point, but in terms of the DOE, there is a screening process by which all claims of occurrence of accidents or any cases of vandalism on school premises are processed through the Department of Education and then through the Attorney General and then submitted to us for our scrutiny, whether or not we feel this is fair.

Thank you."

Senator Anderson then added:

"Mr. President, they are processed by the Department of Education, but really, they are accepted by the Department of Education to pass on to the Attorney General.

When we questioned the Attorney General, he admitted to members of the Ways and Means Committee that there was no policy and they just submit it to the Budget and Finance people for compensation.

There's more confusion and lack of policy in this program than I've seen in a long time in a very small program among the various agencies. Nobody seemed to know why they passed it on or whether it was authorized or whether it was a compensation plan. Everybody just kept passing it on to Eileen Anderson until she finally printed it in the bill. She didn't know why she did it because she couldn't find any policy.

It's a small amount in this bill, but it's a precedent and there are thousands and thousands of school teachers out there and there was no discussion about collective bargaining. We did discuss the possibility of students being included and again the area of gray appeared.

Anybody who parks on State land, including our own employees in our State parking lots, are accountable under this vandalism open clause and it could, in the future, run into many, many thousands of dollars.

Thank you, Mr. President."

The motion was put by the Chair and carried, and S.B. No. 1622-78, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO THE RELIEF OF CERTAIN PERSONS' CLAIMS AGAINST THE STATE AND PROVIDING APPROPRIATIONS THEREFOR", having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

Ayes, 16. Noes, 8 (Anderson, George, Henderson, Kawasaki, Leopold, Saiki, Soares and Yee). Excused, 1 (Taira).

Standing Committee Report No. 473-78 (S.B. No. 1925-78, S.D. 2):

Senator R. Wong moved that Stand. Com. Rep. No. 473-78 be adopted and S.B. No. 1925-78, S.D. 2, having been read throughout, pass Third Reading, seconded by Senator Yamasaki.

Senator Soares spoke in opposition to the measure as follows:

"Mr. President, I rise to speak against this bill and I want to be sure that I am understood that I support a crime commission, but in the discussion of this bill in Committee and with other members of the law enforcement group, I am at a loss to find that the bill contains a certain amount of provisions that raise the efficiency question as to how they are going to operate in concert with our police department.

My first question, Mr. President, is why is the Chairman of the Commission appointed by a two-thirds majority of a Joint Session of the House and Senate and yet the Commission themselves are appointed by the Governor and confirmed by the Senate.

Also, Mr. President, the bill allows the Commission to investigate without any concurrence from the counties or the Department here in Honolulu who may be on the trail of something that is very important, and order them to divulge their investigation and turn over the evidence to the Commission. I question this kind of feasibility of power that we have with the Commission.

Mr. President, the bill provides that the Commission have closed hearings and they can mandate the County governments to cooperate as they see fit, rather than work with and together with the various county police departments.

In the hearings held in the Ways and Means Committee, the local police department felt that while they were working very well with the Commission that these features of the bill would hamper their operation and may cause some problems.

For that reason, I will vote against the bill."

Senator Kawasaki, in favor of the measure, commented as follows:

"Mr. President, I specifically want to respond to the question posed by the good Senator from the Seventh District.

It was my amendment that provided for the appointment of the Chairman of the Crime Commission primarily because of some of the names that were tossed around by the media as to possible Lt. Governor candidates. I was just afraid if we had a person elected to that position by the language of this bill, that whatever his capabilities to lead a Crime Commission is, he automatically would be the Chairman of the Commission. We could have a man or a woman who would not be strong enough to withstand possible intimidation on the part of the organized criminal elements, and this is a possibility because organized crime activities involve big money.

It's an economic necessity for these people sometimes to have an ineffective Crime Commission. I wanted to make sure that the person who leads the Crime Commission is an able person, a tough person with unquestionable integrity, a person whose reputation would be unimpeachable by the respective county police departments.

This is the reason I felt that the appointment should be by two-thirds majority of each house at a vote to be taken in joint session. This is the way we appoint the Legislative Auditor, the Director of the Legislative Reference Bureau and the Ombudsman.

As to giving the Crime Commission subpoena powers and some of the powers enumerated in the bill, I think a Crime Commission without these powers would be emasculated.

We do not quite agree that the efforts on the part of the county law enforcement agencies to contain the activities of organized crime is quite satisfactory, not only to the Legislature, but to the entire population. And I think a very objective Crime Commission that is efficient with the necessary powers, completely divorced from any entanglements with each county's law enforcement agencies, might just do the job.

I certainly would want to give the Crime Commission every support possible and I want to, in this connection, congratulate and compliment the Chairman of the Ways and Means Committee, whose idea it was to form a Crime Commission.

When the idea was first broached here there were a lot of skeptical people, but in retrospect, when you examine what they have done in the short tenure with a very limited amount of funds, about \$106,000 I believe, I think what they have come out with is quite impressive.

I certainly would like to continue the life of the Crime Commission. Give them ample funds, give them the subpoena powers and then see what they can do. Otherwise, all our enunciated concern about criminal activities, particularly on the part of organized criminal elements here, would be meaningless. If you don't provide for a strong Chairman, you emasculate the entire program of the Crime Commission.

For that reason, I want to not only congratulate the Chairman for having the foresight to have enacted something like this with his initiative but also his desire to continue the life of the Commission with ample funds.

## Thank you."

## Senator Soares then commented:

"Mr. President, I might also add that a two-thirds majority vote of a joint session of the House and Senate would be necessary to remove a commissioner only for neglect of duty, misconduct or disability. It means that no matter what kind of performance he has made between sessions, we will have to go back in the next year in joint session to prove either misconduct or prove negligence of duty before he can be removed. I think that feature is dangerous in the sense of a very overly strong Chairman.

Thank you, Mr. President."

The motion was put by the Chair and carried, and Stand. Com. Rep. No. 473-78 was adopted and S.B. No. 1925-78, S.D. 2, entitled: "A BILL FOR AN ACT RELATING TO A CRIME COMMISSION", having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

Standing Committee Report No. 476-78 (S.B. No. 897, S.D. 1):

On motion by Senator R. Wong, seconded by Senator Yamasaki and carried, Stand. Com. Rep. No. 476-78 was adopted and S.B. No. 897, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO SICK LEAVES FOR GOVERNMENT EMPLOYEES", having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

Ayes, 10. Noes, 14 (Chong, George, King, Kuroda, Leopold, Nishimura, O'Connor, F. Wong, R. Wong, Yamasaki, Yee, Yim, Young and Ushijima). Excused, 1 (Taira).

Senate Bill No. 2287-78:

On motion by Senator Nishimura, seconded by Senator O'Connor and carried, S.B. No. 2287-78, entitled: "A BILL FOR AN ACT RELATING TO THE LIMITATION OF ACTIONS FOR DAMAGES TO REAL PROPERTY", having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

Ayes, 22. Noes, 2 (Ching and King). Excused, 1 (Taira).

Senate Bill No. 2590-78, S.D. 1:

The motion to pass S.B. No. 2590-78, S.D. 1 on Third Reading was put by the Chair, and carried, and S.B. No. 2590-78, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO THE INTAKE SERVICE CENTERS", having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

Ayes, 24. Noes, none. Excused, 1 (Taira).

MATTERS DEFERRED FROM EARLIER ON THE CALENDAR

Senate Bill No. 1855-78, S.D. 1:

Senator O'Connor moved that S.B. No. 1855-78, S.D. 1, having been read throughout, pass Third Reading, seconded by Senator Ching.

Senator Nishimura then spoke in opposition to the measure as follows:

"Mr. President, I rise to speak against

this bill. This is another bill that emanated from the Judiciary Committee of which I am Chairman and I signed the Committee Report 'I do not concur' This bill will amend Section 706-646.5 relating to sentencing of repeat offenders.

The laws as we presently have on the books provide that for certain kinds of convictions pertaining to murder, relating to assault in the first degree, relating to kidnapping, relating to rape in the first degree, relating to sodomy in the first degree, relating to burglary in the first degree, relating to robbery in the first degree, relating to the promoting of a dangerous drug in the second degree, relating to the promoting of a harmful drug in the first degree, we have mandatory prison sentences.

It would require, for example, that upon conviction of a second offense for the same offense, in these categories, a person would be sentenced for five years and for the third conviction for the same offense, for ten years mandatory sentence.

The laws on our books, Mr. President, in our Penal Code, provide the chapter on disposition of defendant. It's a balanced, logical, cohesive, rational and integrated treatment of how to handle defendants who are convicted for crimes that they are charged with, particularly felony.

For example, when a person is convicted, our Penal Code Section 706-605. Authorized disposition of convicted defendants..." (Senator Nishimura read the entire section from the Hawaii Revised Statutes.)

"Mr. President, this is what the courts may do when a person has been convicted. Now if the court is going to sentence the person, then the court has to consider Section 706-621. Grounds favoring withholding sentence of imprisonment..." (Senator Nishimura then read the entire section from the Hawaii Revised Statutes.)

"Then, Mr. President, there is Section 706-622. Criteria for placing defendant on probation..." (Senator Nishimura read the entire section from the Hawaii Revised Statutes.)

"On the other hand, Mr. President, when the person has been convicted of a felony and the felony for the person being sentenced falls into certain categories outlined in the Penal Code, then the sentencing is a little stricter. For example, there is a clear provision in the law for the judge to sentence imprisonment for extended terms and in Section 706-662. Criteria for sentence of extended terms of imprisonment for felony..." (Senator Nishimura then read the entire section from the Hawaii Revised Statutes.)

Mr. President, this bill would substitute a legislative mandate that the judge or the Parole Board not exercise any of the discretionary powers that they have in looking at the record of the defendant before the court or the Parole Board that is sentencing him.

I feel, Mr. President, that the Penal Code which has been praised by many people spells out correctly the approach to be used when sentencing a person who has been convicted of a felony, whether he be classified as a multiple offender or dangerous offender or as a professional criminal.

I think it is better to leave the sentencing aspect to the person who is handling the case, who has the felon before him, so that all the pertinent factors and circumstances may be reviewed and the sentencing can be appropriate to the offense and to the individual.

If there is a feeling by the members of this body that the court or certain judges are not implementing the laws of this State correctly, then the proper action to take is to have an investigation and perhaps impeach and remove such incompetents, if he be an incompetent judge. I do not believe, Mr. President, that by enacting mandatory sentencing, we are going to change the incident of crime or the number of criminals that are sent to jail.

For this and other reasons, I urge all the members of this body to vote down this bill on mandatory sentencing."

Senator Kawasaki spoke in favor of the bill as follows:

"Mr. President, I would like to compliment the members of the Judiciary Committee who heard testimony for and against this bill. By virtue of the number of people who have voted in the majority for the enactment of this bill, I think perhaps this is evidence that we are all concerned about the effectiveness of all the statutes covering fines, parole and the implementation of the statutes that we have.

I think if we are really to give meaning to our professed desire to contain the activities, particularly of the serious offender, the felon Class A, B and C, then it behooves us at least to enact this legislation and see what kind of a dent it will make in our crime statistics.

I think you are, as I am, appalled almost weekly when I pick up the morning and evening papers and find that some of the apprehended criminals in very serious offenses against persons particularly, are people who have been paroled time and again...people who had paid fines, people who are back in society again inflicting damage. I point out to you the recent cases of victims who are no longer living today because they were the victims of paroled felons, who were put into society at the judgment of parole authorities.

Had the proponent of this bill who just spoke not been such a strong advocator of the Parole Board having the responsibility of setting the minimum sentence, then perhaps what he has just recited would be received by me with some credence.

He has admitted that who knows better the proper disposition of an offender than a court judge who presided at the trial, who took into consideration all of the evidence of the particular offense, who took into consideration the personal history, the criminal history of an offender. Yet he advocated that we leave the decision as to minimum sentencing on the part of the Parole Board.

I don't quite understand this disparity of view here. As a matter of fact, I wish that the previous bill had passed.

I had the occasion to speak to a number of very respected judges in the Circuit Court system and the Supreme Court, notwithstanding the contention that the Judiciary-and I suppose in this case he is talking about the administrator, Mr. Cingcade, his opposition to the passage of the other bill.

I am concerned on the part of respected judges who are exasperated and chagrined at the fact that, while they mete out sentences that they think are effective in keeping with the seriousness of the offense, the paroling authority metes out minimum sentences that are just a fraction of the original sentence.

When you have this dual authority here I say that existing statutes would be made a sham, statutes regarding fines, the imposition of fines, and the paroling system. I maintain that if we are to have some effective means of combating the proliferation of serious crimes, particularly against persons, then we've got to mandate by statute, mandatory sentencing legislation.

For that reason, I support the enactment of this bill."

## Senator Nishimura responded:

"Mr. President, in response to the previous speaker's comments, I must admit that I am not as articulate as he is, not having had many occasions to expound on this floor and I don't know as many \$50 words as he does, but I think I read the Hawaii Penal Code a litle bit better than he can. And what this thing says is that the judge may withhold sentencing of imprisonment. In other words, the judge may grant probation and he has that function.

On the other hand, the judge does impose the maximum sentence when he does imprison a defendant. The paroling board does impose the minimum sentence. What I am saying is that this is a simple bill on its face, but it has wide ramifications. It touches many parts of the Penal Code pertaining to disposition of defendant.

In our highly complex and technological society, Mr. President, there are no simple answers, only intelligent choices. I submit that staying with the Penal Code is better than enacting laws that appear simple but will not do the job.

Thank you.".

Senator Anderson then commented:

"Mr. President, the Hawaii Penal Code isn't a 'sacred cow' document. It was a document that the judges spent many hours on as one to bring our laws in uniformity and conformity. It was to bring some equity. But it is a living document.

It's one that can be changed and amended as times change. I would hate to think that my support of the Hawaii Penal Code some years back was one that I could never change my mind on, I could never amend, or I could never look at it differently as society changes.

I think the Hawaii Penal Code and its various sections--and I don't profess to be an expert in it--needs constant review as the problems in society become more complex. I think it's a document that definitely needs review. The Chairman of the Judiciary Committee was talking about the public having the right for an investigation if they aren't satisfied. Well, I saw some 2,000 to 3,000 signatures circulating in the Capitol a couple of days ago calling for such an investigation, and I haven't heard yet the Senate Judiciary Committee picking up the cause for the public to be a forum for the public hearing.

The Supreme Court, I suppose, is the proper role, but if the Senate Judiciary Committee is really concerned in what he says in the problems of the public and their sincerity, then maybe the Senate Judiciary Committee is the proper forum for receiving these 2,000 signatures and listening to some of the problems of our people.

Earlier he said that the judges and their discretion...well, their discretion is challenged and questioned by the great majority of our people in this society today in our State. They don't have much confidence in the judicial system anymore. Maybe it is time the mandated sentences be tried or tested and maybe it's an overreaction for a period.

Many of our laws I think are overreactions

when you get into a period of concern and I would like to have seen this bill go one step further in this period of overreaction.

I guess I am as guilty as anybody else. I think these people ought to be put in jail once they've repeated two, three and four times and then the key thrown away."

The motion was put by the Chair and carried, and S.B. No. 1855-78, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO SENTENCING", having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

Ayes, 18. Noes, 6 (King, Nishimura, Toyofuku, R. Wong, Young and Ushijima). Excused, 1 (Taira).

At this time, members of the Senate extended congratulations to Senator Takitani on the celebration of his birthday.
