

FORTY-SECOND DAY

Friday, March 17, 1978

The Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1978, convened at 11:00 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Reverend John Butler of Cathedral of Our Lady of Peace, after which the Roll was called showing all Senators present, with the exception of Senators Anderson, Henderson, Hulten, Takitani, R. Wong, Yamasaki and Yee, who were excused.

The President announced that he had read and approved the Journal of the Forty-First Day.

The following introductions were then made to the members of the Senate:

Senator Kawasaki introduced 60 students from Kalihi-Uka Elementary School, accompanied by their teachers Mrs. Alice Takata, Mrs. Wendy Nakanishi and Miss Judy Yoshida.

Senator Ching introduced 56 sixth grade students from Pearl City Highlands Elementary School, accompanied by their teachers Mrs. Joan Higashi, Mrs. Janice Kashiwabara and Mr. Wayne Sakai.

Senator Ching then introduced Senator and Mrs. Ruben Ayala and Senator and Mrs. Robert Nimmo, members of the California State Senate, Chairman and Vice Chairman of the Agriculture Committee, respectively, accompanied by Miss Karen H. Iwamoto, Public Affairs Assistant, Amfac, Inc.

Senator Toyofuku introduced 10 Kauai High School students, accompanied by their advisor Mr. James Yamamoto; and 45 students from Kapaa Elementary School, accompanied by their principal Mr. Shimamoto and a group of chaperones.

Senator O'Connor then introduced Mr. Norman Berg, a dear friend, from Seattle, Washington.

Senator Leopold introduced 24 seniors from the Hawaii Baptist Academy, accompanied by their teacher Cathy Colbert.

Gupton, President of the Society of the Friendly Sons of Saint Patrick of Hawaii and presented him with a certified copy of the resolution and a lei. Also introduced were Mr. Arthur P. Murphy, Vice President of the Society, and his mother.

At 11:20 o'clock a.m., the Senate stood in recess subject to the call of the Chair.

STANDING COMMITTEE REPORT

On motion by Senator Taira, seconded by Senator Soares and carried, the report of the Committee was adopted.
