Tuesday, March 21, 1978

The Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1978, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Miss Diane Smith of the Honolulu Baha'i Assembly, after which the Roll was called showing all Senators present, with the exception of Senators Hulten and Toyofuku, who were excused.

The President announced that he had read and approved the Journal of the Forty-Third Day.
