Wednesday, March 22, 1978

The Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1978, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Mr. Samuel M. Saffery, Jr. of the Liliuokalani Protestant Church, after which the Roll was called, showing all Senators present.

The President announced that he had read and approved the Journal of the Forty-Fourth Day.

The following introductions were then made to the members of the Senate:

Senator Toyofuku introduced 66 students from the fourth grade at Kapaa Elementary School, Kauai, who were accompanied by their teachers, Miss Ebinsay, Miss Mower, Mrs. Oshima and Mrs. Yokota; and eight parents, including Councilman Jerome Hew.

Senator Anderson introduced 42 members of the Makiki Senior Citizens Club.

Senator Chong introduced a group of 30 students from the Speech Class at McKinley High School with their teacher, Mrs. Fely Serra.

DEPARTMENTAL COMMUNICATION

A communication from the Director of the Department of Regulatory Agencies (Dept. Com. No. 8), acknowledging receipt of Senate Resolution No. 240 (1978), was read by the Clerk and was placed on file.

HOUSE COMMUNICATIONS
