At this time, Senator Yee rose on a point of personal privilege and stated:

"Mr. President, for information and concern, about 8:35 a.m., this morning I was involved in a four-car accident on the H-1 Freeway. Cars were damaged, one was totally destroyed, but, fortunately, no one was hurt.

I bring this up because several months ago I had written to the Chief of Police of Honolulu to ask why citations are not issued by police officers to persons who are in the wrong that caused accidents, and the answer was because of the nofault insurance law passed by the Legislature; that it was an administrative decision of the Police Department who felt that because of no-fault there was no need to interview witnesses; that there's no need to cite anyone for traffic violations and as a result there has been a tremendous savings toward the Department's effort in having their personnel testify in court because of witnesses and violations. As a result, I think, we have all witnessed the increase of premiums on our insurance policies, whereas, no-fault was supposed to help reduce premium.

In my very recent encounter with a very serious traffic accident involving

four cars, the police did their duty as was laid down by the administration of the Police Department. Nobody was cited, everybody is to take care of their own injuries, their own damages to their cars.

I can't help but feel that the wrongdoer will continue to get away whenever there's a traffic accident when no citation is issued and there is no need to appear in court. He will continue to be a reckless driver on the streets.

Mr. Bill Wood, editor of the Hawaii Business Magazine had written an article in the last issue expressing the same concern that I am expressing to you today.

I bring this to your attention because I think this is something that we should all look into in the next session.

Thank you, Mr. President."

Senator Ching then stated:

"Mr. President, a brief rejoinder to the Minority Leader's remarks, if I might.

First of all, I think we all share the feeling that we're glad no one was hurt in the accident, but whatever the action the Police Department has taken, I think this is not as a result, a direct result, of any legislation that this Legislature had a hand in. This was an administrative decision, as the good Senator pointed out.

As far as the no-fault part of our law, and I know there are eminent attorneys in the hall that can correct me on this, the personal injury part of it is covered by your own coverage but as far as the damage to the vehicle, you can still go after the wrongdoer and file a civil action, if necessary, so that he does not get away scot-free, that part of it I have learned through bitter experience.

Thank you, Mr. President."
