## Friday, April 7, 1978

The Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1978, convened at 11:30 o'clock a.m., with the President in the Chair.

Senators King and F. Wong, for the Committees on Ecology, Environment and Recreation and Economic Development, presented a joint report (Stand. Com. Rep. No. 830-78), recommending that Senate Concurrent Resolution No. 96, as amended in S.D. 1, be adopted.

Senator King moved that the joint report of the Committees be adopted.

and that S.C.R. No. 96, S.D. 1, be adopted, seconded by Senator F. Wong.

Senator F. Wong then stated as follows:

"Mr. President, I rise to speak with reservation in support of Senate Concurrent Resolution No. 96 and also Senate Resolution No. 344 which follows, relating to coastal zone management. As members of this Body know, I have signed the committee report 'with reservations' and I would like to state those reservations at this time.

Last year, we enacted Act 188 which many of us considered to be the finest coastal zone management program in the United States. The Legislature in addressing the question of the conformance to the federal coastal zone act said, 'Your Committee recognizes that federal funds are important to implement this Act, but the primary motivation for enactment is to have the best possible coastal zone management program in the United States and one that clearly recognizes Hawaii's unique natural resources and the geographical and political configuration of our islands.'

Furthermore, in the finding and purpose of the Act, we stated, 'Where Hawaii's unique geographical and political circumstances result in a necessity of choosing between the intent of the federal legislation and the specific requirements, the purposes of this Act shall control.'

It seems to me that the legislative intent in no uncertain terms said, if we could not obtain federal funds based upon Act 188, then it was just too bad.

Now we have a situation where the Department of Planning and Economic Development in the administration of this Act is seeking federal funds and because the federal government has indicated that the shoreline management area in the Act does not comply with the federal requirements, it has established an 'administrative boundary' for the purposes of coastal zone management.

The administrative boundary establishes as the area for coastal zone management, the entire State of Hawaii except for forest reserves. I hesitate to second guess the administration in its negotiations with the federal government, but I cannot help but question the wisdom of offering the entire State, except for the forest reserve, as an administrative boundary and then trying to reduce that area at a later date in determining the permanent boundary.

Perhaps a better course of action would have been to submit the application using the existing Shoreline Management Areas and let the federal government tell us what they can and cannot live with, or offer an area twice the size of the existing SMA. I fear that once we have given the federal government the entire State, that it will be very difficult to take anything back.

Mr. President, to designate the entire State except for the forest reserve is not only questionable, but more importantly, it is poor management and ignores Hawaii's unique geographical and political configuration.

It does appear that DPED in its quest for federal funds is jeopardizing the delicate balance that we reached last year in designating and designing a coastal zone management program.

Mr. President, the natural resources of our coastline are too important to be a political football between the federal and State governments. In this regard, the State government should dictate the kind of program that we feel is best suited for the State of Hawaii and not vice versa. We cannot afford to let the federal government tell us how we should run our coastal zone management program.

Mr. President, if DPED's 306 application is successful, we will receive approximately \$1.8 million. That is too cheap and too little to gain for what we will have lost to the federal government.

The actions of DPED have caused me grave reservations and I fear for the real price that we will have to pay for receipt of these federal funds.

Thank you, Mr. President."
