

## FIFTY-SIXTH DAY

Monday, April 10, 1978

The Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1978, convened at 11:30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Reverend Norman Okasako of the Mililani Missionary Church, after which the Roll was called showing all Senators present, except Senator F. Wong, who was excused.

The President announced that he had read and approved the Journal of the Fifty-Fifth Day.

The following introductions were made to the members of the Senate:

Senator Anderson introduced 45 members of the Aiealani Senior Citizens Club.

Senator Yee introduced Soloman and Henrietta Aikau, parents of Eddie Aikau, crew member of the Polynesian Voyage Society canoe Hokule'a who was lost at sea on its voyage to Tahiti. Also introduced were Eddie Aikau's sister Myra and brothers Frederick, Solomon and Clyde, accompanied by their dear friend Zulu. Sitting in the gallery and also introduced were friends of Eddie and members of the rescue group, David Bettencourt, Arthur Daegling, Jr., Wayne Miyashira, Linda, and Capt. David Lyman. Mr. and Mrs. Aikau were then presented with a certified copy of S.R. No. 375 honoring Eddie Aikau which was adopted in the Senate on March 23, 1978.

At 11:45 o'clock a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 11:54 o'clock a.m.
