# FIFTY-EIGHTH DAY

## Wednesday, April 12, 1978

The Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1978, convened at 11: 30 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by Reverend Noboru Ayabe of the Nanaikapono Protestant Church, after which the Roll was called showing all Senators present.

The President announced that he had read and approved the Journal of the Fifty-Seventh Day.

The following introductions were then made to the members of the Senate:
