The Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1978, convened at 2:30 o'clock p.m., with the President in the Chair.

The Divine Blessing was invoked by Reverend Don Baron of the Bible Institute of Hawaii, after which the Roll was called showing all Senators present.

The President announced that he had read and approved the Journal of the Fifty-Ninth Day.

The following introductions were made to the members of the Senate:

Senator R. Wong introduced Mr. Akito "Blackie" Fujikawa, a leader in the movement of IBEW 1186, who was sitting in the gallery.

Senator Chong introduced his friend, Mrs. Elke Marsh, a poet.

Senator King then introduced Mr. Eddie Kamae, leader of the "Sons of Hawaii," and the honoree of S.C.R. No. 18, which was adopted in the Senate on April 4, 1978. Mr. Kamae was presented with a certified copy of the resolution and a lei. Mrs. Myrna Kamae, Eddie's wife, and members of the "Sons of Hawaii," Joe Marshall, David Rogers, Dennis Kamakahi and Joe Bourque were also introduced.

At 2:49 o'clock p.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 2:51 o'clock p.m.

MESSAGE FROM THE GOVERNOR

A message from the Governor (Gov. Msg. No. 260) returning Senate Bill No. 1596-78, without his approval, together with his statement of objections relating to the measure which reads as follows:

Pursuant to Section 17 of Article III of the Constitution of the State of Hawaii, I am returning herewith Senate Bill No. 1596-78, Senate Draft 1, entitled, 'A Bill for an Act Relating to a Study on the Development of an Effective Used Oil Recycling Program.'

The purpose of this bill is to obtain basic information needed to initiate a used oil recycling program in Hawaii by requiring the Energy Resources Coordinator to conduct a study. Although I agree that a study to obtain such information should be conducted, it appears that this bill is not necessary because a similar study has already been included in the State Energy Conservation Program of the Department of Planning and Economic Development. Since federal funds have already been granted for the study, a study will be conducted under the grant from the United States Department of Energy to obtain the information needed to initiate a used oil recycling program in Hawaii.

I have been informed that there also appears to be a constitutional objection to this bill because this bill did not pass three readings in the Senate as required by Section 16 of Article III of the Constitution of the State of Hawaii. As introduced, Senate Bill No. 1596-78 was titled, 'A Bill for an Act Relating to an Appropriation for a Study on the Development of an Effective Used Oil Recycling Program' (emphasis added). The purpose of the bill, as stated in Section 1 of the original bill, was 'to fund a study to obtain basic information needed to effectuate an [sic] used oil recycling program in Hawaii' (emphasis added). Section 2 of the original bill, on page 2 at lines 21-23, appropriated \$20,000 for the study. After Senate Bill No. 1596-78 in its original form passed first reading in the Senate, the title and the body of the bill were amended. The body of the bill was amended to delete the appropriation and to change the purpose of the bill by deleting the words underscored above, 'to fund a study.' The title of the bill was amended to delete the words underscored above, 'an Appropriation for.' It appears that the changes in the body and the title of the bill resulted in a new bill that materially differed from the bill originally introduced and, therefore, the new bill should have independently met the three-reading requirement of Section 16 of Article III of the Constitution of the State of Hawaii. Unfortunately, Senate Bill No. 1596-78, Senate

Draft 1, was not reread in the Senate as a new bill and was read only twice.

Consequently, in view of the lack of necessity for this bill and the apparent constitutional objection that could be made to it, I am herewith returning this bill, as provided by Article III, Section 17, of the State Constitution.

Senator F. Wong then rose to speak in favor of the measure and stated:

"Mr. President, I rise to speak in favor of H.B. No. 2173, C.D. 1, the Hawaii State Plan.

Mr. President, three long years ago this Legislature began its work on the Hawaii State Plan. In drafting Act 189 in 1975, there was a great deal of confusion as to the meaning of a policy plan, as well as the meaning of objectives and

policies. A year later, there were new words added to our vocabulary such as functional plans and even later such things as priority directions. All of these words are now household words.

It was obvious in 1975 that we desperately needed a better planning process for our State. In that year we reconstituted the land use commission and in doing so enacted interim land use guidance policies which will fall upon the enactment of the Hawaii State Plan. Later, we enacted an interim tourism policy act which was used to guide the development of tourism in the State of Hawaii which will also fall upon the enactment of this Plan. Last year we struggled with the issues relating to coastal zone management and found that without a blueprint it was becoming increasingly difficult for us to understand and appreciate the various governmental relationships and the priorities for our State.

Mr. President, in the last three years I have been convinced more than ever that the Hawaii State Plan is long overdue. There is a need for us to plan comprehensively for Hawaii's future rather than reacting to brush fires which oftentimes become roaring forest fires. We need to establish an orderly process whereby the Legislature in exercising its constitutional responsibility will act as the chief policy making body in the State.

The Hawaii State Plan is a bold step in this direction. It balances well the interest of the State and the County governments as well as being sensitive to the needs of the residents and people of Hawaii.

Mr. President, the Hawaii State Plan is not perfect, but it has a solid foundation. It is structured in such a way that it invites public review and input; it invites the Legislature to review recommendations made by the policy council and further invites the Legislature to amend the Plan on a regular basis.

Mr. President, this Plan is an opportunity and a challenge. It is an opportunity to plan for Hawaii's future in a comprehensive manner and to provide direction and priority for the use of our precious and limited resources. It is a challenge to the State and County governments to work together in harmony within the parameters of the State Plan. It is a challenge to the Legislature, to exercise its constitutional responsibility as the chief policy maker. Only time will tell whether or not these challenges will be met. I am confident that with the spirit of cooperation that it can

and will be done.

Mr. President, three years is a long time to work on one bill. The last eight days appeared to be an eternity. Many people within the State and County governments have generously given of their time and talents to produce this important document. I would be remiss however, if I did not recognize the very special contribution of Gay Larned-Griffin, the clerk of our committee, whose dedication and commitment to the Plan was an inspiration to us all. Mr. President, the Senate conferees on the bill deserve the admiration of all of us. The time we spent together on the bill is not important, but the way that they conducted themselves in conference makes me very proud and privileged to be associated with them. At times they were patient and tolerant, at other times they were firm and aggressive, but at all times they conducted themselves with the highest dignity and decorum. It is this kind of dedication that will create a better Hawaii tomorrow.

Mr. President, I have been asked in the last twenty-four hours as to what was the most significant thing that happened to produce the Plan. The answer is prayer. In my judgment, Mr. President, the most significant contribution that was made during the last three years for the enactment for the Plan occurred early Wednesday morning in the majority caucus room, less than fifty feet from here. On that Wednesday morning, most of the Senate conferees together with other members of the Senate and the Governor of the State of Hawaii, prayed for the House and Senate conferees, for the success of the Hawaii State Plan and for the people of Hawaii. As we prayed there were tears in our eyes for the love that we have for our State and her people. Mr. President, a few short hours later our prayers were answered and today we have a Plan that we all can be truly proud of.

Mr. President, if with further consultation with the Lord I choose to join my distinguished colleague, the majority floor leader, and seek an early retirement, I hope that I will be remembered as one of the architects of the Hawaii State Plan and for the prayer that was said that morning.

SPECIAL COMMITTEE REPORT

Senator Nishimura, for the Interim Committee on Judiciary, which was requested to conduct an investigation of juvenile offenders and to make an overall review of the existing delinquency prevention efforts in our community, as well as the existing problems and functions in the juvenile justice system, presented a report (Spec. Com. Rep. No. 1-78) with certain recommendations.

By unanimous consent, the report of the Committee was received and placed on file.

The President then addressed the members of the Senate as follows:

"Members of the Senate:

Before we get into the final moments of the session and before we adjourn sine die, let me make a few observations that I believe should be placed on the record.

In the four sessions that the members of this Body have been together, I believe it can be said, without fear of too much contradiction, that the Senate has performed as an effective, efficient, responsible, and responsive TEAM.

I emphasize the word TEAM, because our productivity has been the result of all of our members working together to come up with a meaningful set of legislation in each of the three sessions past, as well as in the session that we will soon bring to a close.

Looking back to 1975, I believe the record of our accomplishments together is a very impressive one.

We have taken initiatives to redress the imbalances in the respective powers and authority of the legislative and executive branches. We also took steps to make the judiciary branch more independent, as it should be.

Among our many other positive measures have been:

Programs to curb campus violence and strengthen school security.

A crash program to build a new maximum security facility for our State Corrections Program.

Establishment of a full-time Public Utilities Commission and a Paroling Authority.

Homeowner taxation relief by doubling the home exemption, as well as improved tax credit for the low-income taxpayers.

Legislation to insure health care service for the public by enacting a medical malpractice law.

Adoption of a State Plan as a blue print for our future.

Our interest in promoting diversified agriculture was demonstrated in many programs, among them the funding of the agricultural parks throughout the State, additional financing for the Farm Loan Program, and commodity development.

We saw the day of the small farmer returning, and we took those steps necessary to let our young men and women return

to the soil' as yet another career option. Certainly an important consideration in encouraging this industry was our desire to continually increase Hawaii's self-sufficiency.

Threatened by national and international economic forces, we also came to the defense of the agricultural industry that originally led Hawaii's emergence into the modern world -- our vital sugar industry.

The Kakaako Redevelopment Project that is currently under way is also a consequence of the Senate's initiative and foresight.

In response to concerns over a sluggish economy, we pumped many millions more dollars into programs to fund State public service jobs and to step up repair and maintenance in public works.

Last year, we turned our attention to growing problems of crime and violence throughout the State by setting up a Crime Commission to determine the extent of our problems. This agency has been reorganized and extended through legislation approved this year.

We also focused our concentration even more in problems related to unemployment and our economy by passing a package of legislation designed to stimulate economic recovery.

We also zeroed in on two matters important to Hawaii's future: energy and aquaculture.

The follow-through legislation passed this year will, we hope, pave the way for making aquaculture the major industry it should become in Hawaii in the near future.

And, while it may not be recognized as such today, I am certain that in the future the energy legislation we have approved this year will be acknowledged as a measure of this Senate's foresight.

In all that we have managed to accomplish over these past four years, my job as President has been made easier by each of you, through your individual diligence and dedication to the common good.

Above all, this Senate has worked together to be productive. We have stood together when it counted, and I think this is something that this Senate should be remembered for.

Certainly, the example you have

set underscores the real merits of a bicameral legislature.

To me, it is a mark of statesmanship that partisan considerations have rarely impeded the progress of our labors in this Body. On this score, I want to express my appreciation to and commend the minority members and their leadership.

In matters that counted, you have been part of the Senate team, and you deserve to share in the record of achievements compiled in the past four sessions.

I want to again thank each of you and your efficient staff members for making the work of this Chair so pleasant and enjoyable in the sessions that I have been privileged to serve as your presiding officer.

Needless to say, there have been difficult moments -- what job would be worth it were it not for its challenges -- but, by and large, such problems have been resolved with a minimum of lasting grievances because of your desire to work as a team.

Finally, let me acknowledge the uncertainty of the future. I know that a majority of you will be seeking reelection to this Body later this year. We all know that the mood of our constituents is subject to constant shifts in public attitudes.

In my judgment, the voters of your respective districts would be well served by sending all of you back here for another four years.

To each of you, then, Mahalo, my very sincere thank you, and good luck in your future endeavors."

Senator Yee then rose and spoke as follows:

"Mr. President, I'd like to make a few closing remarks.

First, I want to thank all of the majority members for the excellent cooperation they have given the Republicans on this side of the aisle. Thank you for your inspiring leadership during the past four years.

I know some will be saying that this has been a dull session, a quiet session, but let me say that the past four years were very difficult years not only in Hawaii but throughout the United States. These were the years of adjustments, the honeymoon and growth periods were over and it is only natural that we do have a sober session.

This is the first time in my 16 legislative sessions that we are going to adjourn

before the sun goes down and this in itself is a record. It shows the cooperation and the seriousness that we have together taken the concerns of the public.

I want to thank all of you and I do hope we all come back next year because, of those I know who are running for offices, we may not be as quiet and comfortable in the next four years.

Thank you, Mr. President."

Senator Taira then rose to make an announcement:

"Mr. President, I want to announce that I shall not seek re-election to the State Senate this fall. I make this announcement at this time to end all speculation as to my political plans for the future.

This is my 16th year of legislative service, divided equally as a member of the House and as a member of this distinguished Body. Together with my earlier 9 years of service as a public school teacher, I shall be rounding out 25 years of public service. I am proud, happy and thankful for having had such an opportunity to serve our people, and I hope that I have in some small measure, contributed to the growth and progress of our great State of Hawaii during these very difficult years.

I shall retire with no regrets because I know there will always be men and women of vision and dedication ever ready and willing to carry on. This is what has made Hawaii a great State, and I am confident that the future holds bigger and better things for our State and our people.

And now I extend to each of you Senators, your staff members and workers in the Senate and the House, at all levels, to all of you I extend my warm and sincere Mahalo for your friendship, understanding and cooperation during these past 16 years. I wish you well in your future political and legislative endeavors, whatever they may be.

Thank you, Mr. President, and again, Mahalo to all of you."

Senator Toyofuku then commented:

"Mr. President, I rise to speak in compliment to the previous speaker.

I have much mixed emotions today because I feel as though I've just lost my left arm. I feel like I've lost a good friend, a colleague whom I

admire, a brother whom I have done many things with, and worked with on many projects. And yet, Mr. President, I'm very pleased, pleased and happy because my good friend Bob will finally be able to have the peace of mind and the rest that he so richly deserves after many frustrations, disappointments, pressures and anxieties of being a legislator for more than 15 years. This is not to mean, of course, that there has not been much satisfaction, but rather there has been much pleasure and satisfaction of knowing that he has contributed much to the well-being of the people in our State.

Mr. President, I would like to ask you and all of my colleagues to join with me in wishing him well, much happiness and success in the future to you, Bob.

Thank you."

Senator Kawasaki then stated:

"Mr. President, I, too, would like to join the distinguished Senator, Chairman of the Human Resources Committee, in commending my colleague on the left of me for his illustrious service in this Body.

Up until 45 minutes ago I had hopes of possibly talking this gentleman out of retiring because I think his services will be sorely missed here and I believe everyone here shares this feeling with me.

There was never a member of the Senate who is more convivial -- and I am sure my fellow Senators Hara, Toyofuku and Ching will agree with me. We will sorely miss him.

I had some suggestions communicated to me that perhaps we need to have the Governor possibly appoint Bob as Director of the Department of Agriculture to clean up the mess in the Farm Loan Program. I think most of us would take that suggestion to heart and perhaps might make this suggestion. In any case, I too want to join Senator Toyofuku in wishing Bob Taira all the happiness and all the satisfaction and he is assured that we will be calling on him to help us.

We wish him well and hope that he will enjoy the mahjong sessions that he delights in. We hope too that he'll be a good grandfather doing a lot of babysitting chores that he also delights in.

Good luck to Bob Taira!"

Senator Ching then rose to speak, as follows:

"Mr. President, I just heard an announcement that I hoped would not be made. However, I know all of us wish Bob well.

I have two wishes to make. Perhaps somewhere along the line he will see his way through to further serving the people of this State in one more capacity, that is, as a delegate to the Constitutional Convention. We will need men, and women, like him - men of vision and dedication, as he so aptly puts it.

The second wish is that whatever office he seeks in furtherance of his public career, and I don't think he's ready, fully ready, to retire at the young age that he is at, that the rest of us will be here to heartily endorse and confirm an appointment."

Senator F. Wong also rose to speak:

"Mr. President, I would like to join in saying good things about a man that all of us truly love.

Senator Taira, as one of the co-founders of our Wednesday Prayer Breakfast, on behalf of all of the members of the Senate who participated in this affair, we would like to offer you our first, number one, charter membership and hope that you will find the time to join us on Wednesday morning starting next week Wednesday.

Thank you very much."

Senator Leopold then rose to make an announcement, as follows:

"Mr. President, barring any special session of the Legislature this will be my last day as a State Senator.

I want to thank you, Mr. President, for all the courtesies that you have given me and thank all the members of the Senate for all the courtesies that they also have given me. I'd like too, to thank the Clerk and the Assistant Clerk and all the members of the staff who have helped make my four years in the Senate an enjoyable and rewarding one.

I want to wish you, Mr. President, and every member of this Senate the best success in the years ahead."

Senator Yee then rose to comment on Senator's Leopold's remarks:

"Mr. President, I think Senator Leopold is telling us that he will not be seeking re-election to the State Senate and, I believe, we all know that he is seeking a higher office as

the Republican nominee for the Governorship of the State of Hawaii.

John has been a very diligent servant for the past four years. We all know there's no other person that has worked as hard and has shaken as many hands during his political career.

We will miss him here in the Senate and we wish him well."

Senator Soares then added:

"Mr. President, I would be remiss if I did not say a few words on behalf of both my colleagues.

Senator Leopold who I was very fortunate to serve as former leader in the House for three terms, and to have joined him in the Senate these last three years. I believe all of us have recognized that Senator Leopold is a strong-minded person, very dedicated to his cause of serving the people the best way he possibly can, does his homework and being very articulate on the floor of the Senate. I know we will all miss him and I, personally, will miss him, sitting right next to me and sharing with him the many laughs we had together.

Also, Mr. President, if I might, I want to say a very fond Aloha to my very close friend, Senator Bob Taira.

Three years ago, when we were together in Philadelphia, I was wrestling with the thought of being appointed by the Governor to this Body. Some phone calls came through and I was worried as to whether I would get the appointment or not, and Bob may have forgotten, but he reassured me that time tells and things will always come out in the wash. I got washed out and I'm now in the Senate.

Mr. President, I have never met a finer man in my life, a more reasonable person, a man with a capacity for taking one ball game at a time, having the capacity to look beyond many of our visions, and a man that is gifted, in my opinion, really gifted with the ability to hold people together.

Bob, I personally will feel very lost without you. I know we on this side of the aisle respect you very, very much and I ask God to take good care of you and help you.

We are very proud to have associated with Bob Taira.

Thank you."

Senator Chong then remarked:

"Mr. President, there's an interesting book that was published last year authored by Gail Sheehy called 'Passages.' I would like to quote very briefly some apt passages from her book because Bob Taira and John Leopold, and I quote: '... are obviously navigating through various life styles to that point of dignity worth defending...' and both understand that, and I quote again, '...that courage to take new steps allows us to let go of each stage with its satisfactions and to find the fresh responses that will release the richness of the next.'"

Senator Kuroda rose to state:

"Mr. President, I also would like to make a few remarks.

I also want to say good luck to Bob and congratulations on his retirement. However, I would like also to share my remarks more for Senator Leopold who served on the Committee on Consumer Protection and who supported me in my activities as Chairman.

Senator Taira upon his announcement had a good amount of applause, I'd like now to lead a standing applause for Senator Leopold for his hard work and for the hard task that he has before him."

SENATE RESOLUTION

A resolution (S.R. No. 499), entitled: "SENATE RESOLUTION INFORMING THE HOUSE AND GOVERNOR THAT THE SENATE IS READY TO ADJOURN SINE DIE", was jointly offered by Senators Ching, Taira and Anderson, was read by the Clerk.

On motion by Senator Ching, seconded by Senator Anderson and carried, S.R. No. 499 was adopted.

In accordance therewith, the President appointed Senators Ching, Taira, and Yee as a Committee to inform the Governor and the House of Representatives that the Senate stands ready to adjourn sine die.

At 4:15 o'clock p.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 4:51 o'clock p.m.

Senator Ching, for the Special Committee, reported orally that it has informed the Governor and the House of Representatives that the Senate is ready to adjourn sine die.

The President then discharged the Committee with thanks.

ADJOURNMENT

Senator Taira, before making the motion to adjourn sine die, remarked: "I regret that this will be the last motion I will be making in this Body."

Senator Taira then moved that the Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1978, adjourn Sine Die, seconded by Senator Anderson and carried.

At 4:54 o'clock p.m., the President rapped his gavel and declared the Senate of the Ninth Legislature of the State of Hawaii, Regular Session of 1978, adjourned Sine Die.
