Senator Ikeda then rose on a point of personal privilege and stated:

"Mr. President, I rise on a point of personal privilege.

"Mr. President, on September 10, last year, I requested an opinion from the attorney general regarding the applicability of the Sunshine Law to certain statutorily established legal entities. I intended to use this opinion to formulate legislation in the event such legislation proved necessary. During the past five months, I called the general's attornev office repeatedly regarding this request, stressing my concern that this opinion be rendered in time for the drafting of legislation. I have continually assured that it is imminently been forthcoming.

"Mr. President, we are now two days away from the deadline for bill introduction, and I have yet to receive that opinion. Therefore, Mr. President, I am invoking Rule 81 of the Senate Rules for the Fourteenth Legislature which provides that 'Any member of the Senate may ask any question of any state officer relating to the officer's respective department ...' and 'Any officer questioned shall reply to such question upon the following day, unless the Senate shall grant a definite extension of time for replying.'

"Mr. President, I asked the attorney general of the State of Hawaii to respond to the following question: Are the Hawaii Life and Disability Insurance Guaranty Association and the Hawaii Insurance Guaranty Association required to comply with the provisions of Chapter 92, Hawaii Revised Statues? Thank you, Mr. President."
