The following messages from the Governor (Gov. Msg. Nos. 110 to 112) were read by the Clerk and were placed on file:

Gov. Msg. No. 110, transmitting a report, "The Felony Offender and the Criminal Justice System, Arrests," prepared by the Hawaii Criminal Justice Data Center, Department of the Attorney General.

Gov. Msg. No. 111, transmitting a report to the Real Estate Commission, "Mandatory Continuing Education for Real Estate Licensees," January 1987, prepared by Mary S. Shern, consultant.

Gov. Msg. No. 112, transmitting a report prepared by the Hawaii Real Estate Commission in response to S.R. No. 188 (1986), requesting a study of problems related to the employee or independent contractor status of real estate licensees.

STANDING COMMITTEE REPORTS

No. 1, H.D. 1, entitled: "A BILL FOR AN ACT MAKING APPROPRIATIONS TO PROVIDE FOR THE EXPENSES OF THE LEGISLATURE, THE LEGISLATIVE AUDITOR, THE LEGISLATIVE REFERENCE BUREAU, AND THE OMBUDSMAN," passed Second Reading and was placed on the calendar for Third Reading on Friday, February 13, 1987.

Senator Yamasaki, for the Committee on Ways and Means, presented a report (Stand. Com. Rep. No. 2) recommending that Senate Bill No. 263, as amended in S.D. 1, pass Second Reading and be placed on the calendar for Third Reading.

On motion by Senator Yamasaki, seconded by Senator Mizuguchi and carried, the report of the Committee was adopted and S.B. No. 263, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO THE LEGISLATURE," passed Second Reading and was placed on the calendar for Third Reading on Tuesday, February 17, 1987.

Senator Cobb, for the Committee on Consumer Protection and Commerce, presented a report (Stand. Com. Rep. No. 3) recommending that Senate Bill No. 35 pass Second Reading and be referred to the Committee on Ways and Means.

On motion by Senator Cobb, seconded by Senator Blair and carried, the report of the Committee was adopted and S.B. No. 35, entitled: "A BILL FOR AN ACT RELATING TO FOREIGN BANKS," passed Second Reading and was referred to the Committee on Ways and Means.

At 11:19 o'clock a.m., the Senate stood in recess subject to the call of the Chair.
