Tuesday, March 10, 1987

The Senate of the Fourteenth Legislature of the State of Hawaii, Regular Session of 1987, convened at 11:43 o'clock a.m., with the Vice President in the Chair.

The Divine Blessing was invoked by the Reverend Dorothy Nakatsuji of the Episcopal Diocese of Hawaii, after which the Roll was called showing all Senators present.

The Chair announced that she had read and approved the Journal of the Thirty-Third Day.

The following introductions were then made to the members of the Senate:

Senator Hagino introduced 30 students from the Kaala Elementary School student council in Wahiawa, accompanied by parents: Mrs. Jeanne Omaye, Dr. Helen Shackford, Mrs. Myrna Sugiyama, Dr. and Mrs. Jared Kanemaru, and Mr. Alan Calhoun.

Senator Hagino then added:

"Madam Vice President, Alan Calhoun is the 'Pele of Wahiawa,' and for those who remember the Soap Box Derby days, Dr. Kanemaru used to represent our state at the nationals. Actually, he and his family represented us many years when we had Soap Box Derby competitions."

Senator J. Wong introduced 40 members and officers of the Young Ladies Institute (Roman Catholic Church) as follows:

"Madam Vice President, it is a great honor and privilege for me today to introduce to you and this august body 40 members and officers of the Young Ladies Institute. The Young Ladies Institute is a nonprofit organization with memberships on the West Coast and in Hawaii.

"They serve the respective communities by providing scholarships, nursing, social work and science programs for women, and educating young men toward the priesthood, as well. They offer food, clothing and necessities to the poor, the young, the handicapped, the elderly and for people in cities and towns where the institutes are located.

"At this time, Madam Vice President, I'd like to present the Grand President of the Young Ladies Institute, Sharon Colone. Madam Vice President, Sharon is here on her annual official visit to Hawaii to meet with all of the Hawaii members from the Kaneohe, Kailua and Honolulu institutes. Most importantly, she is here to present Bishop Joseph Ferrario with the Golden Jubilee Burse Check. This money is

contributed by the three Hawaii Young Ladies Institutes yearly for educating young men towards the priesthood.

"The other officers present on the floor, Madam Vice President, are from San Francisco and are past grand presidents: Irene Texeira; Peggy Anderson; the grand secretary, Loretta O'Rourke; the grand director, Claire Kendall; and Florence Williamson of Kailua who is the district deputy of Hawaii's three institutes.

"We have other members in the gallery, Madam Vice President, and would they please stand and be recognized.

"Madam Vice President, this is also an additional honor for me today because my mother is a member of the Young Ladies Institute and she's here in the gallery today, Mrs. Marcellina Wong."

All of the honorees rose to be recognized and were presented with the congratulatory certificate and leis by Senators Hee, Holt, Chang, Matsuura, Reed and J. Wong.

At 11:50 o'clock a.m., the Senate stood in recess subject to the call of the Chair.
