### FORTY-FOURTH DAY

## Thursday, April 2, 1987

The Senate of the Fourteenth Legislature of the State of Hawaii, Regular Session of 1987, convened at 11:42 o'clock a.m., with the Vice President in the Chair.

The Divine Blessing was invoked by the Reverend Peter Salmas of the Saints Constantine and Helen Greek Orthodox Church, after which the Roll was called showing all Senators present.

The Chair announced that she had read and approved the Journal of the Forty-Third Day.

The following introductions were then made to the members of the Senate:

Senator Chang introduced representatives from the St. Francis Home Care Services, who were present on the Senate floor, as follows:

"Madam Vice President, it is my great pleasure to present a certificate today to the St. Francis Home Care Services, recognizing the pioneering efforts of St. Francis Home Care Services in Hawaii.

"The St. Francis Home Care Services began in Hawaii on April 2, 1962 as one solution to rising medical costs and as an alternative to institutionalization. Through home care services, a patient receives quality and professionally supervised care from family or friends in his or her home at considerably less cost than if cared for in a hospital or nursing home.

"As today is Thursday, April 2, and is the 25th anniversary of the founding of St. Francis Home Care Services in Hawaii, we have asked several administrators and representatives of the hospital to be with us today: Sister Maureen Keleher, president of St. Francis Hospital; Ms. Charlotte Dennis, director of home care services; Mr. Wally Wake, coordinator of St. Francis Hospital; and Mr. Vincent Lee, assistant administrator for the medical center."

The honorees rose to be recognized and were presented with the Senate Certificate by Senator Chang.

Senator Henderson introduced Miss Diane Vey from Kona, Hawaii, president of the Island Hotel Association. Miss Vey was at the Legislature representing the Big Island Business Council, accompanied by Mr. Clem Judd.

Senator Ikeda, on behalf of Senators Cobb and B. Kobayashi and herself, introduced 140 students of the Kaiser-Kalani Interaction Council, representing their grade level in their school student council, who were at the Legislature learning about the different branches of government. They were accompanied by various principals: Mrs. Lum from Koko Head Elementary School, Mrs. Lau from Wailupe Valley School, Mr. Blitman from Hahaione Elementary School, Mr. Pangilinan from Aina Haina School, and Dr. Noda from Kahala Elementary School.

Senator Reed introduced Mr. David Foster from Molokai who was at the Legislature to testify in one of the hearings.

Senator Menor introduced members of the Aloha Medical Mission, who were present on the Senate floor, as follows:

"Madam Vice President, it gives me great pleasure to introduce to this honorable body several individuals who are members of the Aloha Medical Mission. The Aloha Medical Mission is basically an outstanding organization that has devoted a lot of time and effort to providing free medical services and care to the needy in the Philippines.

"During the past few years, the Aloha Medical Mission has sent physicians from Hawaii to the Philippines to provide this kind of medical care to the needy and most recently, as the certificate that we will be presenting to them indicates, they went to the Philippines in December 1986 to the Bacolod Negros Occidental Province where they donated medical and hospital supplies, provided health education services, trained local doctors, and even rendered free medical services to the needy who do not have access to or who cannot afford professional health care.

"So, it is basically for these accomplishments, these contributions, that these particular physicians and volunteers are being honored today.

"They would like to continue their outreach effort. They would like to go back to the Philippines once again during the coming year to continue to provide those very important services and if at all possible, if their fund raising permits, they would also like to expand their efforts beyond the Philippines and go to places in the Pacific Basin such as, Tonga, Samoa and Palau, and in Southeast Asia where there are also many areas that are in desperate need for this kind of medical care from competent and qualified physicians that we have in Hawaii.

"So, in that regard, they are also going to be having more fund raising activities and, for the information of this body, they have one scheduled for May 9 at the Halekulani Hotel, and if anybody here would like to participate in that you can always contact my office.

"I would like to introduce several of the leaders and participants in this medical mission: Dr. Ramon K. Sy, chairman of the Board of the Aloha Medical Mission; Dr. Erlinda Cachola, president of the Aloha Medical Mission and the wife of our distinguished State Representative Romy Cachola; Dr. Danilo Ponce, a volunteer for the Aloha Medical Mission and who is now president of the Philippine Medical Association that was in fact the organization that spearheaded the creation of the Aloha Medical Mission; and Dr. Charles Carroll, also a volunteer and the assistant chief of surgery for Tripler Army Medical Center."

The honorees rose to be recognized and were presented the Senate Certificate by Senator Menor and leis by Senators Fernandes Salling, B. Kobayashi, A. Kobayashi and McMurdo.

Senator Menor also introduced the rest of the members of the Aloha Medical Mission who were sitting in the gallery.

At 11:54 o'clock a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 11:59 o'clock a.m.

Senator Ikeda also introduced the Cherry Blossom Festival Queen and her court as follows:

"Madam President, it gives me great pleasure this morning to introduce to this august body some very beautiful ladies, and I know the gentlemen have already been eyeing them up.

"We have with us the 35th Cherry Blossom Festival Queen Marlene Akemi Sato. She is the daughter of Dorothy Sato and the late George Sato and a graduate of Kalani High School. Her ambition is to pursue a successful career in marketing combined with a happy and fulfilling family life.

"We also have with us her court. The first attendant is Kimberly Hatsue Inouye, the daughter of Dennis and Thelma Inouye and a graduate of Iolani High School. Her ambition is to have a career as a broadcast journalist and share an exciting and fulfilling life with family and friends. (Not present.)

"The second attendant is Shana Miyoko Kuratsu, Miss Congeniality, the daughter of Ronald and Eleanor Kuratsu and a graduate of Kwajalein Junior/Senior High School. Her ambition is to pursue her dreams in a professional and personal life, and thus in doing so, making a positive contribution to this community.

"The third attendant is Robin Noriko Kosaki, the daughter of Robert and Helen Kosaki and a graduate of Kaimuki High School. Her ambition is to manage a public relations firm with an international clientele and someday be a warm and supportive wife and mother.

"The fourth attendant is Julie Mie Fukunaga, Miss Popularity, the daughter of Thomas and Grace Fukunaga and a graduate of Kalani High School. Her ambition is to obtain a masters degree in business administration and become a successful executive officer in a major corporation and raise a happy family.

"In addition to these lovely ladies, we also have two visitors from Los Angeles. This is the 46th year of Nisei Week Japanese Festival and we have with us Queen Jennifer Lynn Kusumoto Ahn. She was born in Los Angeles and her ambition is to become a successful business person in the fashion industry.

"Miss Tomodachi is Karen Chiemi Tokuta. She was also born in Los Angeles and her ambition is to start a computer consulting business."

Senator Ikeda then introduced Mr. Terrance Iwamoto, general chairman of the Cherry Blossom Festival, and Mr. Matt Miura, president of the Honolulu Japanese Junior Chamber of Commerce, who accompanied the women.

The honorees rose to be recognized and were presented the Senate Certificate by Senator Ikeda and leis by Senators Kuroda, Chang, B. Kobayashi, Aki, Yamasaki, Cobb and Blair.

"Madam President and members of the Senate, I must first say we enjoy your welcome, warm aloha for Karen and me to Honolulu. Our stay here has been very nice and we're now enjoying the sunny weather but believe it or not, and I don't know whether you've heard it, back home it's 85 degrees and sunny, and the week we've been here it's been rainy and cloudy. But we're enjoying it and the warm hospitality from the members of the Honolulu Japanese Junior Chamber of Commerce.

"On behalf of the 1986 Nisei Week Festival and myself, I'd like to present all of you with our official Nisei Week booklet and our official key chain necklace. Thank you."
