FORTY-NINTH DAY

Thursday, April 9, 1987

The Senate of the Fourteenth Legislature of the State of Hawaii, Regular Session of 1987, convened at 11:48 o'clock a.m., with the President in the Chair.

The Divine Blessing was invoked by the Reverend Taylor Potter of Mililani Presbyterian Church, after which the Roll was called showing all Senators present with the exception of Senator Henderson who was excused.

The President announced that he had read and approved the Journal of the Forty-Eighth Day.

The following introductions were made to the members of the Senate:

Senator Fernandes Salling, on behalf of Senator Aki and herself, introduced a group of 27 seventh and eighth grade student-observers from the Student Council of Waimea Canyon Intermediate School, Kauai, and Ms. Joanne Okamoto, student activities coordinator, and Ms. Cyndi Francisco, education assistant.

Senator Mizuguchi introduced a group of 50 sixth grade students from Waimalu Elementary School of Aiea, on a tour of the State Capitol and the courts, accompanied by their teachers, Mrs. Carol Iwase and Mrs. Cynthia Hagino, wife of Senator Gerald Hagino.

Senator Chang then introduced the Reverend Taylor Potter who delivered the invocation and said that "in Rev. Potter's alternate identity he is the instructor of fine basketball technique for the chief clerk of the Ways and Means Committee, Kevin Kuroda, and me at the YMCA."

Senator Kuroda then introduced Mr. Mike Wright, Mr. Cy Livotti and Mr. Bob Kawamoto of Little League baseball as follows:

"Mr. President, Little League baseball season has begun in Hawaii's communities. T-ball and the minor leagues and, in some cases, the major leagues are in operation on every Island and, yes, even on Molokai and Lanai.

"Each year for the past five years, two umpiring experts from Little League regional headquarters, based in San Bernardino, have come to Hawaii to conduct baseball umpire clinics.

"Mr. Mike Wright has umpired in Little League games in California for the past 23 years. He is the sports director of the Santa Ana Recreation Department where he makes his living while he does his volunteer work with Little League baseball.

"Mr. Cy Livotti has been a Little League umpire for the past 28 years. He became the Western Region chief umpire in 1980 and has traveled to Canada, Guam, and Japan to conduct umpire clinics. He first came to Hawaii to conduct umpire clinics in 1978 and has been here the last five successive years, bringing Mike Wright to assist him.

"Mr. Bob Kawamoto, the chief administrator of the Hawaii State Little League, is a resident of Kaneohe who retired from his civil engineer position with the Board of Water Supply two years. He is now a full time volunteer for Little League baseball."

Messrs. Livotti, Wright, and Kawamoto who were sitting in the gallery rose to be recognized.

Senator Solomon then introduced a group of students from Kohala High School building and construction class, accompanied by Mr. Rodney Park. The students placed first in the Hawaii District competitions in building and construction.
