Thursday, January 21, 1988

The Senate of the Fourteenth Legislature of the State of Hawaii, Regular Session of 1988, convened at 11:40 o'clock a.m. with the Vice President in the Chair.

MISCELLANEOUS COMMUNICATION

Misc. Com. No. 1, from the Department of Water, County of Kauai, submitting "Proposed State CIP Projects, Request for State Aid 1988 Session," and "Resolution No. 2," pursuant to Sec. 248-4, HRS, as amended, was placed on file.

Senator Holt then rose on a point of personal privilege, and stated:

"Madam Vice President, your Committee on Tourism has had some difficulty during the interim in getting information from the Department of Business and Economic Development (DBED).

"I think we are all aware of the trouble we had with Expo and the \$2 million oversight on the construction of their pavilion.

"In a related matter involving tourism, the House chairman requested from the DBED copies of the contract on the convention center. This letter from Representative Cachola was dated November 30, and the response is that the consultants with DBED of the convention center studies are Belt Collins and Associates, Wilson Okamoto and Associates, and R. M. Towill Corp. A copy of the contract will be sent to you as requested, upon its availability. That was dated November 30, 1987.

"Subsequent to that, the Senate -- myself -- sent a letter in early January and got a letter back from the director, dated January 11: 'In response to your inquiry regarding the consultants to DBED on the convention center studies, a copy of the contract will be sent to you as requested, upon its availability. The contract is in the process of being finalized.' But my understanding is that the consultants are working or have been working for several months.

"As a result of not getting information we asked for, we sent another letter, not asking for the contracts, understanding that they're still in the process of finalizing, but asking for information. On January 14, I sent another letter to the director and I'll read it to you:

'According to your testimony presented to this committee, last legislative session, funds were requested to undertake studies to assist with the convention center site selection process. Your letter to me dated January 11, indicates funds have been allocated to DBED for these studies.

'Please provide this committee with the following information:

(1) total funds committed for the studies, (2) scope of services for each site to be studied, including market orientation, social impact, marketability, and evaluation criteria, (3) completion date of studies on site selection criteria.'

"I got a letter back from the director saying, 'I received your letter requesting the information on the convention center. As related by our deputy, we are in the process of gathering information. We will not be able to respond by your deadlines. We'll be sending the information as soon as we are able to.'

"I met with the House Chairman on Tourism this morning because he was having the same trouble getting information, and we have decided that we will be having a joint hearing next Thursday at 1:30, conference room 5, or another room if possible, to have a briefing on the convention center studies. I'm just making an announcement of the hearing now -- next Thursday. Thank you."

Senator Cobb also rose on a point of personal privilege, and said:

"Madam Vice President, last session we had a number of very important studies that were commissioned by the Legislature, in most cases by resolution, and in all cases that I can recall, a deadline of 20 days prior to the convening of the 1988 Legislative Session.

"I note, in passing, that some of the major issues that were addressed by such studies, such as tort reform, were late in getting back to this Legislature. In fact, we only received the tort reform study on Monday of this week, which is a lot less than 20 days prior to the session.

"It seems to be only fair that if we are going to be asked to address such major issues on a timely basis, we also receive the reports back on a timely basis.

"One in particular which is very upsetting to this senator is the study that was contained within the provisions of Senate Bill 808-87, concerning a mandated study, not requested but mandated in a bill with a \$100,000 appropriation, for a comprehensive report back on the idea whether or not to sell insurance at the gas pump.

"That bill was not a request. It was a direct order of the Legislature. The resolution is a request -- sometimes with molasses on top of it. A bill is an order. And we passed a bill mandating this.

"To this date, Madam Vice President, that report has not been received by this Legislature, far beyond the 20-day deadline that was mandated in the bill. I, therefore, say for the record, I'm tired of excuses, tired of the runaround. I either want the report or I want a new auditor. Thank you."

The Chair then made the following announcement:

"Members of the Senate, all carryover bills from last year are hereby referred back to the committees they were in at the conclusion of the 1987 session. A list of all carryover bills will be distributed by the Clerk to each Senator's office this afternoon."

Senator Cobb inquired: "Madam Vice President, does that include matters in conference committee?"

At 12:17 o'clock p.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 12:18 o'clock p.m.

The Chair then responded: "Senator Cobb, for your information, conferees have not been discharged. Those bills are still in conference."

ADJOURNMENT

At 12:19 o'clock p.m., on motion by Senator Blair, seconded by Senator A. Kobayashi and carried, the Senate adjourned until 11:30 o'clock a.m., Friday, January 22, 1988.
