Senator Hee rose on a point of personal privilege and stated:

"Mr. President, last week the Committee on Judiciary had a hearing on the proposed reorganization of the Judiciary by Arthur Young and Company. Throughout the hearing which began at 10:00 a.m. and concluded at 4:30 or 5:00, the Arthur Young (representatives) did their best in demonstrating the need to reorganize the Judiciary. In fact, during the hearing process, your committee in preparing for the hearing had asked the Judiciary through their Administrative Director of the Courts for certain kinds of information which would help us to see the bigger picture with respect to reorganizing the Judiciary. Specifically, what it would cost the taxpayers in terms of salaries to division heads and those hired on contract.

"Mr. President and members, I'm here to report to you that the Administrative Director has willfully and knowingly withheld from the Legislature what it cost the taxpayers for certain positions.

"Mr. President, in a letter dated January 22nd from the court staff attorney Abelina Shaw to me, she says and I quote:

'This is in response to your request for information on whether there is a legal basis for the Judiciary to withhold from the Legislature the names and specific salaries of Judiciary employees.

'The personnel rules of the Judiciary when duly promulgated under Chapter 91, have the force and effect of law. Section 22-20-6 of the personnel rules provides that all materials contained in an employee's personnel file shall be considered confidential.'

"Mr. President and members, for your information, we did not ask for the reprimands, the suspensions or awards or honors that would be kept in a personnel file. We asked for what it cost the taxpayers to run the Judiciary. The answer was simple ... we will not tell you because we

promulgated rules which allows us to withhold such public taxpayers' expenditures from you.

"Mr. President and members, I am near completion of a letter to Chief Justice Lum and in the letter I remind the Chief Justice that ... 'As you know, the Constitution of this State provides, Section 8, Article VII, for legislative oversight of the budget by the Legislature. On that basis alone, there should be no question that we are entitled to the requested information. The constitutional basis for legislative review should also provide guidance in setting the framework for the statutory analysis performed by Miss Shaw. She, however, obviously did not proceed with guidance from the Constitution.'

"Mr. President and members, is it any wonder why the Judiciary is in a situation that they presently are with respect to the perception by the public?

"Mr. President, when the committee looked for information in the absence of the public data which this committee is entitled to, we looked in the BJ table set by the Legislature last year. We looked at a particular position, No. 24360, salary code SR-21-B and found that the legislative funding for that position was \$21,240. Mr. President and members, position 24360 is now being paid \$27,000 at a minimum and a maximum of \$43,000, twice as much as the Legislative intent.

"It would be fine, Mr. President and members, if, one, this were an aberration from the norm. It in fact is not. It is consistent with the apparent Judiciary administration's policy with respect to setting salaries. It is a violation of the legislative intent and more importantly the fact that they continue to withhold what it costs taxpayers to fund the Judiciary is indeed another slap in the face to the Judiciary and a slap in the face to the taxpayers of this state.

"Mr. President, inasmuch as this seems to be the most efficacious way of communicating to the Judiciary, I will be sending this letter to the Chief Justice and I would expect, not hope, expect that the Chief Justice is fully cognizant of the Constitution and is fully aware of what the taxpayers' expenditures are, and his responsibility as the chief jurist of this state to the legislative branch of government.

"Thank you, Mr. President."
