## FINAL READING

Conf. Com. Rep. No. 125 (H.B. No. 321, H.D. 1, S.D. 1, C.D. 1):

Senator Mizuguchi moved that Conf. Com. Rep. No. 125 be adopted and H.D. No. 321, H.D. 1, S.D. 1, C.D. 1, having been read throughout, pass Final Reading, seconded by Senator Yamasaki.

Senator Mizuguchi spoke in support of the measure as follows:

"Mr. President, I would like to say a few words in support of this bill.

"Last session, we passed the largest educational budget ever and we did it because of our high commitment to education for good schools and for good students. But, we did not have the opportunity to do something big directly for teachers, the status of collective bargaining being what it was at that time. Now we have that opportunity.

"First and foremost, we need to retain our good teachers without whom we would not be able to develop good students. We also need to attract new and creative young people to what was once and still can be a highly regarded and sought after profession. Certainly, decent salaries are absolutely necessary if we are to retain good teachers and to attract new people to the classroom.

"In this particular bill, over a period of two years starting from last September 1987, the average base salary of teachers will increase by 20 percent. Among the various salary classes, the base increase percentages range from 18 percent to 32 percent. In dollar terms the increase base salaries range from about from \$4,200 to about \$6,700. On balance, this looks like a good settlement but it's not an extravagant settlement. And in our support for better schools, it is only a first step for this session.

"The Governor, in urging immediate action on this bill, has again reaffirmed his support for a school system second to none. And you, Mr. President, on opening day, placed education high on the agenda of this body.

"So the complete record on education for this session is yet to be written. I will be calling on you to help write that record and by the end of this session I hope it will be a record on which we can be proud.

"Senators, let's begin by supporting this bill. Thank you."

Senator Solomon, in support of the measure, rose to ask if the chairman of the Education Committee would yield to a question. The Chair having posed the question and Senator Mizuguchi having answered in the affirmative, Senator Solomon asked:

"Mr. President, would you ask the chairman, has HSTA or the Education Committee come up with a plan of action of how we can weed out those teachers that are not doing their job; and, in fact, are they up to par in monitoring the teaching and delivering of educational services?

"As I have conducted my committee hearings, there is no doubt that the public is very much in support of paying those teachers who are doing an excellent job, but they (the public) would like to know and I would like to know if we do have some kind of plan of action to be sure that those teachers who are not performing up to par are sited so we can deal with that problem and see if we can come to some kind of agreement of how we're going to handle the situation. Thank you."

Senator Mizuguchi responded:

"Mr. President, I have no concrete proposal to weed out poor teachers but in this session we will be working with the Higher Education Committee because they are charged with the responsibility of preparing good teachers and, hopefully, with the collective minds of the union as well as members of this body to come up with a solution to that specific problem."

The motion was put by the Chair and carried, and Conf. Com. Rep. No. 125 was adopted and H.B. No. 321, H.D. 1, S.D. 1, C.D. 1, entitled: "A BILL FOR AN ACT MAKING APPROPRIATIONS FOR COLLECTIVE BARGAINING COST ITEMS," having been read throughout, passed Final Reading on the following showing of Ayes and Noes:
