

## ELEVENTH DAY

Wednesday, February 3, 1988

The Senate of the Fourteenth Legislature of the State of Hawaii, Regular Session of 1988, convened at 11:40 o'clock a.m. with the President in the Chair.

The Divine Blessing was invoked by the Reverend Cipriano Pasoquen, Filipino United Church of Christ, after which the Roll was called showing all Senators present with the exception of Senator Cobb who was excused.

The President announced that he had read and approved the Journal of the Tenth Day.

The following introductions were then made to the members of the Senate:

Senator Tungpalan introduced a group of senior citizens from Atlanta, Wahiawa, and Pearl City.

Senator Matsuura then introduced Mr. Ryotaro Sugi as follows:

"Mr. President, Ryotaro Sugi is a very well-known Asian television and screen performer in Japan. We honor Mr. Sugi today especially for his philanthropic contributions to the people of Hawaii. He has contributed \$10,000 to the 'Just Say No' program; \$5,000 each to the 'DARE' program administered by the Honolulu Police Department, the Association for the Retarded Citizens of Hawaii, the Hawaii Japanese Contract Immigrant Laborer Committee, the Star-Bulletin Good Neighbor Fund and the Advertiser Christmas Fund. He has also pledged funds to the 'Just Say No' program in Los Angeles.

"It is very impressive that Mr. Sugi has also established a 'Thank You, 20th Century, Sugi Ryotaro Fund' in Osaka City which pledges one million yen (\$8,000) annually to Hawaii charitable organizations, and the pledge is in perpetuity even after his death.

"It is a great privilege and honor to introduce Mr. Ryotaro Sugi to this honorable body. He is accompanied by his family: wife, Nobuko; son, Sumihiro; and daughters, Mayumi and Kikue."

The honoree rose to be recognized and was presented the Senate Certificate of recognition, a gift and lei from the Senate. His family also rose to be recognized and were presented with leis by various Senators.

Senator Matsuura also introduced Attorney Richard Fukuda who accompanied the family, together with Mr. Masanori Suzuki, manager, Mr. and Mrs. Tokunaga and a group of fans who were sitting in the gallery.

Senator Young then introduced visitors from Atlanta, Georgia, Judy and Marv Colbs; senior citizens from the Waipahu Community School: Caroline Nakamoto, Paulina Esber, Ethel Miyaguchi, Evelyn Kusaka, Misao Kurashige, accompanied by Joyce Coulbourne, their instructor.

Senator Ikeda introduced Caroline Leedom and Tina Christensen, eighth grade students from Niu Valley Intermediate School, participants of "A Day at the Legislature."

At 11:53 o'clock a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 12:00 o'clock noon.
