Senate Bill No. 151, H.D. 1 (Hse. Com. No. 4):

Senator Hee moved that the Senate disagree to the amendments proposed by the House to S.B. No. 151, seconded by Senator Menor.

Senator Hee then remarked:

"Madam Vice President, the Senate does not philosophically disagree with outlawing the sale of drug paraphernalia. We have been on record since 1987 as moving to outlaw this drug paraphernalia. However, there have been some concerns raised and we would like to look at these concerns. The concerns however are not with the philosophy of outlawing these types of accoutrements. Thank you."

Senator Blair then added:

"Madam Vice President, I commend the chairman for looking seriously at the bill and not just accepting the model language pressed for by certain groups and individuals. Thank you."

The motion was put by the Chair and carried, the Senate disagreed to the amendments proposed by the House to S.B. No. 151, entitled: "A BILL FOR AN ACT RELATING TO DRUG PARAPHERNALIA," and requested a conference on the subject matter thereof.

In accordance therewith, the Chair appointed Senators Hee, chairman, Holt and George as managers on the part of the Senate at such conference.
