Tuesday, February 23, 1988

The Senate of the Fourteenth Legislature of the State of Hawaii, Regular Session of 1988, convened at 11:44 o'clock a.m. with the President in the Chair.

The Divine Blessing was invoked by the Reverend Julia McKenna-Ritchie of The Divine Harmony Community Church, after which the Roll was called showing all Senators present with the exception of Senator Reed who was excused.

The President announced that he had read and approved the Journal of the Twenty-Third Day.

THIRD READING

Senate Bill No. 2570:

By unanimous consent, action on S.B. No. 2570, entitled: "A BILL FOR AN ACT RELATING TO CRUELTY TO ANIMALS," was deferred until Wednesday, March 2, 1988.

Senate Bill No. 2718:

By unanimous consent, action on S.B. No. 2718, entitled: "A BILL FOR AN ACT PROPOSING AN AMENDMENT TO ARTICLE II, SECTION 1, OF THE HAWAII CONSTITUTION, TO CHANGE THE AGE QUALIFICATION FOR VOTING," was deferred until Wednesday, March 2, 1988.

Senate Bill No. 2279, S.D. 1:

Senator Hee moved that S.B. No. 2279, S.D. 1, having been read throughout, pass Third Reading, seconded by Senator Menor.

Senator Hee then spoke in favor of the bill and said:

"Mr. President, this bill is very similar to the bill passed by the Senate in 1987, which makes the 'Johns' arrestable.

"Last year, I said it was the 'hookees' bill, as well as the 'hooker.' This bill once again before this body will now make the 'Johns' arrestable when engaging in prostitution. It is an effort again by the Senate to clean the streets of Waikiki in deference to the former chairman of the Waikiki Improvement Association.

"In addition, this bill also raises the age from 14 to 16, whereby in that effort asking the police enforcement agencies to go after the minors who many times are coerced into engaging in prostitution.

"I urge the members to favorably consider this bill. Thank you, Mr. President."

The motion was put by the Chair and carried, and S.B. No. 2279, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO PROSTITUTION," having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

Ayes, 23. Noes, none. Excused, 2 (George and Reed).

Senate Bill No. 2625, S.D. 1:

By unanimous consent, S.B. No. 2625, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO STATE-OWNED CEMETERIES," was referred to the Committee on Ways and Means.

The Chair then made the following remark:

"Members of the Senate, with reference to S.B. No. 2625, dealing with state-owned cemeteries, the Chair finds that this bill, as amended, provides for the transfer of administrative responsibilities and appropriates funds from one agency to another. The bill, as amended, also establishes a special trust fund. These are matters which fall within the purview of the Ways and Means Committee. Therefore, the Chair re-refers the bill to Ways and Means."

Friday's Order of the Day, the Chair finds that there are insufficient signatures on the committee report. Therefore, the Chair rules that the bill was not properly before the body. All floor actions on the bill are thus null and void and said bill and committee report are recommitted to the Consumer Protection and Commerce Committee."
