However, I did not expect anyone to accuse you of being arrogant. I truly realize you are a busy person and would like to apologize for that comment.

As you know the news media is famous for misquoting people. John Yoshimura of Channel 2 news stated, 'Harris says Hee is soft on porn.' I sat through your hearings on S.B. 2329 and listened intently to your comments. Because you are obviously concerned about pornography in our state, I would have no reason to make such a statement.

I represent a large group of people who want to work with our Senators and Representatives to make Hawaii a safe and beautiful place to call Home. Please carefully consider the harms that the widespread sale of pornography in Hawaii would have on each of its victims, young and old. If you could save but one of them I'm sure you would. So please pass S.B. 2329.

Again, I apologize for the misunderstanding. I look forward to working with you in the future.
