A new innovative approach to the securities requirement will free up capital for local investment and will result in a higher return on the state's deposits, a one percent increase in interest income returns over \$10 million annually to the state treasury without the impact of any tax increases.

"This bill would just move money out of the state when we should try to keep the money in the state. Thank you, Mr. President."

On motion by Senator B. Kobayashi, seconded by Senator Matsuura and carried, S.B. No. 3248, S.D. 2, entitled: "A BILL FOR AN ACT RELATING TO BOTTLED WATER," having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

Ayes, 25. Noes, none.

Senate Bill No. 2329, S.D. 1:

Senator Hee moved that S.B. No. 2329, S.D. 1, having been read throughout, pass Third Reading, seconded by Senator Menor.

Senator Menor rose to speak in favor of the bill, as follows:

"I rise to speak in favor of this bill with reservations. I had hoped that I would be able to offer strong support for this bill in light of what it was intended to accomplish.

The bill was introduced in response to the State Supreme Court ruling in State v. Kam. In the Kam case, the Supreme Court held that the right to privacy accorded by Article 1, Section 6, of the Hawaii State Constitution restricts, in the absence of compelling State interests, the ability of the government to prohibit the sale of sexually explicit adult material for viewing by purchasers in the privacy of their homes. Based on the Kam case, S.B. 2329 as originally drafted identified compelling state interests which justify governmental prohibitions on pornography.

"Unfortunately, the legislative intent of S.B. 2329, S.D. 1, as worded is ambiguous; it is unclear how far prohibitions on pornography should extend. The bill's prohibitions on pornography should extend. committee report identifies compelling state interests for prohibitions on pornographic material which involve actual' depictions of sexual violence including murder, rape, and disfigurement, but not for simulated depictions of such conduct which are also patently repulsive and offensive to human sensibilities. the committee report also fails to mention pornographic materials which depict the degradation and humiliation of others, especially women, and which society clearly does not condone. It should be obvious, for example, that films which graphically depict men defecating on women do not further any redeeming social value or purpose. While the Legislature would have no problem finding compelling state interests to justify prohibitions on these kinds of materials, the committee report as written would appear to preclude restrictions on materials which could properly be categorized as 'hard core' pornography.

"On the other hand, the bill itself indicates that prohibitions could extend to a variety of pornographic materials or performances, both actual and simulated, which fall within the definitions of amended subsections (6)(a) or (6)(b) of H.R.S. Section 712-1210. However, to the extent that the committee report does not appear to reflect the provisions of the bill, I believe that it is necessary to clarify for the Senate Journal the legislative intent behind S.B. 2329, S.D. 1. As vice-chairman of the Senate Judiciary Committee which is recommending passage of this bill, I believe I am in a good position to offer this clarification. I also assisted in the drafting of amendments to this bill.

"First of all, it is the Legislature's intent in enacting S.B. 2329, S.D. 1, that governmental prohibitions should extend to all forms of graphic, hard core pornography --whether actual or simulated -- involving the sexual exploitation of minors, sexually violent and explicit conduct, and the humiliation and degradation of individuals, especially women.

"Secondly, the Legislature finds that there are compelling state interests which justify the continued regulation of pornography. These compelling state interests include the following:

- "1. The problems of sexual violence, sexual aggression short of actual violence, and sex discrimination are serious societal problems that have traditionally attracted a disproportionately small allocation of societal resources.
- "2. Images are significant determinants of attitudes, and attitudes are significant determinants of human behavior. To the extent constitutionally permissible, we must acknowledge that dealing with the images around us is an important way of dealing with undesirable behavior as well.
- "3. An enormous amount of the pornographic material available depicts the degradation, domination,

subordination, and humiliation of others, usually women. This degradation, even when nonviolent, depicts people, usually women, existing solely for the sexual satisfaction of others, usually men, or depicts people, usually women, in decidedly subordinate roles in their sexual relations with others or engaged in sexual practices that can only be considered humiliating.

- "4. Increasingly, however, the most prevalent form of pornography depicts sexually explicit violence, both simulated and actual. Some of this material involves sado-masochistic themes with bondage, whips, and other devices of torture. Some of this material involves actual or simulated rape and sodomy with women as the usual victims. Pornographic material which features extreme violence, such as simulated or real disfigurement and murder, is also available.
- "5. That pornography is harmful is apparent from the nearly unanimous agreement that exposing children to pornographic materials and to the messages conveyed by those materials is undesirable. However, even though the sale of pornographic materials has been totally banned, much pornographic material finds its way into the hands of children. If a total ban on the sale of pornography has not been sufficient to keep pornography out of the hands of children, a partial ban affecting only distribution of pornography to children clearly cannot be expected to be effective.
- "6. The extent to which the harmful effects of pornography on children justifies the outlawing of all pornography may be debated by those desiring the availability of pornographic materials. Notwithstanding such arguments, the Legislature specifically finds that the harmful effect on children constitutes a compelling governmental interest justifying a ban on the sale of pornography to adults as well as to children.
- "7. While individual choice is necessary in a free society, a society with no shared values, including moral values, is no society at all. Materials with no redeeming social value which depict the degradation, subordination, domination, humiliation, abuse, bondage, torture, rape, sodomy, and disfigurement of others in a sexually explicit manner can only lower our society's moral values. The Legislature finds that the preservation and strengthening of these moral values is a compelling governmental interest justifying the ban on the dissemination of pornography for monetary consideration.
- While the sanctity of the home, the right to privacy therein, and the parent-child relationship governmental interests overrides the compelling justifying a total ban on the possession of pornography, even including materials depicting bestiality, child pornography, and actual murders, the dissemination for monetary consideration of materials with no redeeming value which depict the degradation, domination, humiliation, subordination, bondage, torture, rape, sodomy, and disfigurement of others is not entitled to the consideration given to the right of privacy within the home and given to the importance of the parent-child relationship. The Legislature adopts the ruling of the Supreme Court of the United States that 'the protected right to possess obscene material in the privacy of one's homes does not give rise to a correlative right to have someone sell or give it to others' (United States v. 12 200-Ft. Reels of Super 8mm Film, 413 U.S. 123, 128 (1973)], with the full understanding that that ruling was based upon the First Amendment to the Constitution of the United States and not upon the Hawaii Constitution.

- "9. The Legislature finds, based upon documentation in the report of the Attorney General's Commission on Pornography, that organized crime directly operates and closely controls significant portions of the pornographic magazine industry, the peep show industry, and the pornographic film industry.
- "10. The Legislature finds that pornography is a product of criminal activities such as prostitution (when the participants are paid to engage in sexual activity) and coercion (when the participants are forced to engage in such activity).
- "11. The Legislature finds, based upon documentation in the Attorney General's Commission on Pornography, that substantial exposure to sexually violent materials bears a casual relationship to antisocial acts of sexual violence and, possibly, to unlawful acts of sexual violence.
- "I hope that my remarks have served to clarify the purposes of S.B. 2329, S.D. 1, and will lead to effective and vigorous enforcement of our pornography laws by police officers and county prosecutors. While I would have preferred S.B. 2329, S.D. 1, to contain the original bill's provisions establishing increased monetary penalties for distributors of pornography, I believe that S.B. 2329, S.D. 1, if properly interpreted, is a step in the right direction. I am hopeful that the House will strengthen and refine this bill further as it considers and reviews this legislation.

"Thank you for considering this matter."

The motion was put by the Chair and carried, and S.B. No. 2329, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO PORNOGRAPHY," having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

Ayes, 25. Noes, none.

Stand. Com. Rep. No. 2253 (S.B. No. 3042, S.D. 1):

On motion by Senator Yamasaki, seconded by Senator Mizuguchi and carried, Stand. Com. Rep. No. 2253 was adopted and S.B. No. 3042, S.D. 1, entitled: "A BILL FOR AN ACT MAKING AN APPROPRIATION FOR A DEMONSTRATION SHRIMP PROJECT WITH THE SUGAR INDUSTRY," having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

Ayes, 25. Noes, none.

Senate Bill No. 2783, S.D. 1:

Senator Cobb moved that S.B. No. 2783, S.D. 1, having been read throughout, pass Third Reading, seconded by Senator Blair.

Senator Ikeda rose to speak against the measure as follows:

"Mr. President, this is a rather confusing measure. When we passed legislation to allow captives to be formed, we did so to relieve the liability insurance crunch. This bill will allow captives to now write life insurance since that's what credit life and disability coverage is.

"Generally, captives are restricted to providing insurance coverage to its parent company. But in this

case, by allowing them to get into the life business, they would actually become a life insurance company because the credit life and disability coverage would be sold to consumers.

"I don't see the need for this. I think it's going far astray of the intent of allowing captives to be formed. And in addition, I'm not sure that captive insurance companies have the adequate reserves necessary to cover this type of liability, especially because they were formed with the intent of covering property and casualty insurance, and not life.

"For these reasons, Mr. President, I will vote against this bill."

Senator Cobb then rose and said:

"Mr. President, the Department of Commerce and Consumer Affairs finds ... and I'm quoting from their testimony ... 'that the bill will help stimulate the newly authorized captive insurance industry in Hawaii without having a negative impact on the domestic insurance industry. Since the captive insurance company would be restricted to providing credit insurance to its parent, they would not be in competition with conventional insurance offering credit life and disability insurance.'

"I think since the department has no problems with the administration of this proposed idea, the Senate should not, either. Thank you."

Senator Ikeda then responded to the previous speaker's comments and said:

"Mr. President, a brief rebuttal. I'm not sure that the department understands what it is that they are supporting, and that's why I have a problem with it. It is totally different from liability coverage and it will not be a coverage that a parent may be providing to a subsidiary. It will be a coverage that will be offered to the consumer. Thank you."

The motion was put by the Chair and carried, and S.B. No. 2783, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO CAPTIVE INSURANCE," having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

Ayes, 21. Noes, 4 (George, Herkes, Ikeda, Kobayashi, A.).

At 3:35 o'clock p.m., the Senate stood in recess subject to the call of the Chair.
