At this time, Senator B. Kobayashi introduced to the members of the Senate Mr. Richard Hoyt and his daughter Laura who were present on the floor of the Senate. Senator Kobayashi said, "Richard Hoyt is a very successful author, former newspaper reporter for the Star-Bulletin and the Advertiser, former graduate student at the University of Hawaii earning his Ph.D. in American Studies. He has come back to Hawaii for a short visit.... He's had the distinction of being on the coveted front page of the 'New York Times' book review section and featured in 'People' magazine this summer...."

Mr. Hoyt and his daughter rose to be recognized and were presented with leis.

At 11:48 o'clock a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 11:52 o'clock a.m.

Senator Cobb then rose on a point of personal privilege and said:

"Madam Vice President, on February 23, 1988, Mr. Roland G. Van Allen, president of the Hawaii Council of Associations of Apartment Owners (HCAAO) sent a letter and poll to condominiums and other interested parties.

"Unfortunately the HCAAO poll on legislative desires was misleading. One, the poll described the original version of several bills that were subsequently amended in committee. The amendments were made with members of HCAAO present at the public decision-making sessions prior to the mailing of the letter and poll, even though in that letter and poll only the original versions of the bills were sent out, which I think is highly misleading, particularly when those members sat and watched the decisions being made.

"Second, the letter and poll fail to mention that several of the bills were introduced by request of other parties

indicating legislative neutrality and to be put on the table for discussion and consideration only.

"Third, based on these errors, the results of the poll can hardly be considered valid. The Legislature will be considering the amended version of each bill, not obsolete originals as presented by Mr. Van Allen. A more useful poll would ask opinions about the amended version of each bill.

"In a response bulletin he called the other condominium groups and said, 'Four Senate bills introduced by Senate Cobb was summarized by HCAAO in the same misleading fashion of making amendments made in hearings that made them more acceptable to both supporting and opposing sides.'

"Rather than read the entire letter which I'm sending to all members of the Legislature on this subject, as well as to other interested parties, Madam Vice President, I'd just like to point out something else because this letter is being signed by both Representative Joan Hayes and myself, and we state in concluding that both of us strongly support condominium leasehold legislation. What we find it ironic and hypocritical is some people in condominiums oppose 'government interference' by legislation, and yet demand mandatory leasehold conversion, rent controls that have been called Bolshevik by their opponents and outlawing the law's surrender clause. That is government interference to the 'max.'

"In short, government has been deeply involved in condominiums for years, to regulate and protect both property rights and to prevent abuses to the minority.

"Madam Vice President, copies of this will be sent to every legislator for your perusal, but I want to alert members of the Senate, personally, to this kind of deceptive lobbying. Thank you."

Senator Holt also rose to speak on a point of personal privilege as follows:

"Madam Vice President, last Friday your Tourism Committee, in depth, went over the administration's convention center studies. It was a lengthy hearing; a lot of questions were asked.

"One of the major questions was the uniformity of the data entered into the model that was used by the administration. And as a result of the question, we requested a re-run of the fiscal impacts model based on the best case scenario for the three sites, two Waikiki sites and Ala Wai, not just the two Waikiki sites which was in the Governor's studies.

"We have received the response. We got it this morning. It is incomplete because we do not have the run on the other two sites. However, the information we received indicates that the internal rate of return numbers appear changed significantly. We will be analyzing the new data and waiting for the rest of the information to be forwarded to me which will be distributed to the members of the committee as soon as I get that information. Thank you."

Senator B. Kobayashi also on a point of personal privilege and remarked:

"Madam Vice President, to follow-up the previous speaker's remarks, we found out that the studies which cost the state approximately \$600,000 included a great number of errors. Included in the errors was the fact that the site studies were not fully supported by the financial analysis done by Panell Kerr Forster. Because of the rush

and, shall we say, the inconsistencies, we found one set of numbers in the Pannel Kerr Forster study and another set of numbers in the site studies. There were at least two errors each of \$20 million for the International Marketplace study as well as the Magoon Estate site, and this is of course on the cost side.

"On the revenue side, there were other errors. For instance, no revenues were allocated for the local shows at the Ala Wai Golf Course site, inspite of the fact that the site study included 2,000 parking stalls there at the Ala Wai site which were not included in the two Waikiki sites. The cost of the 2,000 parking stalls, incidentally, is approximately \$40 million.

"Further, in the International Marketplace site, specifically, there was a 100,000 square feet of shopping arcade space. Revenues or potential revenues from those spaces were not included in either the site assessment studies or the Panell Kerr Forster studies.

"So, both on the revenue side as well as the cost side, there were major errors. And as I said, these major errors amounted to at least two errors each of \$20 million. Thank you."

Senator Cobb then said:

"Madam Vice President, I rise on a point of personal privilege to simply make a request.

"I appreciate all the good work that's being done on analysis of various convention center sites but I find missing in that analysis so far any detailed consideration of the proposed, and I emphasize the word 'proposed,' Aloha Motors site.

"I think since both the Mayor and Councilman Leigh-Wai Doo are in support of this idea that it ought to be taken seriously and considered seriously.

"In addition, in terms of the community impact analysis for the International Marketplace, I do feel the question needs to be addressed as to what will happen to all of the businesses that are presently located there, if a convention center is to be located at that site.

"With those two caveats, I would merely request the committee, and it's only a request, to please consider not only the Aloha Motors site but the community impacts for both the Magoon and International Marketplace sites. Thank you."

Senator Holt responded:

"Madam Vice President, since my fellow Senator here has suggested that the Committee look at another site beside the two that the House has sent over and the one that we already selected last year, I'd like to invite the rest of the Senators to please let the Committee know if you have other sites you want us to consider this year. Thank you."

ADJOURNMENT

At 12:05 o'clock p.m., on motion by Senator Blair, seconded by Senator A. Kobayashi and carried, the Senate adjourned until 11:30 o'clock a.m., Thursday, March 10, 1988.
