#### Wednesday, March 16, 1988

The Senate of the Fourteenth Legislature of the State of Hawaii, Regular Session of 1988, convened at 11:42 o'clock a.m. with the President in the Chair.

The Divine Blessing was invoked by the Reverend David Holsinger of St. Luke's Episcopal Church, after which the Roll was called showing all Senators present with the exception of Senator Nakasato who was excused.
