#### RE-REFERRAL OF HOUSE BILLS

Senator J. Wong then introduced second grade students from Ka'a'awa Elementary School observing the legislative process who were accompanied by their teachers, Ms. Betty Stephenson, Ms. Adella Johnson, Ms. Lori Muraoka, Ms. Barbara Alathea, Mr. Michael Gallant, Ms. Sandy Alley and Ms. Marilyn Nakasone, and parents, Ms. Penny Martin and Ms. Annette Ostrem.

Senator Hee then rose on a point of personal privilege and said:

"Madam Vice President, yesterday, there were two articles written by The Honolulu Advertiser and Honolulu Star-Bulletin and I want to emphatically underline that I don't make it a habit of arguing with people who buy ink by the barrel, so this should not be construed as an argument with those who wrote the articles. It is, however, an effort on my part to set the record straight relative to what is the flagship bill in the anti-crime legislative package proposed by Hawaii law enforcement agencies.

"The Advertiser had correctly indicated that there were some problems, however, the Judiciary Committee was likely to approve a version of the criminal forfeiture bill sought by the state law enforcement package. And, in fact, the bill which you have re-referred to the Judiciary Committee only is House Bill 2080, H.D. 1, which the chairman of Ways and Means Committee has graciously allowed the Judiciary Committee more time to work on.

"I'd like to set forth for the record and members of the Senate that the so-called flagship bill has some serious flaws and defects in it, particularly to the innocent parties who may be accused of certain offenses. For example, we should understand that if any of us were to leave to take a trip and have our house occupied by someone to take care of that house and the person who occupied that house was arrested for dealing in drugs, that house you left in the charge of someone else will be forfeited under this bill.

"A wife may have knowledge that her husband, perhaps, may be dealing in drugs but is too afraid to deal with her husband's anger. Well, if the husband was arrested, her house in which she owns a half interest would be forfeited.

"There is a case in which an ILWU retiree, who is on a pension and fixed income, has a grandson who was growing marijuana on this pensioneer's property. That property was seized. Now, this old individual could not possibly, for fear of his life, apparently, correct his grandson.

"I could lend you my car and if you dealt with drugs, that car would be seized, and I had no knowledge upon lending you my car that you were going down to the corner to deal in dope. The bill is very broad in the language of 'facilitated and assisted.' For example, if the car were driven it is facilitating and assisting your crime.

"As important in the bill, the burden of proof is shifted to the accused. The burden of proof should remain with the government. After all, it's the government that's bringing the charges. Therefore, the committee needs to address this issue.

"The disposition of property, while a criminal trial is ongoing, is also a problem because the property can be forfeited while it is being in a court of law.

"This bill is seriously defective and I think that the prosecutor, in his statement to the afternoon paper, really struck the heart of the motivation behind the law enforcement agencies. And that is, and I quote the deputy prosecutor, Thomas Pico: 'The point ought to be clear. If the state is not allowed to forfeit real property, the federal government will. The purpose of this bill is so the state can benefit monetarily from these forfeitures.' There's no word of justice in here. It's 'so the state can benefit monetarily.'

"When this bill comes out of the Senate Judiciary Committee, and it will, any talk of a derailment, the implication to killing the bill, is not true. This bill will

come out. But this bill will come out so the burden of proof will remain with the government, so that people are presumed innocent in this state until proven otherwise by those who accuse the innocent, and that this bill will protect those properties which by virtue of circumstance, such as the Hawaiian Home Lands, where pockets of remote areas are probably being cultivated in marijuana, that those homesteaders will not have their properties forfeited, will not have to go to court and bear the burden of proof, will not have to undergo the expense of litigation without some kind of access to compensation from the government. That when these matters are corrected in the bill, and when the Judiciary Committee, with concurrence of the chairman of Ways and Means Committee, derides on a fair way of disposing the money and not create an incentive by the law enforcement agencies to accrue cash -- when these things are done, then the bill will come out in a fair and just manner. Thank you."

At 12:01 o'clock p.m., on motion by Senator Blair, seconded by Senator A. Kobayashi and carried, the Senate stood in recess until 6:00 o'clock p.m., this evening.
