Senator Hee rose to speak on a point of personal privilege as follows:

"Madam Vice President, it appears through the media that the dilemma of Mr. Francis Morgan and the questions raised regarding his dilemma seem to be matriculating towards the chairman of the Judiciary Committee. I'd like at this time to set my concerns on the floor for the record so there is no misunderstanding into what potentially could be a great misunderstanding with respect to my concerns on the bill.

"Let me state that the concerns that I have raised informally and formally have been centered around the ability of this individual to repay the taxpayers of this state. The taxpayers are being asked to cough up \$10 million. And as someone who is not a member of either committee, that is not privileged to the chairman's wisdom and would not so much as to accuse either chairman of overreacting or being over-broadly concerned or not concerned with the taxpayers' money.

"The concerns I've raised as a nonmember, and as a member who is elected by taxpayers whose concerns are of taxpayers, are that, does this man through his company or his holdings, either through a sole proprietorship of Hamakua or an undivided interest in Kualoa Ranch and Kualoa lessees, does this man have the ability and is this man willing to state in writing, not through hearsay through some committee proceeding, or as far as I know it is not recorded nor on the record, is this individual willing and able and will he commit to the taxpayers that they would be the first lien should the \$10 million which he is seeking should not hold up his company? And would this man be willing to give the Senate his books just as a bank would require this individual, prior to the Senate making any decision relative to the financial health and well-being of this individual vis-a-vis the ability to repay the taxpayers of this state?

"I want to make that perfectly clear. As far as I'm concerned the taxpayers deserve nothing less than a bank would require relative to the kinds of information this man would be required to give a bank. Particularly, when the amount is \$10 million and I make that very clear that that's my concern.

"Thank you."

The young ladies and Mr. Woo who were also seated on the floor of the Senate rose to be recognized and were presented the Senate certificate of recognition and leis.

Senator Chang also introduced Mr. Welton Won on his retirement from the Chinese Chamber of Commerce after more than 30 years of dedicated service and "his tireless and devoted efforts to promote the traditions of his cultural heritage."

Mr. Won, also present on the Senate floor, rose to be recognized and was presented a Senate certificate of recognition and lei.
