The Senate of the Fourteenth Legislature of the State of Hawaii, Regular Session of 1988, convened at 11:40 o'clock a.m. with the Vice President in the Chair.

The Divine Blessing was invoked by the Reverend George Lee, St. Philip's Episcopal Church, after which the Roll was called showing all Senators present.

The Chair announced that she had read and approved the Journal of the Forty-Second Day.

The following introductions were then made to the members of the Senate:

Senator Fernandes Salling introduced Kauai County Councilwoman Maxine Correa and her husband Jerry.

Senator Chang introduced the 36th Annual Cherry Blossom Queen and her court: Queen Lisa-Ann Mayumi Nakano; Princess Lori Leiko Shimizu; Attendants, Suzette Naomi Ono, Shari Mie Okamura and Sharlyn Michiko Masaki.

Queen Lisa-Ann and her court rose to be recognized and were presented the congratulatory Senate certificate and leis.

Senator Chang then introduced the 47th Miss Nisei Week (Los Angeles) Festival Queen and her court: Queen Lee Anne Sera; Princess Kimmi Kanenaka; and Miss Tomodachi, Lorene Enomoto. ORDER OF THE DAY

RE-REFERRAL OF A HOUSE BILL

The Chair re-referred H.B. No. 3190, H.D. 1, S.D. 1, to the Committee on Ways and Means.

Senator Solomon rose to speak on a point of personal privilege as follows:

"Madam Vice President, I rise on a point of personal privilege to express for your Senate conferees, Senator Holt, Senator Hee and myself, our concerns on the rightto-sue legislation, a conference item before this legislative session.

"As you know, Madam Vice President, the basis of the right to sue on the part of Hawaiian beneficiaries are two land trusts -- the Hawaiian Homes Trust, with approximately 192,000 acres, established by Congress in 1920, and the Ceded Land Trust with nearly 1.2 million acres, established in the Admission Act of 1959.

"As you know, Madam Vice President, native Hawaiians and native Hawaiian organizations are unable to litigate issues relating to their land trust assets in our state courts. The U.S. Civil Rights Commission reported in the late 1970's that the State of Hawaii was in breach of trust regarding Hawaiian trust lands.

"Your Senate conferees support our native Hawaiian organizations, Madam Vice President, and every citizen throughout this state and our great nation, their right to sue as part of the civil and human rights as guaranteed by the United States and state constitution.

"There exists a need for recognition by the honorable bodies of this Legislature to correct past and present injustices and to protect Hawaiian civil rights. In recognition of the limitations of the present process and difficulties of resolving present impasses, the right to sue is one part of a broader, human political struggle.

"With these inadequate processes in mind, Madam Vice President, your conferees are considering the creation of a resolution with three goals in mind: 1) to ratify present injustices; 2) to provide a process for the realization of self-actualization of native Hawaiians; and 3) to broaden the political struggle to secure human civil liberties.

"The creation of this resolution, Madam Vice President, will further clarify the process by assigning responsibilities and resources to one unit answerable to the Hawaiian people.

"The present political situation fragments our powers. Our fate lies with the Judiciary, the Executive, the Legislature and OHA which perpetuate the preservation of traditional practices. But Madam Vice President, we must be bold and innovative. We must come up with a resolution that will merge these powers so that we can gather data and make recommendations, subject to the Legislature's final approval, regarding reparations due to native Hawaiians for these historical injustices.

"For the record, Madam Vice President, I would like to read for the Journal from a 'Statement to the Senate from Civil Rights Groups for Hawaiians and the Right to Sue Bill.'

'The many individuals and Hawaiian associations who have worked for civil rights for Hawaiians and who have lobbied the right-to-sue legislation for the past five years believe that the time has come for Hawaii's native people to be afforded the opportunity to seek judicial guidance in resolving the historical problems relating to the Hawaiian Homes and Ceded Land Trusts, which were set aside for their benefit by federal and state laws. Native Hawaiians are the only remaining Americans who, because of their race, are denied access to the courts to protect their property entitlements. We consider this injustice to be a denial of our constitutional right for a trial in an impartial form.

'The Report of the Civil Rights Commission issued in 1980 and the Federal-State Task Force Report of 1983 documented the extensive problems relating to native trusts and recommended that the state Legislature enact legislation to provide native Hawaiians and their associations the right to go to court. The Legislature has failed to act for five years. During this period, we have seen increasing acts of civil disobedience, physical injuries to our people, the disruption of public and private business and, more importantly, a rise in the frustration level of the native people who comprise 20 percent of this state's population. In America, the proper place for the resolution of the legal controversies is in the courts. If no access is provided, the only alternative is civil disobedience and violence. We do not want any more arrests or injuries. We do not want any more "Makapu'u incidents."'

"We want, Madam Vice President, as stated in this document, the right 'to avail ourselves of the court system.' A small price, Madam Vice President, and a small tribute to the thousands and thousands of men and women who have died in World War I, World War II, the Korean Conflict, and Vietnam, protecting the human rights and dignity of people. This is what, Madam Vice President, your conferees are interested in achieving.

"At this time, Madam Vice President, I would like to defer to the Judiciary chairman. Thank you."

Senator Hee then rose to speak on a point of personal privilege and said:

"Madam Vice President, rising on a point of personal privilege.

"In some ways the Senate has been patiently waiting for our colleagues on the other side of the aisle to make some decisions relative to reconciling this very serious issue, much like the Hawaiians have been waiting for their day in court.

"Madam Vice President and members, approximately two weeks ago the manager on the part of the House. Representative Andy Levin, the Judiciary chairman in the House, and two other members of the House met with Senators Solomon, Holt, and myself in an effort to informally discuss some of the positions which have remained hard and fast and have prevented a reconciliation of this matter. Through that meeting the Senate conferees who were present there had indicated a willingness to compromise to some of the House positions, some of which I believe, personally, will extract a large pound of flesh out of this issue of justice of the Hawaiian people.

"For example, the Senate position has always been one which contains retroactivity back to 1959. That is so that the Legislature would recognize and acknowledge that there may indeed have been negligent or gross negligent or intentional acts which have hurt the Hawaiian people, and that through this recognition that perhaps these people who have been aggrieved for 200 years would have the opportunity to seek judicial remedy, at least to the time of statehood. That was the Senate position.

"Through informal discussions and in our efforts to reconcile this long-standing issue, we talked about the possibility of a prospective position; that is to say, from this day forward all negligence would be accountable through a judicial procedure, a radically different departure from the Senate position; however, with a caveat which would say, we would take into account the auditor's research to determine if indeed back from the period of '59 negligence could have occurred and at what cost.

"It was a Senate good faith effort by those present to say, 'let's talk about it,' and to say to the House that we are willing to look at your position which is radically different from the Senate's.

"The House has reneged on that informal agreement. The House now is looking for a way out, just as they did last year. The House would now like to put this pound of flesh on the desk of the governor. And it is because of the Senate's position that we are now looking for a fallback to the degree that the governor shall not be the only executive to reconcile a legislative problem.

"The Supreme Court indicated in the suit that this is a legislative concern. And the Senate position is this will be a legislative concern and not an executive concern.

"And so, Senator Solomon is quite right, from my opinion, that for the reconciliation of this long-standing issue of injustice to native Hawaiian people that this problem cannot be skirted from the House to the governor. That this problem will include the House, like it or not, as long as they serve in the Legislature and as long as they are elected, some of whom by Hawaiian people, let the Hawaiian people hold those people accountable in 1988.

"Thank you."

At 12:09 o'clock p.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 12:19 o'clock p.m.

Senator Holt also rose to speak on a point of personal privilege and stated:

"Madam Vice President, I rise on a point of personal privilege.

"Early this session, Madam Vice President, we had a caucus on a very controversial bill. I believe it was in Senator Hee's committee, the drug paraphernalia bill. During the caucus which was very emotional ... what we were very concerned about and our leadership basically told us that what we did in that caucus was going to set the tone for this session. Basically, what we decided to do was to call the other house to move the bill back that

we passed last year and not move the bill out of the Senate, in good faith.

"As we move ahead into the last three or four weeks of this session there will be a lot of very controversial legislation that have to be acted on and I think it's appropriate that we continue to deal in good faith in order to serve the public's interest.

"I was at that meeting with Senator Solomon and Senator Hee. In fact, I was sick; as you know I had the In fact it came on the day that we had our flu. convention center decision-making and everything else. Now, that's not why I got sick, but anyway, I wasn't feeling well but I did attend the meeting with the other conferees on the part of the House who were managing the right-to-sue legislation and I endured. I thought that we came out with a very good understanding on what was to come about, and in fact we even had a deadline in terms of when the House was supposed to come up with the draft. We had a deadline. We asked for one week, but they said they needed more time; we gave them two weeks. Today, as I understand from the chairman, was the deadline for the House to propose a draft for our consideration.

"I think we were dealing in good faith, Madam Vice President. As I understand it, the House does not have a draft for the Senate to consider. And as indicated earlier from the previous speakers, we were ready to compromise to try to come to some agreement, to get something acted this year, to address the situation that people up in the gallery are very concerned about.

"I think if that's the way the House is going to operate, we're going to have a very interesting next few weeks because there are other legislations that are going to come before us. If we cannot negotiate in good faith with the House, it's going to be very difficult for this body to sit down across the table and come to some kind of agreement and then, like what I went through last year, a few hours later they'll come back and change their mind. I don't want to go through that again.

"I think that the hard work and the efforts put forth by the conferees who are trying to address the problem and the House not wanting to get involved with not only this controversial issue, but any controversial issue ... it's easy to make no decision, Madam Vice President, but that's not what we're elected for. We're elected to make decisions and if we don't make decisions then who's going to make them. The people can't do it by themselves.

"Basically, I just wanted to follow-up on the comments made earlier because I don't think it's fair to the people who have been working hard out in the community, pushing for this legislation, to get nothing and for the House to just take the easy way out just to get out of the session.

"I think that credit should be given to the chairman of Judiciary for the hard work that he's done trying to compromise. It's not that easy to compromise on this particular issue but we did come up with a position and we were ready to work, but apparently the House is not willing to do so.

"I have another point, Madam Vice President. I just would like to request some information, Madam Vice President. Maybe, perhaps if you can forward this formal request to the person involved.

"I understand from earlier comments made from the chairman of Ways and Means that the Hamakua Sugar bill is on the tracks. I received some phone calls. My family ... I was just reading an article on James Robertson and I didn't know that my great, great, great, great grandfather back in 1822 came over here and he was a shipbuilder; he was a PR man for a firm back there. That's got nothing to do with me. You know, we have family all over the place and I received some calls regarding some promises that were made when Francis Morgan took over the plantation from Theo. Davies, and that in the negotiations with the ILWU who decided not to ask for any pay raises or anything else, there was some discussion about taking care of the workers' housing needs because they lived in these camps; there was talk about consolidation. I was wondering if we could followup and ask if those promises have been kept.

"Also, my understanding is that he's got twenty-five to thirty thousand acres over there in Hamakua, and it doesn't seem inappropriate for him to set aside fifty or a hundred acres or whatever to take care of the workers who have loyally served him all these years. But I would like to find out whether that promise has been kept.

"In addition, as I understand it, there were other promises to provide land for Honokaa Hospital, and I was wondering whether that promise has been kept.

"I just would like to personally request that if you could get the information back to this body before we have decision-making on the sugar bill, I'd greatly appreciate it. Thank you."
