

## FORTY-SEVENTH DAY

Wednesday, April 6, 1988

The Senate of the Fourteenth Legislature of the State of Hawaii, Regular Session of 1988, convened at 11:43 o'clock a.m. with the President in the Chair.

The Divine Blessing was invoked by Rabbi Arnold Magid of Temple Emanu-El, after which the Roll was called showing all Senators present with the exception of Senator Aki who was excused.

The President announced that he had read and approved the Journal of the Forty-Sixth Day.

The following introductions were then made to the members of the Senate:

Senator Matsuura, on behalf of Senator Hagino and himself, introduced Mr. Takaji Ishida from Waiialua, Oahu, present on the Senate floor, who was being honored for "his countless hours of volunteer work in teaching the art of Aikido to young people. He holds a black belt -- highest ranking -- in Aikido in the State of Hawaii, holds the rank of 4th grade in Judo, and was the first person to start teaching Aikido in Hawaii." Accompanying Mr. Ishida and seated in the gallery were Senator Matsuura's brother-in-law and sister, Kaneo and Betty Kumasaka, Mr. and Mrs. Okimura, and Mr. Paul Lindberg, a student of Aikido.

Mr. Ishida rose to be recognized and was presented the Senate certificate of recognition and a lei by Senator Yamasaki.

Senator Blair, on behalf of Senator Menor and himself, introduced 75 sixth grade students from Iolani School who were accompanied by their teachers, Mr. Okumura, Mr. Basche and Mr. Josephson.

Senator Hagino introduced Shawna Lepage, an 8th grade student from Wheeler Intermediate School, observing the legislative process.

Senator Mizuguchi, on behalf of the Senate, introduced Mr. John Radcliffe, former executive director of the Hawaii State Teachers Association (HSTA), who was present on the Senate floor. He was being honored for 12 years of dedicated service to the public school students, teachers and State of Hawaii. Accompanying Mr. Radcliffe was his wife, Diane, a teacher at Radford High School; Mr. J. N. Musto, head of the University of Hawaii Professional Assembly; Mr. Earl Arruda, HSTA president; and Mrs. Odetta Fujimori, HSTA Political Action Committee chairman.

Mr. Radcliffe and his group rose to be recognized. Senator Mizuguchi presented him with the Senate certificate of recognition and leis were presented to each of them.

Senator Holt, on behalf of the Senate, introduced Mr. Tovia Fatu, captain of the Mayor Wright Homes Crime Watch Program, who was present on the Senate floor. Mr. Fatu was honored for being instrumental in organizing the Mayor Wright community against neighborhood crime and establishing an effective crime watch patrol. Accompanying him was his wife, Mrs. Fatu, and seated in the gallery were Mrs. Anna Kekuma, president of the Mayor Wright Tenants Association, and Miss Verna Keyes, director of Palama Settlement.

The honoree, together with his wife, rose to be recognized and was presented the Senate certificate of recognition and leis.

At 11:55 o'clock a.m., the Senate stood in recess subject to the call of the Chair.
