Monday, April 11, 1988

The Senate of the Fourteenth Legislature of the State of Hawaii, Regular Session of 1988, convened at 11:42 o'clock a.m. with the President in the Chair.

The Divine Blessing was invoked by Chaplain Terry D. Burlingame, Schofield Barracks, after which the Roll was called showing all Senators present.

Senator Solomon rose to speak on a point of personal privilege as follows:

"Mr. President, I rise on a point of personal privilege. I have submitted, Mr. President, for my fellow colleagues' consideration, an article that was printed in Hawaii Business Magazine, April 1988. It's on development on the Big Island. The title of the article is 'Too much, too soon. The Big Island is erupting with development. The bad news is it's not prepared to handle it.'

"I just would like to quote for the Journal, Mr. President. This isn't a new issue; I have risen on many occasions to speak on this, being that most of the impact will be in my Third Senatorial District.

"If you look at the front page, Mr. President, you will see, quote: 'West Hawaii residents have already witnessed housing rental hikes of as much as 100 percent

over the past 12 months, The addition of the Hyatt's 2,000 jobs alone will mean a 20- to 30-percent jump in employment count for the area, and represents more than a 10-percent growth in population. But is West Hawaii prepared to handle such a rapid boost? "Waikiki or Hilo could easily absorb that many people, because they have an established economy and all of the other support systems needed to fill out a community," ... "But not in West Hawaii. We're talking about a county area that has no schools, no hospitals and one road. Up until now, the big deals here have been Waimea's first stoplight, a new bowling alley in Kona, and the Pizza Hut coming to town."

"This is a quote by County Deputy Mooers, who is the mayor's representative in West Hawaii: 'Whose fault is it?' According to Mooers, it is not neglect or indifference by county officials that has led to the Island's current plight. ... 'But when it comes to fingerpointing, some county planners believe ex-Governor George Ariyoshi's administration failed to recognize the needs of the Big Island. Stephen Yamashiro, chairman of the Hawaii County Council, says the county's revenue-generating means, like those derived from real property taxes, are extremely limited'

"Mr. President, I have to disagree with this. I served under George Ariyoshi's administration and I think that the ex-governor was very much aware of the situation in West Hawaii. We did our proportionate share, as far as the Legislature is concerned, and delivered those kinds of services as needed by the district. I have to chuckle about this, Mr. President, because I remember when I was a freshman in this Legislature, I co-sponsored a piece of legislation with senior Senator Mamoru Yamasaki that gave the counties a prerogative to levy a half-percent general excise tax. This bill never passed.

"Continuing with the article, it says that 'the number of housing units in the district has risen from 2,485 in 1970 to 9,150 in 1985, an increase of 268 percent and the population of the area has leaped from 4,832 to 19,700 in the same period -- a nearly 307 percent increase. Majority of these housing projects in terms of cost are out of reach of the majority of my constituents.

"The reason I bring this to my colleague's attention, Mr. President, is because we did have a very inspiring debate on the floor in reference to S.B. 3287, H.D. 1, which will help accelerate the affordable housing program throughout the State of Hawaii. I would like to reconfirm that I have expressed strong support for S.B. 3287, H.D. 1, for these very reasons.

"On the last page of the article, Mike Luce, owner of Luce Contracting Inc. and president of Kona-Kohala Chamber of Commerce, which, incidentally, Mr. President, has never endorsed my candidacy, said, 'Rather than slowing down growth, we need to accelerate infrastructure implementation. Our task is to keep the pressure on our state legislators and county representatives for infrastructure development.'

"The irony of it all, Mr. President, is when our Honorable Mayor Dante Carpenter tried to levy a fuel tax on the Big Island to help address these kinds of concerns, the Kona District voiced strong opposition against the concept.

"I think the time has come to inform those residents in West Hawaii that nothing is free.

"Mr. President, I introduced a ninety-four-million-dollar infrastructure bill that will facilitate infrastructure projects that are needed to support existing resort

development. We have resolutions S.R. 183, S.C.R. 178 pending, Mr. President; requesting the Office of State Planning to conduct a study on the use of impact fees. The impact fee is one means of mitigating the impacts of growth and the adverse financial burden placed on state and local governments. The use of impact fees will assure that new developments are assessed a proportionate share of the cost of additional service facilities and programs serving the development. I feel that this is not unreasonable and I feel that this is an issue this honorable body seriously has to consider.

"Thank you."
