FIFTY-FIRST DAY

Tuesday, April 12, 1988

The Senate of the Fourteenth Legislature of the State of Hawaii, Regular Session of 1988, convened at 11:37 o'clock a.m. with the President in the Chair.

The Divine Blessing was invoked by the Reverend Carrie Bail of Ka Hana O Ke Akua Church, after which the Roll was called showing all Senators present.

The President announced that he had read and approved the Journal of the Fiftieth Day.

The following introductions were then made to the members of the Senate:

Senator Hee introduced a group of 23 students in grades 9 to 12 from Kailua High School who were accompanied by their chaperones, Mr. Melvin Imai and Ms. Karen Segawa.

Senator B. Kobayashi acknowledged that Reverend Carrie Bail, who delivered the invocation, was a former staff member in his office last year.

At 11:42 o'clock a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 11:43 o'clock a.m.

Senator Yamasaki, on behalf of the Senate, introduced Senator Yoshiharu Takahashi of the Fukuoka Legislature who is vice chairman of the Fukuoka Assembly and the Fukuoka/Hawaii Goodwill Federation and one who helped bring about the Fukuoka/Hawaii sister-state relationship in 1981. Senator Yamasaki added that the Senator has brought greetings from Fukuoka Governor Okuda and Speaker Nakamura who will visit Hawaii in September.

Senator Yamasaki also introduced Mrs. Yasuko Takahashi, wife of the Senator, and a group of 40 Fukuoka visitors.

Senator Chang then extended greetings to Senator Takahashi and the Goodwill Federation and remarked:

"Mr. President, during Governor Waihee's goodwill mission to Fukuoka in November 1987, we learned that the Governor of Fukuoka may be accompanying officials and business figures who will be in Hawaii to promote products and commodities at the Shirokiya Fair. The delegation also intends to promote the business and industrial exposition that will occur in 1989, drawing participants and visitors from mainland Asia, Southeast Asia and all of Japan.

"Our delegation suggested that Governor Okuda's visit would be an opportune time for Hawaii and Fukuoka to reaffirm their sister-state relationship that we began in 1981. We would request that Senator Takahashi convey our invitation to Governor Okuda and Speaker Nakamura and tell them that we look forward to their visit in September."

Senator Young, on behalf of the Women's Caucus, then presented Senator Takahashi with a congratulatory Senate certificate for Captain Junko Watanabe Sato from Fukuoka, Japan. Captain Sato of the Japan Maritime Safety Agency was being honored for achieving the highest rank of captain of a coast guard patrol boat and for pioneering the way for other women to attend and graduate from the Japan Maritime Academy, the equivalent of the U.S. Coast Guard Academy.

At this time, Senator and Mrs. Takahashi rose to be recognized and were presented with leis by various Senators.

At 11:48 o'clock a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 11:54 o'clock a.m.
