Wednesday, April 13, 1988

The Senate of the Fourteenth Legislature of the State of Hawaii, Regular Session of 1988, convened at 12:05 o'clock p.m. with the Vice President in the Chair.

THIRD READING

House Bill No. 2358, H.D. 1:

Senator Cobb moved that H.B. No. 2358, H.D. 1, having been read throughout, pass Third Reading, seconded by Senator Blair.

Senator Cobb rose to speak in support of the measure and said:

"Very briefly, Madam Vice President, speaking in support. This issue was of some contention with respect to whether or not dentists could remain exclusively the owners of a dental service corporation.

"Your Committee on Consumer Protection and Commerce went to the extraordinary length of seeking and receiving an attorney general's opinion which responded in the affirmative and which also noted that many other professions, including attorneys themselves, have restrictions that limit the ownership of such a corporation to members of that profession.

"Accordingly, your committee did insert in the committee report a strong agreement with the findings and recommendations of the dentists and in nonconcurrence with the recommendations of the Legislative Auditor.

"In view of the legal research done by the attorney general's office, I feel that all of the questions on this issue have been addressed and I would ask for the members' support.

"Thank you."

The motion was put by the Chair and carried and H.B. No. 2358, H.D. 1, entitled: "A BILL FOR AN ACT RELATING TO DENTISTRY," having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

FINAL READING

MATTER DEFERRED FROM TUESDAY, APRIL 12, 1988

Senate Bill No. 151, H.D. 1:

By unanimous consent, action on S.B. No. 151, H.D. 1, entitled: "A BILL FOR AN ACT RELATING TO DRUG PARAPHERNALIA," was deferred until Thursday, April 14, 1988.

Senator B. Kobayashi rose on a point of personal privilege and stated:

"Madam Vice President, we have before us on our desks Senate Bill 2405, Relating to Health Insurance. This matter has been agreed to by the House and is going to the governor. This is the so-called 'well baby insurance bill.'

"When we passed the bill out of the Senate, there were a very major series of amendments that changed important language relating to group, individual, accident, sickness insurance policies, medical service plan contracts, etc.

"The purpose of the amendments, among other things, was to try to differentiate between these variety of insurance policies as well as to assure that the bill would go to conference. The importance of going to conference, in my eyes at the time I suggested the amendment, was because we have currently in conference a number of related bills left over from last year, particularly the health insurance bills relating to chiropractors and the health insurance bills relating to substance abuse and mental health. And I thought it would be appropriate that these various bills be discussed together, as a package so to speak, and that a policy be determined as to which bills have merit and what the policy of the legislature might be with regard to mandatory health insurance.

"What the House did was something I've never seen before. Through its committee report it has redefined what is meant by health insurance policies, taking perhaps the most major term in the bill, not changed it in the bill itself, but changed it in effect by redefining it in the committee report to what was originally in the House language.

"I'm not sure whether this re-definition of a term this important can be done through a committee report, and I would like to ask our own Senate attorneys, to look at this matter and report back to us.

"Thank you."

Senator Cobb also rose on a point of personal privilege and remarked:

"Madam Vice President, I rise to speak in strong agreement with the chairman of the Health Committee.

"Referring to the yellow House report on Senate Bill 2405, the fourth full paragraph where 'Your Committees intend the term "all health insurance policies"' and so forth ... that and the items mentioned by the Health chairman would, in my view, render the bill defective and would necessitate the recommendation for a veto by the governor. I not only fully concur with his remarks, but I think it's a highly unusual step to redefine in a committee report what was the basic intention in the bill because the bill, not the committee report, becomes the law.

"I fully concur with the idea that the matter should have been discussed further in a joint Senate/House conference committee. I'm surprised that it wasn't.

"And in asking for a legal review, I join with the Health chairman in asking not only for that review but also a recommendation as the whether or not, based on that review, the matter of consideration by the governor for a veto should be recommended by this body.

"Thank you."

At 12:25 o'clock p.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 12:28 o'clock p.m.

RECONSIDERATION OF ACTION TAKEN

House Bill No. 3164:

Senator Hee moved that the Senate reconsider its action taken on April 4, 1988 on Third Reading of H.B. No. 3164, seconded by Senator Menor.

Senator Hee then explained:

"Madam Vice President, this bill is a constitutional amendment and therefore requires ten days' notice to the governor before final reading. I have been informed that that did not occur and therefore the move to reconsider so that we can do it in accordance with the law."

The motion to reconsider the action was put by the Chair and carried.

By unanimous consent, action on H.B. No. 3164, entitled: "A BILL FOR AN ACT PROPOSING AN AMENDMENT TO ARTICLE IV, SECTIONS 4, 5 AND 6 OF THE CONSTITUTION OF THE STATE OF HAWAII TO REPEAL MINIMUM REPRESENTATION FOR BASIC ISLAND UNITS AND TO CHANGE THE BASIS USED FOR REAPPORTIONMENT," was deferred until Monday, April 25, 1988.
