# Friday, April 15, 1988

The Senate of the Fourteenth Legislature of the State of Hawaii, Regular Session of 1988, convened at 11:43 o'clock a.m. with the Vice President in the Chair.

The Divine Blessing was invoked by The Very Reverend Clarence Liu, Vicar General, Catholic Diocese of Honolulu, after which the Roll was called showing all Senators present.

The Chair announced that she had read and approved the Journal of the Fifty-Third Day.

At 11:46 o'clock a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 11:47 o'clock a.m.

The following introductions were made to the members of the Senate:

Senator Tungpalan introduced a group of 55 students from Waiau Elementary School and their teachers, Victor Chang, Ann Suzuki and Barbara Fujikami.

Senator Solomon, on behalf of Senators Matsuura, Herkes and herself, introduced a group of 16 students from Waiakea, Laupahoehoe, Pahoa and Kau High Schools who are participating in the Hawaii District Legislative Experience Program, and their faculty advisors, Mrs. Shelly Carvalho-Wagner and Mr. Callen Kamei, accompanied by their district educational resource teacher, Ms. Jo-Lyn Llaneza.

Senator Hagino introduced a group of 38 students from the Wahiawa Store Front Program and their teachers, Colette Toma, Derek Tengan, Jon Morikawa and Shelly Kunihisa.

As a result, the position of the House is now sufficient in that the regulation will be continued for two years and the Legislative Auditor will be conducting a sunset review analysis in the year following this. Therefore, the action in reconsidering the motion is now quite proper at this time."

The motion was put by the Chair and carried and S.B. No. 2003, H.D. 1, entitled: "A BILL FOR AN ACT RELATING TO TRAVEL AGENCIES," was placed on the calendar for Final Reading on Monday, April 18, 1988.
