Friday, April 22, 1988

The Senate of the Fourteenth Legislature of the State of Hawaii, Regular Session of 1988, convened at 11:43 o'clock a.m. with the President in the Chair.

The Divine Blessing was invoked by Brother Stephen Vale of St. Stephen's Diocesan Center, after which the Roll was called showing all Senators present.

The President announced that he had read and approved the Journal of the Fifty-Eighth Day.

The following introductions were then made to the members of the Senate:

Senator B. Kobayashi honored Dr. Stuart Gerry Brown, Professor Emeritus, University of Hawaii, American Studies Department, for "a very distinguished record of academic achievement, having authored or co-authored over twenty books, some of them currently in their fourth edition. Most recently, he has been awarded the Special Freedom of the Press Award at the annual meeting of the Honolulu Media Council." Dr. Brown was not present and the Senate certificate of recognition was received by Mr. Tom Brown, son of Dr. Brown and a researcher in the Senate Majority Office.

Senator Menor then rose to speak in favor of the nomination as follows:

"Mr. President, I would briefly like to rise to speak in favor of Standing Committee Report No. 2922. As the chairman of the Senate Corrections Committee, I would like to recommend to this body the confirmation of Mr. Harold Falk as the director of the Department of Corrections.

"Mr. Falk will be assuming the office of director at a time when the Department of Corrections faces serious and difficult problems as it tries to achieve the potential that the Legislature envisioned for it and as the department tries to create and build a more positive future for Corrections here in the State of Hawaii. These problems include the continuing problem of prison overcrowding and the need for more inmate programs, poor employee morale, the need for new juvenile and women's correctional facilities, and the need to create more meaningful incentives to attract and retain qualified prison guards and correctional personnel.

"In addition to these problems, Mr. Falk is also going to have to devote more serious attention to long-standing management and correctional problems, administrative problems within the correctional system, many of which predates this administration.

"Your Senate Corrections Committee, during the course of this legislative session, has carefully reviewed these problems. I think you can see that Mr. Falk is really going to have his hands full as he assumes the office of director of the Department of Corrections. In fact, on several occasions I've indicated to Mr. Falk that it's really not too late if he wants to back out and reconsider his decision to take on the directorship, but he has assured me that he definitely wants to be the director of the Department of Corrections.

"So basically, as chairman of the Senate Corrections Committee, I am recommending the confirmation of Mr. Falk not only because he truly wants to be the director of the Department of Corrections, but also because of assurances that I have received and the committee has received from Mr. Falk and the Governor's office to the fact that the Department of Corrections will, in fact, make a sincere and good faith effort to resolve the concerns and problems that I have discussed today. I remain confident and I remain optimistic that through Mr. Falk's leadership the Department of Corrections will in fact achieve a better and brighter future here in the State of Hawaii.

"On that note, I strongly recommend Mr. Falk's confirmation to this body. Thank you."

Senator Reed also rose to speak in support of the nomination as follows:

"Mr. President, your Committee on Corrections has taken seriously the consideration of Mr. Harold Falk as Director of Corrections. We have frequently asked hard questions of Mr. Falk, and not always concluded in agreement. But throughout, he has shown that he possesses the strength of his convictions, yet is willing to listen and willing to change. I am confident that he is dedicated to improving Corrections. The only thing that causes me to question his qualifications is that it is difficult, as Senator Menor intimated, to understand why any sane person would volunteer for the job. But then, I guess you could say that of our job also.

"I am confident that Harold Falk is an honest man of integrity who will take seriously the challenge of improving the way we deal with those requiring incarceration in our society. I urge this body to unanimously support Harold Falk. Thank you."

Senator McMurdo then rose on a point of personal privilege and said:

"Mr. President, last night, here at the State Capitol, I heard what I hoped was a rumor that the House position had narrowed to the International Market Place and that the Senate would be taking this under advisement. When I woke up this morning and read the morning paper, I read that the convention center choice is cut to two.

"Mr. Chairman, this is shocking news to me. heartbreaking news to me. And I'll tell you why. It isn't simply that the choice of the International Market Place means that all city and county zoning laws and variances will be overridden. It isn't that the International Market Place is about five acres and that it is far too small for a convention center. It isn't that the developer will be allowed to build hotels when we have a moratorium on hotel rooms in Waikiki. No, it's because as this State Legislature deliberates over the issue of this convention center, this indicates that we're close to making a disastrous decision -- a decision whereby lives, livelihood, families and values are compromised and summarily Any decision which displaces honest Americans who have fought their way out of a repressive society into a democratic system only to discover that their voices and their pleas are not important is an unconscionable decision and a deliberate compromise to the integrity of our democratic system. And I speak this morning of our new Americans who are American citizens, and who are voters who are the ones who came from Korea to this society to make a go in a new country.

"'Have your say the American way,' that's what our state slogan for voter participation says and it makes no distinction between new citizens and all other citizens. Neither our state nor the U.S. Constitution makes this distinction. Your oath of office is not an oath of 'iffice' -- IF it's potentially profitable to displace hundreds of people; IF the people will have short memories. IF we do not take our obligations seriously, THEN we have scrapped a democratic society.

"Any convention center which impacts so severely is wrong in both its intent and its effect. This is not what America is all about. America is the land of opportunity, not of the opportunistic. A wrong decision is not the answer to the problem of a hard decision. Therefore, I plead with the Tourism chairman and my fellow Senators that they hold firm to the Senate position as they did in Senate draft of House Bill 3396.

"I would like to quote from page 2 of the committee report of that draft which says:

'... More importantly, your Committee is sensitive to the problems which may be caused by displacement of the small businesses from the Marketplace. Your Committee does not wish to have on its conscience the elimination of the source of livelihood for the dependents of those small businesses,'

"I would hope that all of the Senators and the people on the conference committee would take this to heart and not have it upon the Senate's conscience. Thank you very much."

Senator Holt also rose on a point of personal privilege and said:

"Mr. President, I rise on a point of personal privilege and I guess in response to the previous speaker.

"The Conference Committee did meet last night with the House. I've received the proposal from the House. It is under advisement. It is under analysis. No decision has been made. "The committee still feels strongly about the elimination of the livelihood for those people working there and will continue to hold the Senate position. But I'm not sure whether the previous speaker meant we should move the convention center to Ala Wai or not. I think at this point and time we have a lot ... no, we don't have a lot of time left, we've got eleven-and-a-half hours left to work with the House to come up with a solution. We will be getting back into conference sometime later today and we are mindful of the situation at the International Market Pplace and will continue to work toward a solution on the convention center issue. Thank you."

Senator Hee also rose on a point of personal privilege and said:

"Mr. President, by way of informing the members on the floor, we have yet to reach a compromise on the native Hawaiian right-to-sue bill. I share the concerns of the House Tourism chairman. There is time. It's a matter of working out what I consider minor technical details.

"Briefly to articulate one of the details, we have agreed to the retroactive clause of the native Hawaiian right-to-sue bill. However, the House maintains the position that retroactivity should be the jurisdiction of individuals and not Hawaiian organizations. I think that in and of itself is a slap in the face to native Hawaiian people. That notwithstanding, the House manager Andrew Levin still has time to respond. The last communication was sent at 4:00 a.m. by me to him this morning. As I understand it, the manager on the part of the House, Representative Levin, myself, Senator Solomon and Millani Trask will be appearing on 'Dialogue' this evening on the right-to-sue bill and I hope those people who have been concerned about that legislation take the opportunity to 'hand it to us on the platter' this evening on public television."

Senator McMurdo then rose to respond to Senator Holt's remarks and said:

"Mr. President, could I be allowed to answer to the Tourism chairman to make a point. I just want to make it perfectly clear that I've not changed my position on the Ala Wai, either, although I did hear a note of hope in the Senator's voice. I was speaking strictly at this point on the International Market Place. Thank you."

Senator Solomon also rose on a point of personal privilege and said:

"Mr. President, I had made some remarks on the floor yesterday regarding the reputation of Miss Milliani Trask, and at this time, Mr. President, I would like to enter it into the record the draft of Representative Andy Levin's April 6 press conference on the right-to-sue. The reason, Mr. President, I would like to make this point on the floor is because we in the Legislature have legislative immunity and I feel Representative Andy Levin's remarks were unfair.

"I would like to read for the record, Mr. President, the excerpts from House manager Andy Levin's remarks, excerpts, Mr. President, that I have been very careful not to take out of context. As stated, Mr. President:

'I have been made out to be the bad guy in the issue by the very people who claim that they want to see a Right to Sue bill become a reality. Mililani Trask has managed to distort many of the facts of the situation and has totally ignored others. Ms. Trask is a lawyer and should know the value of fair representation

when it comes down to who did what, when, to whom. If we take a closer look at the record,'

"At this time, Mr. President, I would like to clear for the record as to any unfair misrepresentation of Miss Trask's conduct as an attorney in the State of Hawaii. It is because Miss Trask knows, Mr. President, in my opinion, the fair value of representation. It is because Miss Trask knows when it comes down to the issues who did what, when, and to whom, that I am speaking on her behalf, so I can clear the record for her.

"If we continue to page 2 of this quite lengthy press conference release, the House manager, Andy Levin, says:

'But I am definitely willing to take even more lumps if we can get this matter settled to everyone's satisfaction The House, the conferees and I are all committed to a Right to Sue bill but not on Ms. Trask's terms. In fact, Hawaiians who want to see this issue settled once and for all can examine the record and may well conclude that Ms. Trask's efforts have hindered the process more than helped it and may ask her to please step down and let others handle negotiations. Even now, those who know the situation believe that she only speaks for a very small group of people. Do you think that confrontation and public hysteria will solve the problems?'

"May I remind, Mr. President, the manager on the part of the House that this is America, that we are protected by the Constitution in terms of freedom of speech and the right to peaceful protest. It further states, Mr. President:

'If Senator Hee is in agreement, and can be flexible, then I think we can finally get into the last phases of negotiation. The House will enter this conference with the highest expectations and the highest enthusiasm. If we do our work right, we can send an agreement to the Governor that he will be proud and happy to endorse.'

"Mr. President, at this time I would like to yield the floor to the Judiciary chairman because we, in fact, Mr. President, have done just that. Thank you."

Senator Hee then rose and said:

"Yes, Mr. President, I can be flexible. This is America. Mr. President, it's obvious we have the makings of a potentially award winning documentary on public TV tonight. And I would like to be the first to extend an invitation and an open arm to you to appear as our leader to sit in the middle of everything that happens to be. But, we are close. It's a matter of, I believe, the House manager as, as ... be that as it may, to be flexible.

"We have virtually compromised and still maintained our position of retroactivity. It's a question of, really, at this point whether the Hawaiian organizations should be treated differently than Hawaiian individuals. The Senate would maintain that the organizations should have every right to seek redress in the court of law where negligent acts have occurred to Hawaiian people, the people that they represent as organizations and associations. Thank you."

Senator Solomon then rose to conclude her remarks and said:

"Mr. President, I'd like to finish my remarks at this time if I may, my concluding remarks.

"It's in my opinion, Mr. President, that I believe Miss Trask has done an excellent job in her presentation of the facts. Mr. President, it is through her efforts that she has made the State of Hawaii become aware that this is a matter of human justice and human rights. And, Mr. President, I hope that in tonight's dialogue presentation we are able to rise above these personal attacks and to look at the issue of right-to-sue in its proper perspective as being a settlement in terms of human rights and human justice. Thank you."

Senator Cobb then rose on a point of personal privilege and said:

"Mr. President, with respect to a convention center, although I'm certainly not a member of the Conference Committee or a member of the Tourism Committee, I am going to be exercising the prerogative of a single Senator in voting and I would like to share with my colleagues, very briefly, some of the criteria I am going to be looking for in the bill so there will be no surprises come Monday. By the way, Mr. President, Yogi Berra once said, 'Ith ain't over until it's over.' Another wise man said, 'The opera ain't over until the fat lady sings.' But we're beginning to hear some music. The hour is approaching.

"When we look at the convention center, I want to see not only an environmental impact statement, but I would like to see addressed a business impact survey, as well; a community impact survey, a traffic analysis as well as detailed bids in writing for any site from any owner or developer. And the broader the range of sites, the better.

"Finally, Mr. President, speaking as one Senator, I think the Legislature and not an authority should make the final selection. We're elected to make those kind of tough decisions and I think it rests with us. I will not prejudge any site or sites. I would only ask that as much as possible we maintain the Senate position, maintain the flexibility for the greatest number of sites, and at the same time try to adhere to a good economic as well as community impact analysis before we make a final choice.

"Thank you, Mr. President."
