Monday, April 25, 1988

# RECONSIDERATION OF ACTION TAKEN

Conf. Com. Rep. No. 278 (S.B. No. 2924, S.D. 1, H.D. 1, C.D. 1):

Senator Hee moved that the Senate reconsider its action taken earlier on Conf. Com. Rep. No. 278 and S.B. No. 2924, S.D. 1, H.D. 1, C.D. 1, seconded by Senator Menor and carried.

On motion by Senator Hee, seconded by Senator Menor and carried, Conf. Com. Rep. No. 278 and S.B. No. 2924, S.D. 1, H.D. 1, C.D. 1, entitled: "A BILL FOR AN ACT RELATING TO NEGLIGENCE INJURY AND NEGLIGENCE HOMICIDE," were placed on the calendar for Final Reading on Wednesday, April 27, 1988.

At 5:29 o'clock p.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 5:30 o'clock p.m.

Senator Hee then rose on a point of inquiry as follows:

"Mr. President, I rise on a point of inquiry.

"Mr. President, I'd like to ask members of the Senate, who is the member on the floor who informed Doug Woo that the chairman of the Judiciary Committee was to blame for this extension? I'd like to ask all the members on the floor to identify themselves, that individual...."

At 5:31 o'clock p.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 5:33 o'clock p.m.

Senator Hee then continued:

"Mr. President, we started this year with a bang and there's no reason why I believe this year is not going to end with a bang, figuratively speaking.

"I will withdraw the question, Mr. President, inasmuch as there doesn't seem to be a response anyway. So I will withdraw the question."

Senator Hee continued:

Mr. President, I stand now on a point of personal privilege.

"Mr. President and members, it has been brought to my attention by the media, a member of the media Doug Woo of Channel 9, put everything on the record, an individual whom I trust, an individual who has never led me to believe or given me a reason not to trust him, that the chairman of the Judiciary Committee is the reason that we are here for an extension; that the bills are Judiciary bills.

"So I would like to elucidate and educate the members on the floor, the media, and anyone else who is remotely interested in why we're here and why we have relied on the governor to extend the Legislature.

"The first two bills on the Order of the Day are the jurisdiction of Ways and Means. On the Order of the Day on page 2, the first two bills are Ways and Means; the third bill is Judiciary; the fourth bill is Finance in the House and Judiciary in the House; the fifth bill is Ways and Means, the sixth and seventh bills are those of

Senator Aki; the eighth bill is Ways and Means; the fifth bill on page 3 is Tourism and Senator Aki; (and the only reason why I bring Senator Aki's name out is because I cannot remember what the name of his committee is housing, it's the Committee on Housing); the next bill is Judiciary; the next bill is a House bill; the next bill is a Judiciary House bill; a Business House bill; the next two are Judiciary; and the last one is a House Judiciary.

"On page 4, the first one is a House Judiciary; the next six are the Senate Judiciary; the last one is a House Judiciary; and the last five are Senate Judiciary.

"As far as I recollect, Mr. President, I'm neither the chairman of Ways and Means, nor am I the chairman of Housing, nor am I the chairman of Tourism, nor am I the chairman of Business and Economic Development, nor do I chair the House Finance Committee, nor do I chair the House Judiciary Committee.

"So let's put the spade right on the table. If there's any member who would prefer to go home because they don't want to take action on any Judiciary matter, that's fine with me. I would make the motion to recommit every single Senate Judiciary bill today, and if anybody wants to second that motion, be my guest. Because if nobody wants to buckle up and vote on the Hawaiian right-to-sue, fine. That's why we're here.

"You know, if nobody wants to vote to give the Waimanalo farmers, every revocable permittee in the State of Hawaii the opportunity for a 35-year-lease, so be it.

"And if nobody wants to vote on the convention center, so be it.

"So if whoever is blaming the Senate Judiciary chairman, I accept. I accept the fact that 15, not even 15, of the 30-plus bills are Senate Judiciary bills. I accept the fact that my staff put all those bills in the box and on the way to the Senate Clerk ran for their life because of the unfortunate incident on Friday night. I accept as the chairman. I accept the fact that I told my staff, right there (points to staff member), the little guy, to go hide in Finance with the rest of the members who were hiding in there for their safety. I accept.

"But if there is any Senator who would like to second the proper motion to recommit, based on that, let me be the one. I accept. I signed for that extension because that's the Legislature's job, not the governor's. And if people want to 'wala au,' people want to 'waha,' 'palanaia, kiloi ka'opala.'

"Anybody who wants to second my motion, be my guest. Okay?

"Thank you, Mr. President."

Senator Solomon also rose on a point of personal privilege and said:

"Mr. President, I rise on a point of personal privilege to comment on the riot of the Korean merchants this past Friday. Just a commentary.

"Mr. President, I ask you, where is the justice in allowing the Korean merchants to threaten the lives of our fellow colleagues here in the Legislature. 'Kill Romy Cachola!' 'Get Milton Holt!'

"The reason why I feel compelled to rise on this issue is because we have been considering in this honorable body issues of great importance to the Hawaiian people. We

issues of great importance to the Hawaiian people. We the Hawaiians have been negotiating for the right to sue bill for the past six years.

"Because the Hawaiian people could not use the court process to settle disputes with trusts that they are direct beneficiaries of, we have had to resort to demonstration and protest, Mr. President. Everytime we have staged a protest in this state, and I have been a part many, I have never experienced what had occurred on Friday.

"When we, the Hawaiian people, protested against the displacement of the farmers in Kalama Valley and Waihole-Waikane, they sent 50-plus Honolulu police officers to maintain, control, crowd control, and to stabilize those who were protesting.

"When we protested in Kona at Kukailimoku and Sand Island, they sent the dogs and their bulldozers, and they sent the National Guard dressed in riot control gear.

"Mr. President, we as your conferees on the Senate backed down on the Senate position on retroactivity. Unless the governor comes up with a plan by 1991, and the Legislature adopts the plan. This plan will address the issue of retroactivity. Only if the governor fails to come up with a plan, then retroactivity will trigger. This is the only way the Hawaiian people can address their concerns of wrong from the days of the overthrow of Queen Liliuokalani. Did we, the Hawaiians, come down here and threaten the of lives of the leadership? No, we did not.

"How many Hawaiians have died on the waiting list? How many families have been destroyed because they were disfranchised from the 'aina'?

"Mr. President, it has been during my short tenureship here in the Senate that we have had the courage to look at bills which have adverse possession, the escheat of 'kuleana' lands.

"Mr. President, we had no compromise in these pieces of legislation that would give the Hawaiians \$5 million to relocate. For the Hawaiian people, there was no consideration and no relocation.

"I want to thank the governor for having the courage to extend this session so that we as Hawaiians can settle our issues through the courts.

"This is a very sad commentary, Mr. President, and I cannot help myself but to speak on this issue. Thank you."
