"Mr. President, I rise to speak against the nomination of Nani Gladys Brandt. I'd like to read very briefly excerpts from some letters from Molokai homesteaders:

'As I have no way of knowing about them I do not question Nani Brandt's administrative abilities. It may be that she is quite competent in that regard. What I do question is her temperamental suitability for the job. I know from years of talking to them that the Molokai Hawaiian Homesteaders feel intensely alienated from the Hawaiian Homes Administration. They feel their interests are at best largely ignored and usually actively There must be a reconciliation between frustrated. those served and those serving them. A person chosen to be the link between these alienated parties must be a healer who can help bring about this reconciliation. The air of arrogant disdain that Nani Brandt habitually assumes when dealing with Hawaiians will intensify the animosity rather than bring reconciliation.'

"Another letter, briefly:

'I am native Hawaiian, a homesteader in the Kapaakea Homesteads on Molokai and president of the Kapaakea Homesteaders Association. Because I am not able to be present at this hearing, I send written opposition to Gladys Nani Brandt for the Molokai Hawaiian Homes Commissioner position. We want a commissioner we can trust and know will work for our Hawaiian people's interest first. Because of past observations and experiences with Nani, we feel that she is not the person we can entrust with such a position.'

"One more letter, this from Hui Alaloa Inc., signed by Sherman Napoleon, Sr. from Molokai. He writes in part, 'Although many objections have been raised by Molokai citizens against Mrs. Brandt's nomination, those objections have fallen on deaf ears.' He continues, 'If Nani Brandt is confirmed as our commissioner, she will remain as a visible symbol of the divisiveness and acrimony that scarred our island during the Kaiaka Rock debate. The Governor can do better for Molokai and for the Hawaiians, and we ask the Senate to give him that opportunity by rejecting Nani Brandt's nomination.'

"I also have petitions here signed by more than a hundred Molokai Hawaiian Homestead lessees opposing Mrs. Brandt's nomination. I've received several phone calls in opposition. I have not received any phone calls in favor although in justice to the nominee, I believe it's running about 50-50 and many people spoke in favor of the nominee at the hearing.

"I wish that Mrs. Brandt had come to talk to me. She didn't. This is not a personal rejection on my part. I feel obligated to vote 'no' because I represent Molokai and because I have a special Aloha for many of the people who are objecting to this nomination. Many of the homesteaders have expressed concerns to me that they find Mrs. Brandt inaccessible and unapproachable. They feel she will not represent their best interests.

"I would like Mrs. Brandt to know that I have not solicited any 'no' votes from other members of the Senate and I am not doing so now. I'm voting 'no' as a symbolic gesture. I do not want this nomination to slide by unanimously. With due respect, I want Mrs. Brandt to remember this 'no' vote, my 'no' vote, as a reminder to be accessible, to be approachable and try her very best to represent the interests of those Hawaiian homesteaders who are genuinely worried that she will do otherwise. Thank you."

Senator Hee also rose to speak against the nomination as follows:

"Mr. President, I rise to speak in opposition of the nominee at this time. Again, just as the previous speaker, I've not sought to defeat the nomination. It's an unfortunate situation that for the second time this nomination has come before this body. The unfortunate situation is that I believe Mrs. Brandt is, in her heart, a good person. I have had the opportunity to get to know her. Unfortunately, the views which she has espoused in the past have sought to divide the community and has been in some ways a catalyst to separate the 'haves' from the 'have nots.'

"I rise to speak against this nomination because of the number of 'kupuna' who have thought otherwise, whose views have been different; in particular, Judith Napolean who was a long-time activist and passed away last year. And in some ways, I think if Judith Napolean were to send the message down, at least to me, the vote would be 'no.' And for those reasons, regrettably, I would have hoped the governor would have sent a more palatable individual to heal the deep scars that exist in the community. However, that's why he is the governor. I will vote 'no.' Thank you."

Senator Aki then rose to speak in support of the nomination as follows:

"Mr. President, I rise to speak in support of Nani Gladys Brandt's appointment to the Hawaiian Homes Commission.

"A year ago when this nomination was before the committee, your committee on Hawaiian Affairs, the testimony we received was strongly in opposition to her appointment. A group of concerned citizens flew over to testify at our hearing strongly opposing Nani Brandt. In the final days of the session, her name was withdrawn by the governor.

"At our recent hearing, held on April 21, 1988, your committee received numerous testimonies in favor and against this appointment. The community remains divided on this issue.

"However, the situation on Moloka'i is far different today than it was a year ago. Today, the people of Moloka'i are talking about jobs and economic opportunities. A year ago, the community was still debating the Kaiaka Rock Project. There are still some strong sentiments regarding this issue -- an issue which can only be resolved by time and sound, effective leadership, positive leadership which would work hand-inhand with those in government like us and also serve as a bridge to bring community leaders into the process.

"To the credit of all those who flew in to testify, I must say that both pro and con did an excellent job.

"Those who spoke against Nani's appointment did so with honest conviction and a strong concern for Moloka'i.

"Those who spoke for Nani's appointment did so with that same courage and conviction. The community leaders of Moloka'i indicate a willingness to truly work for the betterment of their community. It is time that Moloka'i move on. Therefore, I urge both sides to begin working together for the betterment of their community. I especially urge Nani Gladys Brandt to reach out and meet the concern expressed by her opposition. I believe that while the task may be difficult, it can be accomplished. I strongly recommend that Nani work closely with the Hawaiian Homesteaders on Moloka'i.

"In closing, I am confident that Nani Gladys Brandt will meet the challenge that she faces as a commissioner, and I urge all members to vote in favor of her confirmation to the Hawaiian Homes Commission.

"Mr. President, I just want to thank all of the members of the Senate on behalf of the Waimanalo farmers for their strong support on this bill. Thank you."

Senator Hee then rose to speak in support of the measure as follows:

"Mr. President, this is indeed a happy occasion assuming, of course, that the veto message has been adhered to by the Legislature and the governor will see fit to sign this bill into law. As I indicated last year when we thought that it was going to pass, this is the work product of so many individuals farming in Waimanalo and their assistance from friends and family in Waimanalo as well as other parts of the state.

"This bill has been broadened from last year to include all revocable permittees, statewide. So what was once the burden shouldered by the farmers in Waimanalo had been increased this year to the burden of the entire state. This bill accomplishes what the Legislative Auditor had recommended many years ago to the Department of Land and Natural Resources. In the words of Libert Landgraf, it is a bill that is 27 years too late, with respect to the long and arduous process of those who had been revocable permittees struggling to survive without the comfort of long-term leases and without the leverage to secure conventional loans through our lending institutions.

"It is a happy occasion and I would like to thank the chairman, the previous speaker Senator Aki, because with respect to the farmers and those revocable permittees statewide, Senator Aki has demonstrated remarkable leadership and it is a credit to his commitment to farming."

Senator Reed rose to speak against the measure as follows:

"Mr. President, I rise to speak against the Workers' Compensation Fund primarily because it's unnecessary. If lack of competition were indeed the problem, creation of another company would help, but that is not the case. There are enough companies already providing workers' comp insurance. What's interesting about this bill is that the rationale for pushing it and passing it through is that it would help the business community.

"I was at a Labor Committee hearing when a union representative said that that was why this bill was so important. It would help the business community. When I asked him if that was so, why does the small business community and the business community, in general, almost unanimously oppose the workers' comp fund, he replied that business people don't know what they're talking about. That's a classic response anytime a special interest tries to shove something down the throats of people who know very well why they don't want it. This bill is opposed by the very people that it purports to help. In reality, the workers' comp fund is a smoke screen perpetuated by the unions to derail any meaningful reform of our workers' compensation laws. I will vote against it."

Senator Yamasaki then rose to speak in favor of the measure and said:

"Mr. President, I rise to speak in favor of S.B. 2298, S.D. 1, H.D. 2, C.D. 1.

"This bill amends the name of the fund to read 'State Compensation Insurance Fund.' Several amendments have been made to avoid an interpretation that the state could somehow become a responsible party in the operation of the fund.

"It also provides that private independent insurance agents may sell workers' compensation insurance coverage for the fund.

"The bill provides for compliance under Chapter 431 as any other insuree to obtain a certificate of authority and it requires a status report to the Legislature.

"To implement the objectives of the insurance code, the appropriation of \$10 million shall be deemed a surplus for the purposes of statutory insurance accounting.

"With these amendments, the fund will be able to operate under ideal competitive conditions and serve to satisfy the Legislature's original intent without endangering the insurance industry and entangling the state in a lucrative private enterprise.

"Mr. President, for the past several weeks, the opposition has waged a strong media campaign against the bill. Some of the ads read, 'What could you do with \$10 million? Our Legislature is thinking of squandering \$10 million on a risky venture to put the state into the insurance business. State funds don't reduce workers' compensation rates. In fact, rates have been increasing in states with state funds.' And California, Minnesota, Arizona are the states identified. The ad further says, 'Why should Hawaii start a \$10 million state fund when it won't keep rates down?'

"Fact number 2 says, 'State funds can lose a lot of money,' and lists Ohio, Washington, Oregon, West

Virginia, Montana, North Dakota, and Wyoming as states with state funds in serious financial trouble.

"Fact number 3 says, 'The state has a terrible record in operating insurance funds.' Manoa Finance and other financial institutions were operated by businessmen who were employers, and their actions resulted in the fiasco. The director of the former Department of Consumer Affairs appealed to the Legislature for immediate help to save the financial institutions from going under completely and causing a collapse if investors withdrew their deposits.

"What the opposition failed to inform the public about California, Arizona and Minnesota is that although rates have gone up, the return of investment earnings to the employers reduced their net cost of the premiums.

"According to the California state fund annual reports, the dividends paid to policyholders were as follows:

1982 -	\$180,156,000
1983 -	205,390,000
1984 -	190,906,000
1985 -	229,298,000
1986 -	207,168,000

Over \$2 billion dollars have been returned to policyholders over the years.

"The California state fund supported an upward adjustment in benefits which increased costs, but they were proud of their performance in reducing the financial impact of such increases on California employers by offering them a superior workmen's compensation insurance product at a reasonable cost.

"The California state fund not only collect premiums, but also provide a network of full service district offices in Eureka, Redding, Santa Rosa, Sacramento, Oakland, San Francisco, Stockton, San Jose, Fresno, Bakersfield, Woodland Hills, Ventura, Los Angeles, Arcadia, Culver City, Cerritos, San Bernardino, Santa Ana and San Diego.

"In addition, it provides to employers, occupational health services, immediate claims adjustments, legal defense, vocational rehabilitation programs and catastrophic injury rehabilitation, industrial hygiene with a certified industrial hygienist on its staff and maintains an industrial hygiene laboratory accredited by the American Industrial Hygiene Association making it one of only a few insurers in the state to be recognized for maintaining excellent in-house analytical services. With more than 2,000 employees, the California state fund maintains a very high degree of dedication and professionalism.

"California will be celebrating its 75th anniversary, having sold its first policy on January 1, 1914.

"Other insurance carriers were, in effect, forced to be competitive and started paying dividends. An estimated 85 percent or more of all California workmen's compensation insurance premiums are developed under policies with dividend participation provisions which reduce the net cost of insurance to employers.

"The California state fund has set an example for prompt, fair and humane adjustment of claims to injured workers and their dependents. This is not true in Hawaii and I should know because I have had long experiences in handling workers' compensation industrial accident cases -- the burden of proof is placed many times on the injured workers. "Before concluding, I'd just like to note that one of the largest policyholders in California is the California Farm Bureau Federation with over 19,000 farmers and ranchers. It has been the largest group insurance program for farmers in the nation for over 45 years with more than 174 associations representing tens of thousands of participating employers who are covered by the California state fund.

"Hawaii's state fund is expected to learn much from the California state fund. Hawaii has established a close relationship with its president and assistance will be requested to make it an effective and attractive insurance program. Hawaii's business people are being misled by their leaders who appear to be misinformed.

"Mr. President, the 1986 insurance commissioner's report on workers' compensation statistics on direct premium written, direct premium earned, direct losses paid and direct losses incurred, indicates that the insurance industry of Hawaii made a hefty profit of approximately \$79,000,000 from Hawaii's employers. Much of this profit should be available to the employers and this is why a state compensation insurance fund must be made operational with this bill.

"The subject of whether we need a state fund is already in the back of us when Act 296 became law in 1985, it established a workers' compensation state fund -- a law which was supported by the previous administration and of which the present governor was an active and wholehearted supporter.

"Mr. President, there should be no recourse to turn back and I therefore urge this body to move Hawaii forward with a history making legislation and vote 'aye' on this bill. Thank you."
