

## SIXTH DAY

**Wednesday, January 25, 1989**

The Senate of the Fifteenth Legislature of the State of Hawaii, Regular Session of 1989, convened at 11:37 o'clock a.m. with the Vice President in the Chair.

The Divine Blessing was invoked by the Reverend Robert Lott of the United Methodist Church, after which the Roll was called showing all Senators present with the exception of Senator Ikeda who was excused.

The Chair announced that he had read and approved the Journal of the Fifth Day.
