Monday, January 30, 1989

The Senate of the Fifteenth Legislature of the State of Hawaii, Regular Session of 1989, convened at 11:38 o'clock a.m. with the Vice President in the Chair.

The Divine Blessing was invoked by Chaplain Wayne Anderson, Castle Medical Center, after which the Roll was called showing all Senators present with the exception of Senators Crozier, McCartney and Wong who were excused.

The President announced that he had read and approved the Journal of the Eighth Day.

Senator Hagino, on behalf of Senator Ikeda and himself, then introduced to the members of the Senate a delegation from the 1988 Miss Korea-Hawaii Scholarship Pageant and the Hawaii Korean Chamber of Commerce, sponsors of the festival, as follows: Mrs. Duk Hee Murabayashi, president of the Hawaii Korean Chamber of Commerce; Ms. Wendy Kim and Mr. Douglas Park, co-chairmen of the Miss Korea-Hawaii Pageant Committee.
