Senator Solomon rose on a point of personal privilege and said:

"Mr. President, as a courtesy to Lieutenant Governor Cayetano, I would like to advise all of my colleagues that there was a letter that was distributed to every Senator's office and he has asked me to please ask you all to read the letter and take it under advisement. Thank you."

The Chair then responded: "We did receive the letter in our offices this morning."

At 11:51 o'clock a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 11:54 o'clock a.m.

Senator Holt also rose on a point of personal privilege and said:

"Mr. President, this morning your Committee on Tourism, Recreation and Planning held a joint hearing with the House Tourism Committee on HVB's '88-'89 contract.

"In our discussions, I was surprised to learn that HVB has decided to officially endorse certain private enterprises as part of its advertising campaign. I find this to be extremely disturbing, Mr. President, because this practice will create an unfair business advantage at the state's expense.

"What I'm talking about is they have produced a publication which is the official travel guide of the Hawaii Visitors Bureau with GTE Travel Enterprises. Currently,

there are at least two other local publications being put out privately.

"More specifically, Mr. President, the state provides approximately 93 percent of HVB's funding. Because of this fact, it will appear that HVB should be obligated in some fashion to observe our state ethics law. It is my intent, therefore, to seek the advice and counsel of the State Ethics Commission on this matter. It is also my intent, Mr. President, to withhold any decisions regarding HVB's budget request until this matter is settled. Thank you."

ADJOURNMENT
