At 11:42 o'clock a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 11:44 o'clock a.m.

At 11:45 o'clock a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 12:14 o'clock p.m.

At this time, Senator Crozier rose to introduce to the members of the Senate Ms. Mel Worthington, president of the West Oahu College Women's Caucus and member of his staff.

Senator Crozier then rose to speak on a point of personal privilege and remarked:

"Mr. President, I rise to share with you and my fellow colleagues the status of Senate Bill 1264 relating to proposing constitutional amendments to Article XII, Sections 4, 5, and 6, and adding a new section to Article XII of the State Constitution, to change the definition of the Public Trust and add a definition of Native Hawaiian.

"Senate Bill 1264 was introduced by you at the request of the Office of Hawaiian Affairs.

"Quite a fire storm has arisen over S.B. 1264 and especially to the new proposed section which would give a new definition to the term 'Native Hawaiian.' At present, Native Hawaiian means anyone who has half or more Hawaiian blood and all others with less than half Hawaiian blood are considered 'Hawaiian.' This is for the purpose of spending the monies derived from the state by the admission act of Section 5F or more commonly known as the ceded lands monies.

"The new definition would make any Hawaiian a Native Hawaiian and who could share in the proceeds of the 5F post-rata share.

"Mr. President, I was fortunate to be a member of the 1978 Constitutional Convention along with Senators Lehua Fernandes Salling, Gerry Hagino and Tony Chang. In fact, Mr. President, Senators Fernandes Salling, Hagino and myself, sat on the Hawaiian Affairs Committee from which the Office of Hawaiian Affairs emanated.

"I knew then, and I have not changed my view, that the con-con was creating an institution by which the Hawaiian people could choose, through an election process, their leaders and spokesman to resolve the myriad of issues and concerns that have plagued the Hawaiian people. One of the concerns was the bringing together all Hawaiians, both native and others, to work for the common good of all.

"Mr. President, ten years ago, as an Hawaiian Affairs Committee member, I strongly recommended that there should not be two classes of Hawaiians because it would be divisive. The structuring of programs would be almost impossible; the implementing of those programs would be cumbersome, and at times non-productive, because too much effort would be wasted trying not to spend Section 5F monies on less than 50% Hawaiians. All of those points have proven to be true.

"Mr. President, I do not fault the 1978 con-con for not heeding my comments because the whole concept of having an elected body to act as the clearing house for the Hawaiian people is avant-garde in itself.

"So, the con-con wanted to take a more judicious approach and not challenge the term 'Native Hawaiian,' thus creating two classes of Hawaiians. And they probably took the right approach. I did warn them that someday there will be a big fight over this condition.

"Mr. President, my colleagues, my crystal ball nor my magic tea leaves forewarned me that the very fight I foretold would happen at my table, but that is what has come about.

"I still stand by my conviction that there should be only one class of people serviced by the Office of Hawaiian Affairs. Ask any half-Hawaiian or even a full-blooded Hawaiian grandmother, who should health, educational or cultural programs be spent on, her, or her grandchildren who may not qualify as a native Hawaiian? Her reply will be something like, 'I am a kupuna, I represent yesterday and, today, please direct your efforts, your monies and programs to my moopunas (my grandchildren) because they need the assistance to survive today and to prepare for tomorrow.'

"Mr. President, the trustees of the Office of Hawaiian Affairs have reflected on the negative reaction that has been received so far, and have taken the position that of which compassionate and understanding leaders take. They sat down and addressed the arguments and complaints that were lodged against them and this initiative.

"They have reached the conclusion that perhaps not enough public hearings were held, the use of ceded lands monies to fund the poll created a furor, and the logistical difficulties that the late balloting caused, have created enough confusion and ambiguity that the only prudent thing to do is to ask that S.B. 1264 be held in committee for this session. The chair and the committee applaud the trustees and will abide by their wishes. We will hold the bill.

"Mr. President, this issue of blood quantum is still here. It must be resolved so that the Office of Hawaiian Affairs can truly begin to have the positive effect which so many of us believe in our hearts it can accomplish. The trustees of the Office of Hawaiian Affairs want to allay any misunderstanding and misgiving and are willing to have an educational program to make Hawaiians and Native Hawaiians aware of all aspects of the 'blood quantum' issue. They are committed to having public forums and finally to have a balloting process free of the many shortcomings it previously had.

"Mr. President, the Committee on Housing and Hawaiian Affairs will support such an endeavor by recommending in the Office of Hawaiian Affairs budget, the sum of \$60,000 of general fund monies for this initiative.

"Mr. President, the Office of Hawaiian Affairs has had a very rough and tumultuous beginning and after ten years, it is still in its early stages of evolution.

"I believe in the Office of Hawaiian Affair, and as a part-Hawaiian, a Senator, and the chairman of the Housing and Hawaiian Programs Committee, I publicly state that I recognize the trustees of the Office of Hawaiian Affairs as the duly elected leaders of the Hawaiian people and I will extend to them all privileges and courtesies merited to an institution which is charged with the grave responsibilities it must shoulder."

Senator Blair, on behalf of the Senate, then rose to extend Happy Birthday wishes to Kevin Kuroda, clerk of the Senate Ways and Means Committee.

At 12:24 o'clock p.m., on motion by Senator Blair, seconded by Senator Reed and carried, the Senate stood in recess until 9:30 o'clock p.m.
