Wednesday, March 1, 1989

The Senate of the Fifteenth Legislature of the State of Hawaii, Regular Session of 1989, convened at 11:38 o'clock a.m. with the President in the Chair.

The Divine Blessing was invoked by the Reverend Yoshiaki Fujitani of the Honpa Hongwanji Mission, after which the Roll was called showing all Senators present with the exception of Senators Aki and Holt who were excused.

The President announced that he had read and approved the Journal of the Twenty-Fourth Day.

The following introductions were then made to the members of the Senate:
