Senator Yamasaki, chairman of the Committee on Ways and Means, then requested a waiver of the 48-hour Notice of a Public Hearing for the subjects listed on the agenda of the Senate Ways and Means Committee's hearing notice for Friday, March 3, 1989, and the President granted the waiver.

Senator Holt then rose to speak on a point of personal privilege and stated:

"Mr. President, I am in receipt of a letter from the director of taxation, dated March 2nd, which states: 'Pursuant to your request, I am furnishing transient accommodations tax revenue collections for the months of January 1988 and January 1989 by county and state totals. In reviewing these figures it should be kept in mind that January of 1988 was a down month for tourism as it was feeling the effects of the 1987 stock market decline.'

"I wanted to make sure that ... and it shows in here transmittal receipts of this January of \$7.2 million versus last January of \$4.0 million. I want to make sure that people keep that in mind when you see big press releases by HVB on how great tourism is doing -- this January versus last January -- because in their release Carter protruded the January boost to combine industry and HVB marketing efforts. We have to keep that in perspective ... the stock market decline that the director of taxation has reminded us to do when we look at HVB's budget for this year. Thank you."

The Chair then made the following observation:

"Members of the Senate, as you know, tomorrow is the deadline to deck bills for third reading. I have checked with LRB and the Majority Research Office and they seem to be on top of everything and feel confident that they will be able to handle the business, unless there is a deluge of last minute committee report requests. There should be ample time to get everything out tomorrow.

"I would like to request all chairmen to please expedite the signing of pending committee reports. Also, Senators are requested to remain in the building today and tomorrow for signing of those reports."
