Senator McMurdo rose to speak in favor of the measure and stated:

"Mr. President, I rise to speak in favor of this bill. On Friday there were two separate notes in The Honolulu Star Bulletin. One, in Washington, William Reiley, the administrator of the Environmental Protection Agency, called on the White House to adopt a policy calling for the complete phase-out of ozone-depleting chemicals by the end of the century. Last Friday, President Bush, according to CBS news, adopted the policy.

"This policy would double the pace at which production and consumption of CFC's (chlorofluorocarbons) would be restricted.

"In an equally strong move, twelve European countries have agreed to eliminate all production and use of any chemicals that harm the earth's ozone shield.

"The environmental ministers from the twelve countries also agreed to cut production of the chemicals by 85 percent as soon as possible. And as of this morning's Advertiser, six more have signed the international accord.

"Last week, a NASA study revealed a frighteningly high concentration of the chemicals in the Arctic. If they don't dissipate before the Arctic summer, there is potential for serious damage to the ozone layer in that area.

"It is time for serious action.

"Senate Bill 1344, S.D. 1, was based on the very latest scientific research and environmental policies. It is consistent with recent recommendations of the Environmental Defense Fund and the Friends of the Earth.

"Very importantly, it is also consistent with the industry recommendations.

"The Mobile Air Conditioning Society (MACS) has called for many of the prohibitions in this bill.

"The American Refrigeration Institute (ARI) has approved a purity standard for recycled refrigerant from air conditioners and freezer units.

"The Motor Vehicle Manufacturers Association (MVMA) and the Society of Automotive Engineers (SAE) are developing a proposed standard for automotive air conditioners.

"It is an accepted fact that almost 50 percent of the CFC's released into the atmosphere come from air-conditioning and freezer units.

"S.B. 1344, S.D. 1, contains the following:

- It prohibits the retail sales of refrigerants containing CFC's.
- 2. It prohibits the intentional release of CFC's into the air from any source.
- 3. It prohibits the servicing of mobile air conditioners without using a vampire. (Now, vampires suck the CFC's into the machine and then when they refrigerator or the air conditioner is repaired the vampire can be used to put the CFC's back, and so none of it gets into the air.)
- It also adopts rules and procedures for the disposal of any devices or units utilizing CFC's that include mandatory recovery and recycling of CFC's.
- It requires the use of vampires for servicing refrigerators, freezers and any other chilling, cooling, and air-conditioning units.
- It establishes rules and regulations for smallappliance repair shops that are not covered by above changes.

"Time is late. We need regulations of the automobileservicing industry and the refrigerator-freezer industry at the state level where the licensing boards have control.

"Let Hawaii be a leader in this fight to save the ozone layer. Pass S.B. 1344, S.D. 1, and send a message to the other 49 states, as well as to the EPA and to the Bush administration.

"I urge your 'yes' vote on this bill. Thank you."

Senator Chang also supported the measure and remarked:

"Mr. President, with your permission and with the permission of my colleague, may the Journal reflect her remarks as my own."

"Therefore, Mr. President, I think the Senate should be commended for passing this bill out and the chairman, Senator (B.) Kobayashi, should be commended for his work on the bill. Thank you very much."

"Mr. President, I reluctantly rise to speak against this bill. I know that the Judiciary chairman has worked very hard in bringing about reform and equal access to our election process. However, as far as this bill is concerned, the problem I have with it is that it allows a voter to register and vote in the same election day.

"While the intent of this specific piece of legislation that deals with voting and registering on the same day is noble, I can foresee some real problems because of the nature of the rush and the excitement and the workload of precinct workers and poll workers on election day.

"On this particular bill, I have to side with our precinct workers and our civic-minded citizens who register early. Many kinds of unwieldy problems will occur on election day due to this provision. With that reservation, I will be voting against this bill. Thank you."

Senator Menor spoke in support of the measure and said:

"I'd like to speak in favor of this bill and, in response to the previous Senator's remarks, I'd just like to clarify and point out that I also share the concerns that he has raised about certain aspects of this bill that I think need to be improved.

"For example, there is a need to amend the provision relating to the tie-breaking provision. There are some concerns that I have with respect to the provision on the filling of vacancies. And, in particular, with respect to the provision calling for election day registration, I have concerns about the administrative burdens that might result in the Lieutenant Governor's office if that provision were to pass in this present form as contained in the bill and, also, about the possibility of fraud that could result from election day registration.

"However, I am committed to try to resolve these concerns by way of amendments as this bill moves out of the Senate and into the House. In that regard, I'd like to assure everyone here who share the same sentiments and concerns expressed by Senator Mizuguchi, that I shall do the very best I can to work with the House to address these concerns to make the necessary amendments to make this bill workable. But I think that the issues contained in this, and in particular the need to encourage and facilitate voter participation which this bill tries to address, are concerns that are important enough to warrant the Senate passing this bill out to the House for further consideration.

"And if this bill cannot be amended to address the concerns that have been expressed today on the Senate floor, then I will be the first one to take the position that this bill should not be enacted into law. Thank you."

Senator Tungpalan then spoke against the bill and said:

"Mr. President, I'm voting 'no' on this measure because, unfortunately, in this day and age we have negative campaigning. A candidate subject to this negative campaigning the day before election really wouldn't have a chance to rebut any of those remarks. So, in that respect, I will be voting 'no.'"

"Mr. President, I would like to note that the Association of Clerks and Election Officers of the State of Hawaii, which includes all of the county clerks, provided testimony before the Judiciary Committee in support of the bill."

And I wish we would address that issue as well, if not in this session, in the coming session. Thank you."

Senator Cobb also spoke to support the measure and remarked:

"Mr. President, I'm going to be voting for this matter with similar reservations, but, in addition to the remarks of the previous speaker, I think we need to be consistent in allowing commissions to set salaries but in line with the recent salary commission's recommendations for a range of salaries.

"I think a similar range should be established for each of the commissions so that the members who determine the salary can choose from among that range based on the experience and expertise of the particular director. Without such guidelines or ranges, there's really no criteria or standard or other means to ascertain what the salary should be and I think it would help a lot if we are looking at the Executive Salary Commission recommendations to structure such a range in the future for all of our commissions as well. Thank you."

Senator Menor also supported the measure and stated:

"Mr. President, very briefly, to speak in favor of this bill.

"Basically, this bill would be consistent with the trend that the Legislature has established over the years which is to confer authority upon boards and commissions to establish the salary levels for their executive directors. It should be noted that the salaries of the executive directors of most state boards and commissions are not set by the Legislature. These boards and commissions include the Aloha Tower Development Corporation, the High Technology Development Corporation, the Criminal Injuries Compensation Commission, the Land Use Commission, and other boards and commissions which are like those boards and commissions that I've mentioned which set the salary levels for their executive directors.

"And to the extent that the functions of the Ethics Commission are very comparable to the functions of these boards and commissions to which I've just referred, it seems to me that it would be only fair that the salary level of the executive director of the Ethics Commission also be set by the commission and not by the State Legislature.

"For those who would have concerns about the Legislature surrendering oversight over the establishment of the executive director's salary for the Ethics Commission, I'd just like to point out that the Legislature can still provide its input and oversight in the Legislature's review of the executive budget.

"Finally, I'd like to point out that from the time that the Ethics Commission was established in 1967 to 1982 the Ethics Commission did have the authority to set the salary level for the executive director. So in that regard this bill will be conforming the process for setting the salary level for the executive director of the Ethics Commission, confirming that process to previous practice. Thank you."

"Mr. President, this was put at the end of the calendar at my request. I wanted to ask a couple of questions of the chair on Culture and the Arts. She graciously answered everything that I had to say and shared I think a little bit of my concern, and is going to, I believe, take care of the problems I expressed when it comes to dealing with the House. Thank you."

Senator Blair moved that S.B. No. 269, S.D. 1, having been read throughout, pass Third Reading, seconded by Senator Fernandes Salling.

Senator Koki spoke against the measure and said:

"Mr. President, the gross excise tax is a tax that the state has allowed retailers to add on to the pricing in the past, so the idea is not deceptive. If we want to prevent the retailer from charging more than the 4.167 percent, which is the actual cost of the tax, that will be another story altogether.

"We could pass a law that would say will be a deceptive trade practice to represent it to be more than 4.167 percent. The transition cost to the retailers will be high. You know they need to re-do their computers, their cash registers, and also to re-train their people.

"Also, if they need to list the tax as an additional cost such as cost of goods, then most retailers would put a markup on it like all other direct costs. Hence, a higher price to the consumer.

"Another factor to consider is price point barrier. Let's take, for example, an item that's priced at 98 cents. You always wonder why it's 98 cents, \$9.98 or \$99. There are psychological barriers that the retailers are confronted with. Consequently, if an item costs 98 cents, and he would have to sell it for \$1.02, including the tax, what he needs to do then, what he will do either, is to leave it at 98 cents and thereby absorbing the cost, or he will just go up to \$1.05 because he's broken the price point barrier of a dollar.

"So businesses are going to be having a very difficult time in absorbing the 4 percent because many businesses make in their total profits, net profits, anywhere from 2 percent to 10 percent with the majority of them floating between 4 and 6 percent profit, net profit, so you cannot logically expect a business, a retailer, to absorb the cost of the gross excise tax.

"Consequently, I'd like to suggest that to make it equitable so that the consumer just pays the cost of the tax that we change it to 4.167 percent. Anything higher than that is deceptive practice. Thank you."

Senator Tungpalan rose to speak in support of the measure and remarked:

"Mr. President, thank you for allowing me the opportunity to rise to speak in favor of this measure.

"I think the point we want to get across to many of the retailers -- and I graciously accept your explanation as a retailer, Senator -- is that when we go to the grocery store we want to be sure that we're paying at the most 4.16.

"However, at a recent trip to one of the major grocers, I was charged not 4.16, but 4.5 percent. You know, it gets to be a little disturbing to go to the cash register thinking that you're going to pay the 4 percent and maybe 4.16 percent. But to think that now people can go even further, and that this is not within the realm of deception or illegality, but is simply 'permissive' as a letter from the Attorney General stated to the Tax Department. I think it behooves the Senators here to take action affirmatively to at least let the retailers know that what we are being charged should be specifically for the product and perhaps the cost that they have to pay for the tax. I think anything beyond that is not only deceptive but, in my heart, illegal. Thank you."

Senator Cobb also supported the measure and said:

"Mr. President, I rise to speak in favor of this measure.

"During the course of testimony, it became abundantly clear that there is a subterfuge taking place in the retail marketplace. As the Senator from the 22nd District just pointed out, in many cases more than the required minimum amount of the tax is being charged. In fact, in some cases cited before our committee, the stimated amount of the tax charged is up to 10 percent.

"The point in fact what this bill will do is to make sure the final end price shall reflect the tax collected. And because we hear so much about let the marketplace decide in terms of competition, then whether it goes over a dollar or under a dollar is not the point. The end price to the consumer is the point, and to allow the consumer to decide. And as far as this chairman is concerned, anything collected in excess of 4.167 percent is deceptive, if it's collected in the name of a tax. And the evidence of that during the course of the hearing became very clear. And that's why your committee was moved to pass this measure out.

"I urge the members to support it. Thank you."

Senator Ikeda also supported the measure and said:

"Mr. President, this bill came about simply because of the fact that people are trusting when they go to the store. They expect to pay a 4 percent tax. They are used to paying the tax, and they don't very often check to see whether or not it is actually 4 percent.

"Like my colleague from across the aisle, I happen to have checked on a few things. And with the advent of computerized cash registers, it is very common for the amount of the tax to exceed 4.16, and it very often does. To my surprise, this is not illegal, at least not as long as this bill doesn't pass.

"I think the consumer has a right to know exactly what they are paying for. And if an add-on to the price is made then it should be done so openly and it should not be done under the guise of a tax.

"Unfortunately, Mr. President, we have a general excise tax, not a sales tax, and because of that we cannot limit the tax to 4.16. But we can say, in effect, that charging beyond 4.16 percent is a deceptive practice, and that is exactly what this bill does.

"In this way, Mr. President, the consumer is assured that the bottom line price that he pays, whether it be a dollar, \$1.04, \$2.00, \$2.10, includes no more than the 4 percent tax that the law mandates. And the consumer won't have to worry about paying more than what is justly due the government. Thank you."

"Mr. President, I'd like to just inform the members that after a lot of discussion in the Majority caucus, the caucus does not support the substance of the bill calling for a pay schedule for the Office of Hawaiian Affairs, but they are willing to entertain some other form of remuneration. If this bill survives this process, I'll be informing the House of the wishes of the members so that when the bill comes back, it will come back in some other form other than the pay schedule. Thank you."

The motion was put by the Chair and carried, Stand. Com. Rep. No. 674 was adopted and S.B. No. 750, S.D. 2, entitled: "A BILL FOR AN ACT RELATING TO THE OFFICE OF HAWAIIAN AFFAIRS," having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

Ayes, 24. Noes, 1 (Reed).

Stand. Com. Rep. No. 681 (S.B. No. 1321):

Senator Blair moved that Stand. Com. Rep. No. 681 be adopted and S.B. No. 1321, having been read throughout, pass Third Reading, seconded by Senator Fernandes Salling.

Senator Reed rose to speak against the measure and said:

"Mr. President, I'd like to make some very brief comments in opposition to this bill.

"I share the concern of many in our community that state government is becoming increasingly top heavy with an ever-expanding bureaucracy. Senate Bill 1321 would appropriate money for the very laudable purpose of coordinating programs for control of violent behavior. Strangely, however, this bill will put that function of controlling violent behavior in the Office of State Planning.

"If there is money available, it would be better spent assisting already existing Alternatives of Violence programs, state-wide, rather than expanding the state bureaucracy. Thank you."

Senator A. Kobayashi spoke in support of the measure and remarked:

"Mr. President, I'm speaking in favor of this bill.

"The responsibility of coordinating the efforts of the different domestic violence groups is put into the Office of State Planning because they will be planning for an office that will eventually house all these different programs. We couldn't just set up an office right away, and rather than going willy-nilly into any kind of plan the Office of State Planning will be coordinating all the efforts and setting up a regular office to house not only the POS groups, but the different agency groups. Thank you."

Senator Holt also supported the measure and said:

"Mr. President, being the chairman of the committee that jointly referred the bill out, basically, to support the previous Senator's statement that the idea is not to set up more layers of bureaucracy but to get the mechanism together that will provide the vehicle that the previous Senator spoke to to address this very important community issue. Thank you."

The motion was put by the Chair and carried, Stand. Com. Rep. No. 681 was adopted and S.B. No. 1321, entitled: "A BILL FOR AN ACT RELATING TO VIOLENT BEHAVIOR," having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

agreed to amend the bill to insure the integrity of the public hearing process as part of the procedure. Thank you."

Senator Chang supported the measure and said:

"Mr. President, I too will be voting for the measure because I believe as does the proponent of the bill in the potential end-use of this energy resource. However, in the process of debating and deliberating on this measure, I would hope that another look be taken at subsection (c) on page 2 of the bill which relates to the 'waiver by the State of the mineral rights royalty payments normally made by the developer' to the state as a means of compensation for unreimbursed interconnection costs not recovered by avoided cost payments. Thank you."

"Mr. President, speaking in support of this bill, very briefly.

"Mr. President, the purpose of this bill is to clarify the existing law regarding the requirements for a special management area permit for development projects which affect our shoreline areas. It is my understanding that the current law is ambiguous in terms of its definition of the word 'development.'

"As you are aware, Mr. President, this problem can and does lend itself to various interpretations which have no bearing on the intent and purpose of our coastal zone management laws.

"For the record, Mr. President, I believe it is the responsibility of the Legislature to clarify the law, rather than our courts. The bill before us will accomplish this by clearly making a distinction between the type of development as intended under our CZM laws and ocean recreation activities which are regulated under our boating laws.

"More specifically, this bill will make it clear that Chapter 205 of the CZM does not apply to ocean recreation activities.

"I'm voting in favor of this bill for this reason and urge my colleagues to do so. Thank you."
