

THIRTY-THIRD DAY

Tuesday, March 14, 1989

The Senate of the Fifteenth Legislature of the State of Hawaii, Regular Session of 1989, convened at 11:36 o'clock a.m. with the Vice President in the Chair.

The Divine Blessing was invoked by Lt. Raymond Wikle, Commanding Officer, The Salvation Army, after which the Roll was called showing all Senators present with the exception of Senator Reed who was excused.

The President announced that he had read and approved the Journal of the Thirty-Second Day.

The following introductions were then made to the members of the Senate:
