## Wednesday, March 15, 1989

The Senate of the Fifteenth Legislature of the State of Hawaii, Regular Session of 1989, convened at 11:37 o'clock a.m. with the President in the Chair.

The Divine Blessing was invoked by President Al Malupo of the Church of Jesus Christ of Latter-Day Saints, after which the Roll was called showing all Senators present with the exception of Senator Aki who was excused.

The President announced that he had read and approved the Journal of the Thirty-Third Day.

The following introductions were made to the members of the Senate:

Senator McMurdo introduced a group of 20 adults of the Deaf Elderhostel of Kapiolani Community College, Community Service Program.
