#### Wednesday, March 29, 1989

The Senate of the Fifteenth Legislature of the State of Hawaii, Regular Session of 1989, convened at 11:45 o'clock a.m. with the Vice President in the Chair.

The Divine Blessing was invoked by President Sam K. Shimabukuro, Church of Jesus Christ of Latter Day Saints, after which the Roll was called showing all Senators present with the exception of Senators Cobb and McMurdo who were excused.

The President announced that he had read and approved the Journal of the Forty-First Day.

The following introductions were made to the members of the Senate:

They were accompanied by Mrs. Janet Matsumura, mother of the queen, and Mr. Carlton Saito of the Honolulu Japanese Junior Chamber of Commerce.

Queen Lori Matsumura, her court and those accompanying her rose to be recognized and were presented leis by Senators Yamasaki, Matsuura, Holt, Nakasato, Mizuguchi and McCartney.

Senator Chang said: "We extend our congratulations to these lovely, talented, intelligent, and poised young ladies and our best wishes as they begin a challenging and rewarding year as ambassadors of goodwill for the Japanese community and the Honolulu Japanese Chamber of Commerce."
