Thursday, March 30, 1989

The Senate of the Fifteenth Legislature of the State of Hawaii, Regular Session of 1989, convened at 11:38 o'clock a.m. with the Vice President in the Chair.

The Divine Blessing was invoked by Chaplain James Rockenstein, Lt. Colonel, USAF, Wheeler Air Force Base, after which the Roll was called showing all Senators present with the exception of Senators Cobb, Matsuura and McMurdo who were excused.

The President announced that he had read and approved the Journal of the Forty-Second Day.

The following introductions were then made to the members of the Senate:

Senator McCartney introduced Mrs. Gladys Inada, principal, Ms. Grace Ing, Ms. Margaret Sokoeki, Ms. Maxine Haun, and Ms. Mae Kishimoto, teachers, of Ahuimanu Elementary School, participants of the Master-In-Learning Project, and said: "Ahuimanu Elementary School is in my district and I am very proud of the school and very proud to represent them. As you know, we have been talking about school-based management and how we need to have shared decision-making at the school level. Ahuimanu School is a pioneer in shared decision-making at the school level and has a very progressive program."

Senator Koki, on behalf of Senators George, McCartney and himself, introduced a group of ten Cub Scouts from Cub Pack 214, accompanied by their leaders, Don and Estrelita Myers, Linda Kim and Richard Kuniyoshi. Senator Koki noted that "the boys are here today to fulfill their requirements for the Citizenship Award enabling them to earn their Arrow of Light badge which they will receive in May."

Senator Chang introduced Ms. Nam Snow who was also sitting in the gallery.

Senator Crozier introduced a group of Boy Scouts from Iroquois Point, Ewa Beach, accompanied by Mike Brown, Carol Lorenz, Joe Gay, Clara Pike, Mr. and Mrs. Watkins, Mario Bautista and "a very special lady," Regina Mass, with Mrs. Lynn Crozier, wife of Senator Crozier.

Senator Crozier said: "... what is so special about these young men is that most of them will not be making Hawaii their long term residence. They are here from the Navy for a few years and will be moving on to other parts of the world. Hopefully, when they leave they will take with them fond memories of Hawaii ... our beautiful islands and people."

Senator Solomon, on behalf of Senators Levin, Matsuura and herself, introduced Councilwoman Helen Hale of the Hawaii County Council.

Senator Fernandes Salling then made the following introduction:

"Mr. President, I'd like to introduce to this body Mr. Walter Lappert who is sitting with us on the floor of the Senate this morning and to congratulate him for being selected as 'Hawaii's Exporter of the Year.'

"Mr. Lappert, founder and owner of Lappert's Inc., internationally renowned producer of gourmet ice creams

At this time, Senator Holt rose on a point of personal privilege as follows:

"Mr. President, I am in receipt of a correspondence from a journalist through a travel agent in Germany who is pretty aware of what the state is doing in promoting Hawaii over there and this letter speaks of a brochure that was produced by HVB, some 30,000 copies of it, with state dollars, obviously.

"This letter is dated February 24th and this person indicates (the brochures) had not been distributed. The brochure was produced last year and the calendar of events which promotes Hawaii starts in September of 1988 and here we are in February and the brochure was still just sitting in a warehouse in Germany. Apparently, the information had gotten to a journalist in Germany that the brochure was still sitting in a warehouse. This travel agent got to our people in HVB and told them about the brochure still sitting there and the HVB marketing director said he talked to our DBED people and they said it was just doing well and how well they were using it. What happened was that the journalist wrote this article, I asked for it, and I want to share it with you. It is written in German and I cannot translate it so I sent it up to the University of Hawaii at Manoa and Dr. Niklaus Schweizer, professor of German, did the translation for me.

"The title of the article was, basically, Hawaii's best hidden secret and the article is titled, '"He Kukini" is Stewing in the Warehouse.' It reads:

'The travel agencies would lick their fingers, for the brochure of the Hawaii Visitors' Bureau written in the German language contains fabulous information which would be splendid in order to advise people by Using the format of a newspaper, the Hawaiians, having recognized the importance of the German market for their archipelago, immediately in the wake of the ITB have produced a publication in German. Twelve colorful pages of the dimensions of a newspaper offer information on the individual islands, history, suggestions concerning clothing and souvenirs, and a comprehensive calendar of events taking place from April until September. The edition of 31,000 copies is stewing in the warehouse of the USTTA agency, however, and nobody has heard anything about it. Too bad.'

"I just wanted to share that information with you as our Ways and Means Committee proceeds with budget negotiations."
