The Senate of the Fifteenth Legislature of the State of Hawaii, Regular Session of 1989, convened at 11:43 o'clock a.m. with the Vice President in the Chair.

The Divine Blessing was invoked by Sister Brenda Lau from the C.S.J. Catholic School Department, after which the Roll was called showing all Senators present with the exception of Senators Cobb and McMurdo who were excused.

The President announced that he had read and approved the Journal of the Forty-Third Day.

At 11:51 o'clock a.m., the Senate stood in recess subject to the call of the Chair.

The Senate reconvened at 12:19 o'clock p.m.

Senator Matsuura rose on a point of personal privilege and said:

"Mr. President, I rise to speak on a point of personal privilege.

"There was an article in this morning's Honolulu Advertiser, 'Senate puts HawTel service plan for deaf on hold.' What I want to explain is that, I am not criticizing the article in terms of its accuracy, I think the article clearly explains what the chairman did. But, I think what the article failed to explain is why the chairman did that, and this is why I want to take the time to explain.

"First, let me explain what this hearing-impaired service is about. What it does is, when a hearing-impaired person makes a phone call, or calls in to the telephone company where there will be an operator, that hearing impaired person would type a message on an equipment which will be then read on a monitor at the telephone company. The telephone company then takes

the message, calls the person and whatever the voice transmission shows, she will type the message on the monitor again and relay it back to the hearing-impaired. This is how they get to communicate.

"Up to this point or since 1981, the tax payers have been paying for this service. It is provided gratis for the hearing-impaired people. There is a proviso we passed, whereby HawTel is to have the sole responsibility of initiating this hearing-impaired service. What this does is that when the provider such as GTE takes over the service, the subscribers, not the tax payer, will now have to pay for this service. It will be charged as a surcharge, and the subscriber will pay for this service.

"Now, I want to explain what we have done. The Senate version gives the (public utilities) commission an opportunity to investigate other providers. If GTE is coming up with a rate that is too high, with this provision there would be some control. The Senate version reads: 'The commission may investigate the availability of experienced providers of relay services for the deaf and hearing-impaired.' And that is not 'shall,' it is a 'may'; it is something in which the commission may do. If this proviso was not inserted, and if GTE comes up with a very high figure, the users must accept GTE's amount, whatever the amount maybe.

"The second thing about this Senate version is that we have inserted that the commission (the Public Utilities Commission) 'shall establish the special needs advisory committee to advise the commission of special communication needs for the deaf and hearing-impaired and to make recommendations concerning program improvement, including the distribution of telecommunication devices for the deaf.'

"The reason why we have this provision is that this advisory concept has worked. It has worked in other states very effectively; this is why we want to put it in. The service being provided to the hearing-impaired in Hawaii today is totally inadequate. So, whenever a new provider comes in, we want to make sure that the service is going to be equal to what is being provided the hearing-impaired in the other states; in other words, unlimited calls and unlimited time on the telephone.

"Now, the third thing that we put into the Senate version is that we want to line in and indicate the surcharge. The bill reads 'Such surcharge shall be separately identified on the customer's bill as "special needs communications funds."' The hearing-impaired are not the only ones that are going to need this kind of service. There will be others coming forth later. We want to put a line item on your bill, the telephone bill, so that at least every subscriber will know how much this thing is costing him, and there will be some accountability.

"Lastly, because I want the hearing-impaired population to know that we want the best service for them, and because the subscribers are going to pay for this, we have to make sure the cost is realistic and should be at the lowest cost possible.

"We also provide within the Senate version enough funds to at least be the first state in the Union to provide interstate and international calls proviso into this service.

I wanted to clarify this article to say that the Senate in no way wants to limit the kind of service that is going to be offered the hearing-impaired. In fact, we want to go one step further in being the first to let the hearing-impaired communicate with people in other states and to make international calls. We want them to have unlimited number of phone calls. On the other hand, I

think that we have to also be responsible so that the cost element will not go out of control. This Senate version provides that control, that monitoring, so that this will be a fair service provided to the hearing-impaired and at least the public won't complain.

"Thank you Mr. President.

Senator Yamasaki, chairman of the Committee on Ways and Means, then requested a waiver of the 48-hour Notice of a Decision-Making Hearing for the subjects listed on the agenda of the Senate Ways and Means Committee's hearing notice for Friday, March 31, 1989, and the President granted the waiver.

At 12:22 o'clock p.m., on motion by Senator Blair, seconded by Senator George and carried, the Senate stood in recess until 8:00 o'clock p.m., this evening.
