Senator Yamasaki moved that H.B. No. 205, H.D. 1, S.D. 1, having been read throughout, pass Third Reading, seconded by Senator A. Kobayashi.

Senator B. Kobayashi rose to speak in support of the measure and said:

"Mr. President, I rise to speak in favor of the bill.

"I'd like to point out that the education budget (S.D. 1) is \$28.1 million better-funded in education than the comparable House budget. And it is not just a matter of

having more dollars in the Senate budget that distinguishes it from the House budget. It's partly a matter of how that money will be spent.

"Built into the budget are means by which local level decisions can be made on spending priorities. That is, there are a number of large-dollar items in which monies will be allocated to the specific schools and the schools themselves will decide whether the money will be spent for one purpose or another. Let me give you a few examples. The Senate budget includes \$2.4 million for textbooks and instructional materials. This is an item not in the Governor's budget and not in the House budget. The monies will be allocated to the schools and the individual schools will be able to decide whether they buy science textbooks or English textbooks or social studies textbooks, or any other instructional material. That will be a school-based decision.

"Further, there is approximately \$6.3 million for core learning. Core learning will provide additional teachers on the secondary level and will have the effect of decreasing class size. For this item, the schools will be able to decide whether they want additional off-ratio teachers in any particular area and assign the teachers accordingly; to math, if that's their decision, or English, if that is their decision.

"Additionally, there is a very large increase for the school priority fund. Currently, school priority fund is pegged at \$17 per student. The Senate proposal virtually triples that to \$50 per student. The school priority fund, as you know, allows the individual schools to take a lump sum of money -- in this case \$50 per student -- for any school priority which is of course decided on by that school. Should a school decide to buy a microcomputer, that is their decision. Further, they can decide to buy textbooks or art supplies or sports equipment for their athletic teams or whatever. That becomes their decision.

"In addition, the Senate budget includes \$1.5 million per year for a total of \$3 million for the biennium for discretionary support personnel. There is no designation in the budget as to whether these monies are to be spent for library assistants, curriculum coordinators, counselors, school clerks, or whatever, although all of these above positions were requested by one or another individual. Rather in this case, these monies will be distributed to the district level and the district level will then prioritize the various school needs in the district, and then redistribute money down to the school level.

"So, as you can see, the money hopefully will be spent sensibly by people who know best what will produce the best results. Money will hopefully go further and bring better educational results in the classroom and at the student level where, of course, it really counts.

"In addition to these items being spent at the local level, I should note that these items are very basic, non-controversial, and I think generally agreed to be of educational merit. These items are not fanciful, theoretical, exotic items which may or may not have any proven results in the classroom or with students. So, hopefully, we will have with this built-in flexibility greater results for our dollar with decisions made at the school level.

"Please note that these fundings are separate and apart from the school-based management program. They will certainly fit into the spirit of school-based management and for those 30-odd schools that are fortunate enough to become designated school-based management schools, these monies will have additional flexibilities which will enable these schools to best assert themselves in developing their own school-level priorities.

"I should note that the budget also includes a number of items which will have a major effect on a very large problem area. And, that is, our so-called special needs schools. Special needs schools are sometimes called 'at risk' schools, schools which for a variety of reasons are not doing as well as they should. These schools have a very difficult time improving because under our current system they are treated just as any other school and not given any additional resources.

"There is in the budget \$4.2 million, the amount the Governor requested for special needs schools. These funds will be distributed to approximately ten schools during the first year on a half-year basis and then during the second year of the biennium on a full-year basis. These monies will provide individual schools with the mechanism to, shall we say, pick themselves up by their bootstrap to leave the current problems that they have behind and reach new plateaus of excellence. In support of special needs schools, there are funds for after-school instruction, which are intended largely for 'at risk' students.

"Another item which was added late in the Ways and Means process was \$3.2 million for microcomputers. Microcomputers, as you know, won't solve all of our problems, but many of our schools have been using their discretionary school priority funds for this purpose, and also conducting school fund-raising campaigns which go to augment their meager supply of microcomputers. So the \$3.2 million for microcomputers I think will be a welcome addition to the school budget.

"In all, I think we have the basis for not only improved learning but, hopefully, improved learning which motivate or empower the local schools to take hold of their own destinies, assert themselves, become more energetic, have an opportunity to display their own initiatives on their problems as they see it. So, I'd like to thank the Ways and Means chairman and members of Ways and Means for their support of the budget, and I urge support for this bill."

Senator Solomon also supported the measure and remarked:

"Mr. President, I too speak in support of the budget bill.

"Mr. President, I would just like to make a few remarks on the Higher Education budget. As you here well know, my fellow colleagues, my committee, has been interested in looking at the autonomy issues for the University of Hawaii at Hilo.

"A bill was passed out of your Committee on Higher Education recommending autonomy, to create a separate entity which would be a Hawaii State University and this would involve the Hilo campus. As you well know, the bill was held in the Ways and Means Committee.

"A second attempt to bring the issue to the floor for our consideration is a bill that had recommended a master plan funding for the new West Oahu College. We had requested that it would also include consideration to create a separate president for the University of Hawaii at Hilo; thereby, be able to give the University of Hawaii at Hilo some autonomy in terms of fiscal control and programming. That, Mr. President, was held in the Ways and Means Committee.

"However, Mr. President, I think that we have made tremendous progress in that we included an item in the budget that would not only allow for the West Oahu campus planning dollars, but also encourage the Board of Regents to come up with a master plan on the governance

relationships among the community college system, the University of Hawaii at Manoa, the University of Hawaii at Hilo, and the new West Oahu Campus.

"Mr. President, I cannot state this with any more determination than I have in the past that it is in my opinion as your committee chairman in Higher Education that Manoa is definitely moving away from undergraduate education. We can see it in the budget appropriations and I cannot encourage the Board of Regents more to take this into serious consideration and come up with a recommendations so we here at the Legislature can deal with this problem. We definitely have an obligation to take care of the needs of the undergraduates to provide them with an intensive four-year academic program.

"In conjunction with this, your committee will be holding a joint committee hearing with the House and we will be briefed by Dr. Ernest Boyer who was hired by the Board of Regents to report back on a Senate Resolution that was passed pertaining to the possibility of giving autonomy to the community colleges.

"Again, Mr. President, I must admit that I am not completely satisfied. However, I'm happy that at least we do have a budget appropriation and we can perhaps encourage the Board of Regents through resolution, to seriously look at the governance question regarding the University of Hawaii in Hilo."

Senator McCartney also spoke in support of the measure and said:

"Mr. President, this being my first vote ever on the budget, I'd like to rise and speak in favor of the budget, and I'd like to echo the words of our Senate Education chairman that it is very good budget.

"You know, for years the education community has struggled and struggled to get funding to put programs into place. Because of constraints in funding we weren't able to do some of the things that we should have done, and this budget reflects the commitment to education; a commitment to our children; a commitment to our future.

"I'm very proud to have participated in this budget in the Ways and Means Committee and I'd like to commend our chairman of the Ways and Means Committee for taking a bold position on education and not being afraid to spend the money on educational reform because it does take money to reform an educational system and there are a lot programs that are needed there. I commend the chairman and the committee. Thank you for allowing me to participate in the process."

Senator Yamasaki, chairman of the Committee Ways and Means, then said:

"Mr. President, I rise to speak in favor of House Bill 205, Relating to the State Budget.

"Mr. President, the State of Hawaii is experiencing an unprecedented growth with a huge surplus at this moment. The general outlook, according to the Council on Revenues, appears to be looking good, and economists also have painted a similar positive picture.

"However, our real concern should be whether this growth can be sustained over the six-year planning period of our state budget, including reduction of federal funds, and, therefore, it will be prudent for us to bear in mind that when we approve expenditures the health and welfare of this state, including our children, must be given additional support to improve the quality of life of our residents. With this in mind, expenditures in the budget

takes into consideration the broader social and economic needs of our residents.

"This budget provides for adequate funds to improve our programs in education, both lower and higher education, which has been given top priority. Health care for infants and toddlers - to give them a healthy start by an increase in programs administered by the Department of Health and also programs for the elderly and our needy.

"In lieu of the transfer of sin taxes to the counties, funds have not been provided to the counties to meet their needs through grants-in-aid programs.

"Overall, Mr. President, the budget provides for the bottom line of our efforts to improve the quality of life of the people of this state and the beginning of a new future for our children. I ask, Mr. President, that a unanimous vote be cast by this body.

"Mr. President, at this time, I would like to note a correction that is necessary to be inserted in the Journal because there are some pages that have been duplicated and some pages that have been omitted.

"First, pages 87 to 96 duplicates pages 77 to 86, and should be deleted. Also, page 100 ends with Section 66, and page 101 begins with Section 85, the missing pages have been identified and I have a copy of the additional pages that should be inserted which covers Section 67 to Section 84. These pages will be provided to the Journal Clerk. These corrections will be transmitted to the House for consideration in conference.

"Last, but not least, I would like to thank the staff and also the subject matter committees for their cooperation in assisting in the development of the budget process. Thank you very much, Mr. President."

NOTE: Sections 67 to 84 of H.B. No. 205, H.D. 1, S.D. 1, follows:

SECTION 67. Provided that of the general fund appropriation for Waimano training school and hospital (HTH 511), the sum of \$552,195 in fiscal year 1989-1990 and \$975,000 in fiscal year 1990-1991 shall be used to fund home and community based services programs for persons with developmental disabilities, to serve as the State's share in obtaining Medicaid funds in the Home and Community Based Services II program.

SECTION 68. Provided that of the general fund appropriation for Waimano training school and hospital (HTH 511), the sum of \$935,550 in fiscal year 1989-1990 and \$982,328 in fiscal year 1990-1991 shall be used to provide services, which the legislature finds to be a public purpose, for Waimano training school and hospital, through purchase of services agreements under chapter 42, Hawaii Revised Statutes.

SECTION 69. Provided that of the general fund appropriation for health education (HTH 908), the sum of \$127,652 in fiscal year 1989-1990 and \$134,034 in fiscal year 1990-1991 shall be used to provide health education services, which the legislature finds to be a public purpose, through purchase of services agreements under chapter 42, Hawaii Revised Statutes.

SECTION 70. Provided that in expending the general funds appropriated for general administration of the department of health (HTH 907), for the departmental reorganization and in order to ensure the efficient expenditures of these funds the department shall:

(1) Conduct public meetings and presentations which address, among other things, specific plans for mental health services covering (a) children/adolescents; (b) adults; and (c) drug and alcohol abuse with special emphasis on the seriously disabled mentally ill; and

(2) Invite primary consumer groups, family members, and advocates of mental health services to suggest candidates for the position of deputy director for behavioral health and forward such suggestions to the governor.

SECTION 71. Provided that the County/State Hospitals Division shall be authorized to establish a two-year pilot project whereby the Department of Health's County/State Hospitals Division would be delegated the authority to recruit, screen, certify, and hire eligible applicants for selected classes for the public hospitals in the County/State Hospitals Division. By setting the implementation date for January 1, 1990, the Division will be able to complete discussions with the Department of Personnel Services regarding this project and develop the framework and staff to assume the additional requested authority. During the two-year pilot project, the Division would delegate authority to Maui Memorial Hospital. This would occur after the program becomes functional at the Division level. Provided further that the Department of Health shall submit a report of specific concerns and recommendations to the Governor and the Legislature twenty days prior to the convening of the 1991 regular session.

"SECTION 88D. Provided that Article VII, section 8, of the constitution of the State of Hawaii provides that the budget shall be submitted in a form provided by law setting forth a complete plan of expenditures of the executive branch; provided further that this budget when it becomes an Act is a law which may add additional requirements for future budget submittals under Article VII, section 8, of the constitution of the State of Hawaii where they are not in conflict with other law; provided further that the executive budget for fiscal year 1989-90 submitted to the legislature shall further reduce the appropriation for the county/state hospitals division to \$8,929,059; provided further that the executive budget for fiscal year 1990-91 shall further reduce the appropriation for the county/state hospitals division to \$7,798,279; provided further that the executive budget submitted to the legislature shall reduce the appropriation for the county/state hospitals division submitted in fiscal year 1991-92 by \$1,130,780; provided further that the executive budget submitted to the legislature shall continue to reduce the appropriation for the county/state hospitals division in each fiscal year following 1991-92 until the appropriation for the division is zero; and provided further that the executive budget submitted to the 1989 legislature shall contain this provision updated one year."

SECTION 73. Provided that of the general fund appropriation for general administration (HTH 907), the sum of \$186,451 in fiscal year 1989-1990 and \$195,775 in fiscal year 1990-1991 and of the federal funds authorized for that program (HTH 907), the sum of \$9,480 in fiscal year 1989-1990 and \$9,480 in fiscal year 1990-1991 shall be used to provide health services, which the legislature finds to be a public purpose, for general administration, through purchase of services agreements under chapter 42, Hawaii Revised Statutes.

SECTION 74. Provided that of the general fund appropriation for general administration (HTH 907),

the sum of \$240,000 in fiscal year 1989-1990 and \$240,000 in fiscal year 1990-1991 shall be used for grants-in-aid as provided in chapter 42, Hawaii Revised Statutes, relating to health services which the legislature finds to be a public purpose, for general administration.

SECTION 75. Provided that of the general fund appropriation for private hospitals and medical services (SUB 601), the sum of \$400,000 in fiscal year 1989-1990 and \$325,000 in fiscal year 1990-1991 shall be used for grants-in-aid as provided in chapter 42, Hawaii Revised Statutes, relating to private hospitals and medical services, which the legislature finds to be a public purpose.

SECTION 76. Provided that of the general fund appropriation for private hospitals and medical services (SUB 601), the sum of \$1,743,643 in fiscal year 1989-1990 and \$1,630,977 in fiscal year 1990-1991 shall be used for subsidies as provided in chapter 42, Hawaii Revised Statutes, to private hospitals and medical services, which the legislature finds to be a public purpose.

SOCIAL SERVICES

SECTION 77. Provided that the department of human services is authorized to trade off, transfer, or establish positions within the existing authorized position counts and without regard to means of financing for the purpose of maximizing the utilization of personnel resources and staff productivity; provided further that the department of human services shall submit a report to the legislature twenty days prior to the convening of the 1990 regular session that includes (1) the status of all positions provided for in this Act; (2) a description and an explanation of the reasons for the actions taken pursuant to this Act.

SECTION 78. Provided that of the general fund appropriation for services to individuals and families (HMS 111), eligibility determination (HMS 236), general support for public welfare (HMS 903), and general administration (HMS 904), in order to ensure the appropriate expenditure of funds by the department of human services, no funds shall be expended for the purchase or lease of microcomputers and word processing equipment until an office automation master plan is presented to, and approved by, the department of budget and finance.

SECTION 79. Provided that of the general fund appropriation for services to individuals and families (HMS 111), the sum of \$7,886,065 in fiscal year 1989-1990 and \$8,232,932 in fiscal year 1990-1991 and of the federal funds authorized for that program (HMS 111), the sum of \$3,183,761 in fiscal year 1989-1990 and \$3,183,761 in fiscal year 1990-1991 shall be used to provide services, which the legislature finds to be for a public purpose, to individuals and families through purchase of services agreements under chapter 42, Hawaii Revised Statutes.

SECTION 80. Provided that of the general fund appropriation for services to individuals and families (HMS 111), the sum of \$230,125 in fiscal year 1989-1990 and \$472,978 in fiscal year 1990-1991 shall be used for grants-in-aid as provided in chapter 42, Hawaii Revised Statutes, relating to services, which the legislature finds to be for a public purpose, to individuals and families.

SECTION 81. Provided that, in order to determine if the department of human services is appropriately expending moneys appropriated for the rental housing

augmentation and assistance program, the legislative auditor shall conduct a financial and management audit of the rental housing augmentation and assistance program (HMS 220), which shall include, but not be limited to, a review of the department of human services' compliance with Act 217, Session Laws of Hawaii 1988, relating to an amendment of, and appropriation to, the state rent supplement program and the management controls in place to administer rent supplement payments to "housing owners" on behalf of "qualified tenants"; provided further that the auditor shall conduct a review of the median gross rent rate per month, by county, and submit a progress report of actual expenditures for this purpose for fiscal year 1988-1989 and the first half of fiscal year 1989-1990, and projected expenditures for the second half of fiscal year 1989-1990 to the 1990 regular session; provided further that the auditor shall also evaluate the department's efforts in implementing the intent of Act 217, Session Laws of Hawaii 1988, to raise the rent supplement limit and to address the needs of families and elderly individuals on the waiting list by providing payments and services in a more efficient manner; and provided further that the auditor shall submit a report of findings and recommendations to the legislature twenty days prior to the convening of the 1990 regular session.

SECTION 82. Provided that of the general fund appropriation for rental housing augmentation and assistance (HMS 220), the sum of \$408,000 in fiscal year 1989-1990 shall be expended as follows: \$329,000 to design and implement a security and control system pilot project at Mayor Wright and Kalihi Valley housing projects; provided further that the pilot project shall be modeled after the Red Hill security and control system in order to control the flow of vehicular traffic and to enhance the safety of the designated areas; \$75,000 to compile and evaluate statewide data on the homeless population in order to determine appropriate budgetary needs; and \$4,000 to design and construct a fence for the Kilauea elderly housing project.

SECTION 83. Provided that of the general fund appropriation for private housing development and ownership (BED 225), the sum of \$979,900 in fiscal year 1989-1990 and \$419,100 in fiscal year 1990-1991 shall be used for grants-in-aid as provided in chapter 42, Hawaii Revised Statutes, relating to private housing development, which the legislature finds to be for a public purpose.

SECTION 84. Provided that of the general fund appropriation for housing finance and development administration (BED 229), the sum of \$50,000 in fiscal year 1989-1990 shall be expended for the publication of an education brochure about leasehold arrangements in Hawaii for distribution to the public.

Senator Holt then added his remarks in support of the bill and said:

"Just very briefly, I know we've had a long day, to share with you my support for this budget.

"We probably will get a lot of phone calls in the next few days on some of the recommendations but basically the Senate is adamant to continue to fund the Hawaii Visitors Bureau directly for advertising, marketing and promotional activities and we have reflected that in our budget recommendations.

"However, you will find that there is a recommendation to have the Hawaii Visitors Bureau generate more

revenues for their own administration, and that is primarily because from the contracts and information that we have before us and in Ways and Means is that of an administration budget of about \$4 million, currently, they are only putting forth \$130,000 for administration, about 3 percent.

"So, with that I'd just like to express my support for the recommendations of Ways and Means as we head into conference."

The motion was put by the Chair and carried and H.B. No. 205, H.D. 1, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO THE STATE BUDGET," having been read throughout, passed Third Reading on the following showing of Ayes and Noes:
