## Wednesday, April 5, 1989

The Senate of the Fifteenth Legislature of the State of Hawaii, Regular Session of 1989, convened at 11:37 o'clock a.m. with the Vice President in the Chair.

The Divine Blessing was invoked by the Reverend Larry Kositsin, Seventh-Day Adventist Church, Kailua, after which the Roll was called showing all Senators present with the exception of Senators Chang and Cobb who were excused.

The President announced that he had read and approved the Journal of the Forty-Sixth Day.

The following introductions were then made to the members of the Senate:

Senator McCartney introduced a group of students, seated in the gallery, from King Intermediate School who were visiting the Capitol to observe the legislative process, accompanied by their teachers, Mrs. Charlene Tarr, Mrs. Lori Hanaike and Mrs. Ann Kawai, and counselor, Mr. Ernest Hamai.

Senator Solomon, on behalf of the Senate President and the Higher Education Committee, introduced three scholars from North Korea: Professor Li Dong Sam, Professor Pak Chang Gon and Mrs. Kim Gyong Ha, researcher. Senator Solomon noted that they are here on an invitation from the Korean Studies Center of the University of Hawaii and will also be visiting Harvard University, Columbia University and the University of Southern California.

The gentlemen and lady, who were seated on the floor of the Senate, rose to be recognized.

Senator Matsuura then introduced Mrs. Jean King, former lieutenant governor of Hawaii and former member of the state Senate and House of Representatives, who was seated in the gallery.

Senator Crozier, on behalf of the Big Island Senators, introduced Witte Akana and said, "He is a very close friend who is like a brother to me. Witte is the son of Mayor Bernard Akana."

Senator Menor introduced his student "shadow" Andrew Lee from Wheeler Intermediate School, son of Representative Sam Lee.

Senator B. Kobayashi then introduced Mr. Bruce Carlson, director of Waikiki Aquarium, and said:

"Mr. President, it gives me great pleasure to introduce an individual and an organization, the Waikiki Aquarium, which is celebrating its 85th anniversary. The aquarium first opened its doors in 1904 and has gained a world-wide reputation for its exhibits and for educational excellence and service to the community. It has provided an opportunity for millions of local residents and visitors to see the wonders of the undersea world in a natural setting.

"The Waikiki Aquarium has more than 250 species of marine life on display and is the focal point of information and learning for school children and adults alike. Currently, the Waikiki Aquarium ranks 8th amongst Hawaii's visitor attractions with over 350 thousand visitors annually and more than 35 thousand students each year participate in the aquarium's education programs.

"On Saturday, April 8th, the Waikiki Aquarium is celebrating its 85th anniversary with a special birthday party which features activities especially designed for young children ages 2 to 10. Adults are also invited to attend."

Mr. Carlson, present on the Senate floor, rose to be recognized and was presented the congratulatory Senate certificate and lei.

Senator Holt, on behalf of the Senate, introduced a group of student-athletes from Kamehameha Schools who are members of three championship teams: the ILH Division II Championship Boys Basketball Team with head coach Norman Janicki, assistant coaches Ed Chu, Spencer Napoleon and Paul Akeo; the ILH Division I Championship Boys Basketball Team with head coach James Winchester, assistant coaches Guy Bello and Clay Cockett; and the State Championship Girls Soccer Team with head coach Walter Thompson and assistant coaches Greg Suetsugu and Rinda Young.

All of the students and coaches who were seated in the gallery rose to be recognized.

Senator Holt also introduced the following Kamehameha Schools student-athletes who represented the respective championship teams on the floor of the Senate: Jason Tamashiro and Jarrett Chang, seniors, Division II Basketball Team; Kevin Lau and Brett Hitsman, seniors, Division I Basketball Team; and Kaira Karlen and Jody Kaulukukui (daughter of Judge Thomas Kaulukukui), seniors, Girls Soccer Team.

All of the students rose to be recognized.

At 11:50 o'clock a.m., the Senate stood in recess subject to the call of the Chair.

Senator Ikeda introduced Lei Mamo Howell as follows:

"Mr. President, it is my distinct pleasure to introduce, on behalf of the Women's Caucus, a woman who has achieved success in all aspects of her life. She is wife, mother, grandmother, as well as a successful entrepreneur. Lei Mamo Howell began her career as an entertainer and then as a model in Europe for top international couturiers like Dior and Estevez. She returned to Hawaii and continued modeling for local establishments, most notably Carol and Mary.

"Mamo began her manufacturing business by designing and marketing a baby blanket and for three years this was the sole product of her one-woman company. Wanting to expand her business Mamo decided to make larger blankets or kihei pili. Mamo's grandmother and mother were quilters so Mamo decided to incorporate the designs of Hawaiian quilt into textile art. The result was a distinctive look. Excited about finally creating something new and unique, Mamo set out to market her new blanket. Unfortunately, no one was very receptive to this new product. She had invested quite a bit of money into the print screens and out of desperation to get some kind of return in her investment Mamo made women's dresses. She started with just two styles and two prints. Again, the reception from store buyers was cool. persevered and continued to make sales calls to almost every store in Hawaii and finally a few stores did finally buy some of her things. Thus began her manufacturing and extensive designing career.

"Mr. President, as you know, on Aloha Friday you see many of her designs in beautiful colored muumuus on the floor of the chambers.

"The Department of Business and Economic Development annually recognizes Hawaii's garment industry. This year Mamo Howell's firm has been selected to receive the award for the company which has contributed the most to the local fashion market.

"Mr. President, fellow colleagues, it gives me great pleasure to introduce this extraordinary woman this morning, Lei Mamo Howell."

The honoree rose to be recognized and was presented the congratulatory Senate certificate and lei.
