

## FIFTIETH DAY

Monday, April 10, 1989

The Senate of the Fifteenth Legislature of the State of Hawaii, Regular Session of 1989, convened at 11:37 o'clock a.m. with the President in the Chair.

The Divine Blessing was invoked by the Reverend Robert Wasner of the Windward Unity Church, Kailua, after which the Roll was called showing all Senators present with the exception of Senators Cobb and McMurdo who were excused.

The President announced that he had read and approved the Journal of the Forty-Ninth Day.

The following introductions were then made to the members of the Senate:

Senator Crozier, on behalf of Senators Chang, Mizuguchi and himself, introduced Donny Holt, assistant Sergeant-at-Arms. Senator Crozier noted that Donny will be leaving for Micronesia after the session.

Senator Levin introduced Dr. Al Manville, a wildlife biologist, certified pilot, chairman of the Entangled Network Coalition and an interpreter for the Mandarin-Chinese language, who was seated in the gallery. Dr. Manville is here today to give a presentation on marine debris and plastics.

Senator Menor, on behalf of Senator Mizuguchi and himself, introduced president of City Bank, Mr. Earl Hirotsu, executive vice president, Mr. Michael Kawamoto, and senior vice president, Mr. Wayne Miyao. Senator Menor noted that City Bank is celebrating its 30th anniversary.

Senator Crozier, on behalf of the Senate, wished Senator Ann Kobayashi a Happy Birthday.

Senator Matsuura rose on a point of personal privilege and said:

"Mr. President, the reason I'm standing today is that I wanted to mention, especially to the chairman of Ways and Means, that if you read in the paper today, Texas A&M did reproduce the same effect that the Utah University scientists did in cold fusion.

"Why am I mentioning this and what's relevant has to do with the purchase of Palmyra Island. Palmyra Island has approximately 15 to 20 billion dollars worth of manganese crust and manganese nodules in the island in the EEZ. One of the components in the manganese crust is a rare metal called palladium. I can assure you that if this cold fusion experiment has been really reconfirmed, palladium someday is going to be in very great demand. There are three places where the manganese crust are found. One is around the Big Island; another is around Johnston Island and the third deposit is around Palmyra. I just want you to know that Palmyra is for sale and the owners want to sell the Island to the State of Hawaii. Thank you very much."

Senator Blair then posed a question:

"Mr. President, on that point I'm wondering if the previous speaker would yield to a question?"

The Chair posed the question and Senator Matsuura having answered in the affirmative Senator Blair asked:

"Are you suggesting that we transfer geothermal funds to the purchase of Palmyra Islands?(Laughter)"

Senator Matsuura answered:

"Well, geothermal is imminent. I think it is going to take about 12 years to develop a full-sized commercial cold fusion plant. But I can assure you, if you get geothermal and you get that cold fusion plant in Hawaii we won't have the kind of problem they are having in Alaska today. If cold fusion really works, that will be the future of energy, and Palmyra will be one of the key elements. So I say we do both. Thank you."

#### ADJOURNMENT
